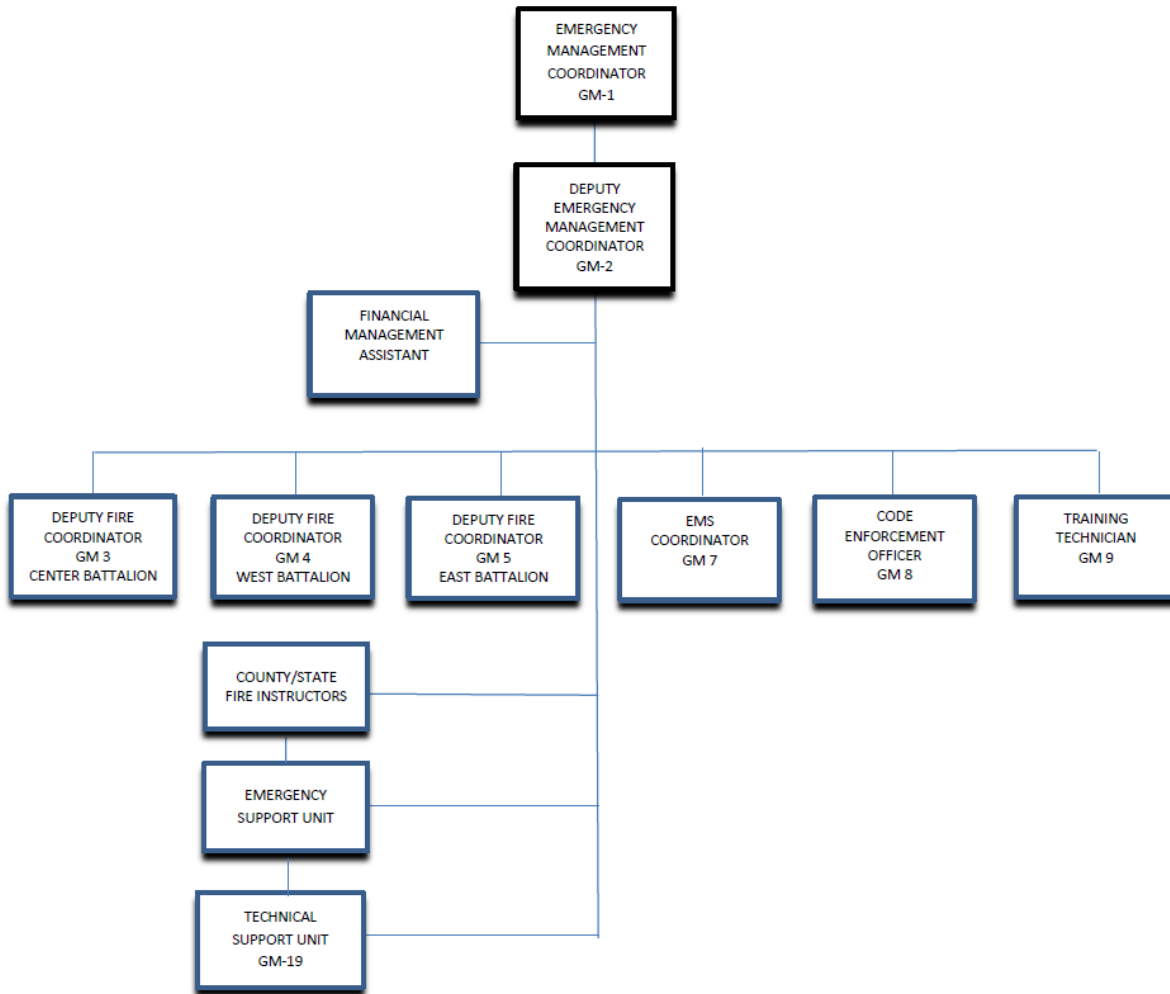


## OFFICE OF EMERGENCY MANAGEMENT SERVICES

#### **DEPARTMENT DESCRIPTION**

The Office of Emergency Management Services is responsible for the overall coordination of 17 volunteer fire departments, 2 Emergency Medical Services departments and 1 career fire department. The coordination of services these agencies provide represents a geographical area of 501 square miles, which includes a population of approximately 58,000 people. Additionally, the office provides numerous Fire/EMS training programs required by the NYS Office of Fire Prevention and Control and the NYS Department of Health to our local emergency responders. The office serves as the liaison between local government, State and Federal agencies on a regular basis as well as during times of natural and man-made disasters. The Office of Emergency Management Services is the Point of Contact for the NYS Homeland Security Task Force in delivering various training programs along with administering equipment and WMD equipment caches.

The department reviews and updates County emergency response plans regularly along with providing assistance to local governments in the development of their emergency response plans. The Office of Emergency Management Services provides the services of a specialized Emergency Support Unit to jurisdictions when local resources have been exhausted or specialized equipment may be required.

## **KEY 2023 ACCOMPLISHMENTS**

### **EMERGENCY PREPAREDNESS - RESPONSE**

- **COVID-19 Response**
  - Even though COVID-19 is no longer considered a public health emergency, it continues to be a presence, threatening the health and well-being of the population. The Genesee County Office of Emergency Management personnel is prepared to respond to the COVID-19 pandemic as the situation warrants.

- **NYS LOCAL EMERGENCY MANAGEMENT ACCREDITATION PROGRAM**
  - The Genesee County Office of Emergency Management (GCOEM) is participating in the NYS Local Emergency Management Accreditation Program. EMOs who achieve this accreditation must meet a variety of emergency management standards. The standards were developed based on a combination of factors, to include the Emergency Management Accreditation Program (EMAP) standards, relevant State laws (e.g., Article 2B of NYS Executive Law), and emergency management best practices.

- National Incident Management System (NIMS)

    - The County Legislature approved the current plan in October 2019.
    - As required by law, this multi-jurisdiction plan is due for scheduled updates (every five year).
    - Genesee County requested and has received funding to complete the updates to the hazard mitigation plan.
    - A consultant has been secured (TetraTech, Inc.) and the process is underway.
    - Genesee County Office of Emergency Management serves as the liaison to the planning partnership, contracted consultant, and state and federal agencies for the completion of this plan.
  
- NYS Office of Fire Prevention and Control
  - Many of the NYS training programs have gone through a restructuring in recent years. Genesee County continues to offer these programs based upon our customer’s needs and requests. We continue to draw students from the region. However, the decline in the volunteer workforce effecting fire/EMS staffing has also effected the enrollment in the training programs such as the entry level Tri-County Basic Exterior Firefighter Operations (BEFO) that has been canceled in the past several years due to low enrollment. Fortunately, most other programs offered have met the minimum enrollment requirements.
  - Genesee County OEM staff continues to strive to produce excellence in the product they deliver in all of the training courses offered at the Genesee County Fire Training Center.

  - An expanded training program, consisting of a power point presentation and complete with an all-inclusive handbook is held each spring for all fire department chiefs. This training program is an effort to expand the awareness, education and abilities of department officers as well as provide consistency of operations across the county.
  
- The NYS Department of Health
  - GCOEM serves as the course sponsor for NYS emergency medical training courses.
  - The County of Genesee, working with the staff from City of Batavia Fire Department offered a Basic Certified First Responder (CFR) course in 2023.
  - The outlook would be to offer the basic and refresher Certified First Responder (CFR) program in addition to an Emergency Medical Technician (EMT) program.

## SPECIAL PROJECTS

Due to the continual decline in the number of personnel joining the fire/EMS service as well as the decline in qualifications and skills of the current labor pool, Genesee County modified the Emergency Management Services Task Force, established in 2000, to meet the current needs and challenges facing the volunteer fire /EMS services. The Task Force worked in conjunction with a consultant team, Municipal Resources, Inc. on a comprehensive study of current fire/EMS services and the trends leading to the future of the Fire/EMS service within Genesee County. This resulted in a COMPREHENSIVE FIRE/EMS IMPLEMENTATION PLAN complete with 90 recommendations for implementation to ensure efficient and competent fire/EMS services for the future of Genesee County.

Emergency Medical Services was identified as the most critical need to be addressed in the report. Pertinent county staff members are working with EMS agencies to ensure Genesee County's future includes reliable emergency medical services across the county.

NYS has not approved a "paid per call" stipend for volunteer firefighters but has allowed for stipends when firefighters complete certain training programs. We are creating standard operating procedures for all fire departments and standardizing the on-boarding process for new firefighters.

    - Is appropriately equipped and trained to handle and function in all categories for all unknown industrial chemical hazards in liquid, aerosol, powder, solids and vapor/gas forms.
    - Generally, not expected to be fully equipped to intervene and handle incidents involving CBRNE.

- Continue to enhance the Fire Investigation Team Capabilities
- Pond rehab (Dedicated Drafting Area and Maintain Vegetation)
- Monitor and evaluate the delivery of training for Emergency Medical Services
