Legislature Clerk read a retirement notification from Laurie Miller, Board of Trustee from Genesee Community College. Retirement effective June 30, 2023. Ms. Miller dedicated three terms as a Board of Trustee. Legislature commented on her impact and acknowledged her service.

<u>Legislator Comments</u>: None.

<u>County Manager Report</u>: Matt Landers discussed meeting with EFCUH Officials There was a follow-up call regarding opportunities for water funding.

Tom Carpenter, Tim Hens and Justin took the initial call from the county with individuals from DOH and EFC Officials in late November. Katie Holman and Shelley Stein got the attention of these individuals due to behind the scenes work. Tim Hens called Matt after the initial phone call; the tone set was that these individuals were here to help find funding through the State for the water project. A follow-up call was scheduled. The take away from the initial call was that DOH and EFC could not talk about or deal economic projects. After the initial call Tim Hens sent this group the master plans, cash flow etc. The follow-up call was very different from before, there were moments of silence and more having to engage with the Officials. State Officials told Matt that the county had broken up a 150 million dollar project into 3 phases or projects. In the initial phone meeting, the county was advised to combine the 3 phases into 1 phase. However, the follow-up meeting told them to do it how they wanted to. In the follow-up phone meeting EFC offered 30 million dollars for funding, which is much less than what was anticipated. Now the project is at risk for losing funding if it is combined into one project. There is disappointment due to the initial meetings of a larger funding opportunity. Believed the DOH and EFC were going to help get better funding for the project. Tim Hens, Matt Landers and Shelley Stein reached out to Katie Holman to do an investigation to figure out what changed between the November meeting and the January meeting. There are still other possible sources for funding and 30 million may not be what was expected but it is still helpful. The overall take away is that 30 million dollars will still help but would like to keep other options open for more help towards funding.

### MORTGAGE TAX INCREASE EXTENSION– REQUEST FOR AUTHORIZING LEGISLATION – APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the County of Genesee has imposed an additional one-quarter of one percent (0.25%) local tax on mortgages for real property situated within the County of Genesee in addition to the tax imposed on said mortgages with the local tax of one-quarter of one percent to be used for the purpose of offsetting expenses of the Recording/County Clerk's Office or any County General

Fund purpose in Genesee County, and

**WHEREAS**, the legislation authorizing such additional mortgage tax will expire July 31, 2023 and the County Legislature wishes to extend its provisions, and

WHEREAS, The Committee of Ways and Means does recommend requesting approval for continuation at this time. Now, therefore, be it

**RESOLVED,** that the Genesee County Legislature does hereby petition State Senator George Borrello and Assemblyman Stephen M. Hawley to draft and introduce such legislation and further requests the New York State Legislature to support the legislation necessary to continue a one-quarter of one percent (0.25%) increase in Genesee County's mortgage tax rate. Be it further,

**RESOLVED**, that certified copies of this resolution be sent to Governor Kathy Hochul, Senator George Borrello and Assemblymen Stephen M. Hawley and any other agency as indicated by the Chair of the Genesee County Legislature.

REQUEST FOR AUTHORIZING LEGISLATION-SALES TAX/CONTINUATION OF ONE PERCENT (1%) INCREASE EXTENSION UNTIL NOVEMVER 30, 2026 - APPROVAL OF

Budget Impact: There will a \$90,000 decrease in the Casualty Liability Insurance Reserve. The reserve balance is \$1,229.998.70 as of 12/31/21. The Casualty Liability Insurance Reserve balance will be \$1,139,998.70 after the \$90,000.00 decrease. The 2022 closeout has not been completed to date.

**WHEREAS**, The Director of Information Technology did present a 36-month lease agreement with Empire Access for one strand of fiber from County Building II to LeRoy Police Department at 3 W Main St, LeRoy, NY 14482, and

**WHEREAS**, The Ways and Means Committee did review the request and does recommend approval at this time. Now, therefore, be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the agreement with Empire Access, 34 Main Street, Prattsburgh, NY 14873 for a 36-month lease effective June 1, 2023 through July 1, 2026 at a cost of \$500.00 a month and a \$1,000 installation.

Budget Impact: \$1,000 for installation only. County IT can cover this expense from the current Contracted Services line A.1680.4600.0000. The \$500.00 monthly charge will be from budget line A.1680.4290.0600 Internet and Bandwidth and will be covered from the elimination of a fiber connection to the Cedar Street radio tower and the elimination of the Radio Monitoring services previously provided by Integrated Systems.

**WHEREAS**, The Director of Information Technology did present a 36-month agreement with Empire Access to provide land line phone service for the Genesee County Airport located at 4701 East Saile Drive and Genesee County Emergency Management Services located at 7690 State

Street Rd., and

**WHEREAS**, The Ways and Means Committee did review the request and does recommend approval at this time. Now, therefore, be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the agreement with Empire Access, 34 Main Street, Prattsburgh, NY 14873 for a 36-month phone service agreement effective June 1, 2023 through May 31, 2026 at a cost of \$199.60 a month.

Budget Impact: \$199.60 monthly charge from A.1680 4290.0400 NY Phone-Basic Svc. County IT will eliminate the Verizon service and the difference in cost is negligible.

WHEREAS, The Director of Information Technology did present a monthly lease agreement with Time Warner Cable Northeast, LLC D/B/A Spectrum for Business Internet Service to the Genesee County Park Nature Center at 11095 Bethany Center Road, East Bethany, NY 14054, and

**WHEREAS**, The County Attorney did review the contract and Ways and Means Committee did review the request and does recommend approval at this time. Now, therefore, Be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the agreement with Spectrum, 2620 West Henrietta Road, Rochester, NY 14623 for monthly services effective March 1, 2023 at a cost of \$84.00 a month and a \$99 installation fee. Budget Impact: \$99 for installation only. County IT can cover this expense from the current Contracted Services line A.1680 4600.0000. The \$84.00 monthly charge will be from budget line A.1680 4290.0600 Internet and Bandwidth and will be covered from the elimination of the current HughesNet service, which costs the County \$102.75 a month.

ACCEPTANCE OF GRANT FUNDS/2022 BUDGET TRANSFER/2022 BUDGET AMENDMENT-SHERIFF-SAM/CREST GRANT-APPROVAL OF

**WHEREAS**, The State and Municipal Facilities Capital Program (SAM) has awarded Genesee County \$100,000 in grant funding to assist with costs associated with the renovations to the 911 Dispatch Center, and

**WHEREAS**, The grant funds will be used to offset costs associated with the 911 Dispatch Center Console Furniture capital project, which was established by Resolution #64 of 2022, by replacing a portion of the project funded by 1% Sales Tax with grant funds, and

**WHEREAS,** The Sheriff is requesting acceptance of the grant funding, and a budget transfer and budget amendment of \$100,000, and

**WHEREAS**, The Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to accept the State and Municipal Facilities Capital Program funding in the amount of \$100,000, and be it further

**RESOLVED**, That the Genesee County Treasurer is hereby authorized and directed to amend the 2022 budget as follows:

\$100,000 decrease to A.9950 9000.0000 (Transfer to Capital)

\$100,000 decrease to A.1000 1110.1 (1% Sales Tax)

And make the following 2022 budget transfer:

\$100,000 decrease to H.3397 5031 (Interfund Transfers)

\$100,000 increase to H.3397 3097 (State Aid)

Budget Impact: 2022 budget amendment and budget transfer in the amount of \$100,000 to accept State and Municipal Facilities Capital Program grant funding. The grant funds will be used to offset costs associated with the 911 Dispatch Center Console Furniture capital project by replacing a portion of the project funded by 1% Sales Tax with the grant funds.

Legislator Deleo seconded the resolution, which was adopted by 166 votes (Klotzbach -16 Absent and Maha - 18 Absent).

**RESOLUTION NO. 32** 

AGREEMENT APPROVAL – SHERIFF / SQUAD 9 LLC - APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the Genesee County Sheriff's Office, in order to comply with Governor Hochul's Executive Order 18, is requesting permission to enter into an agreement with Squad 9, LLC for consulting services to assist with the creation of a Threat Assessment Management Team (TAM), and WHEREAS, Squad 9, LLC (located at 65 Falling Brook Road, Fairport, New York 14450) has agreed to provide training, coordinate and assist with meetings and data collection, marketing to community members, and encourage government and private entities to cooperate in identifying and stopping persons on the pathway to violence, and

WHEREAS, after review by the County Purchasing Director and County Attorney, it has been determined that Squad 9, LLC, is a sole source provider, and

**WHEREAS**, it is recommended that the county enter into an agreement with Squad 9, LLC, not to exceed \$23,600, which will be reimbursed through the NYS Homeland Security Domestic Terrorism Prevention Grant, for services provided from February 1, 2023, through August 31, 2024, and

**WHEREAS**, the Ways & Means Committee did review this proposal and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Chair of the Genesee County Legislature and Genesee County Sheriff are hereby authorized to enter into an agreement with Squad 9, LLC (located at 65 Falling Brook Road, Fairport, New York 14450) to provide training; coordinate and assist with meetings, data collection, marketing to community members; and encourage government and private entities to cooperate in identifying and stopping persons on the pathway to violence at a cost not to exceed \$23,600, which will be reimbursed through the NYS Homeland Security Domestic Terrorism Prevention Grant, for services provided from February 1, 2023, through August 31, 2024.

Budget Impact: No budget impact or county cost. Grant funds in the amount of \$23,600 have been appropriated in the 2023 Genesee County Sheriff's Office budget.

Legislator Deleo seconded the resolution, which was adopted by 166 votes (Klotzbach -16 Absent and Maha - 18 Absent).
