WEDNESDAY, FEBRUARY 28, 2024

The Genesee County Legislature met in Regular Session on Wednesday, February 28, 2024 at 5:30 PM in the Legislative Chambers of the Old Courthouse.

Legislator Torrey offered to assist with the audit, the prayer followed by the Pledge to the Flag. Roll call taken, all in attendance, Madam Chair Stein stated they have a quorum.

In addition to the regular meeting, Madam Chair Stein called a public hearing in regards to persons 65 years of age or over/tax exemption (over age 65 sliding scale exemption).

<u>Proclamations & Commendations</u>: Commendation for Mary Spaulding Retiring from the Job Development Bureau presented by Legislator Clattenburg and accepted by Mary Spaulding.

Approval of Minutes: stand approved the February 14, 2024 minutes.

Committee & Special Assignment Reports: Legislator Maha reported information at NYSAC conference regarding Rescue EMS Crisis package, there are a number of bills presented on behalf of EMS, Legislator Maha requested the Clerk, Lisa Casey to be a resolution together. He also noted the state reviews over 24 thousands bills through Legislature. Chair Stein mentioned Robert Robinson a professional registered parliamentarian, reviewed suggested terminology and actions taken during a meeting. In example, roll call for a quorum and stand approved in relation to Robert's Rules. Communications & Petitions: None.

<u>Legislator Comments</u>: Chamber event recognized on Saturday, March 2nd, Chair Stein announced, "congratulations to all".

<u>County Manager Report</u>: County Manager Matt Landers reported that Tammi Ferringer was recognized at NYSAC for completed training in County Government, concerns with long-term Medicaid spending, sent out support letters asking to restore cuts – asked for additional funding to go towards highway restoration, discussed sales tax on Airbnb and Vrbo – treasurer could track and monitor, broadband money still not in the state budget, Received grant for Tower placement – 2.2 million.

RESOLUTION NO. 75

AUTHORIZATION TO AWARD MEGA ENERGY BIDS - APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, On October 12, 2023, the Genesee County Legislature approved Resolution No. 2023-396, to issue an Invitation to Bid on behalf of the Municipal Electric and Gas Alliance for the supply of electricity and renewable energy credits for municipal and other customers located in National Grid, Central Hudson Gas and Electric, New York State Electric, Gas, and Rochester Gas and Electric, Orange & Rockland Utilities, PSE&G – Long Island and Con Edison utility, and an Invitation to Bid on behalf of the Municipal Electric and Gas Alliance for the supply of natural gas for municipal and other customers located in National Grid, Central Hudson Gas and Electric, New York State Electric and Gas, Rochester Gas and Electric, National Fuel, and Liberty Utilities utility territories, all in accordance with provisions of New York State Law, and

WHEREAS, Pursuant to the "piggybacking" provisions of both New York State General Municipal law Section 103, and County Law Section 408-a, such procurements for energy supplies allow other participating municipalities in New York State to receive offers pursuant to the terms of the procurement, and

WHEREAS, Responses to the Invitation to Bid were received and opened at the offices of the County Manager, Old Court House, 7 Main Street, Batavia, NY 14020 up to and including 2:00pm on Tuesday, January 23, 2024, and subsequently evaluated by MEGA staff and consultants for determination of lowest qualified bid(s) for the energy products requested in the designated utility service areas, with the results as follows:

Constellation New Energy- For electricity and renewable energy credits to Municipal and other customers located in National Grid, Central Hudson Gas and Electric, New York State Electric and Gas, and Rochester Gas and Electric, Orange & Rockland Utilities, PSE&G – Long Island and Con Edison utility territories.

NRG Energy- For natural gas supplies to Municipal and other customers located in National Grid, Central Hudson Gas and Electric, New York State Electric and Gas, Rochester Gas and Electric, National Fuel Gas and utility territories

And

WHEREAS, the MEGA Board of Directors, through action of its executive committee, on February 13, 2024, has accepted such bids and requests that Genesee County approve the award of the bids as noted above and authorize the County Manager and/or Chair of the Legislature to enter into contracts with the low bidders, and

WHEREAS, bids were presented to and reviewed by the Ways & Means Committee and the Committee does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to execute contracts as appropriate to implement the above described program.

Legislator Dibble seconded the resolution which passed by 200 votes.

RESOLUTION NO. 76

2024 SALARY SCHEDULE AMENDMENT-SHERIFF'S OFFICE/CREATION OF ONE TEMPORARY DEPUTY SHERIFF POSITION – APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, Deputy Travis DeMuth recently submitted his resignation estimated to be between March 15 - March 25, 2024, and

WHEREAS, the Sheriff's Office has, and is currently filling, three (3) Deputy Sheriff vacancies with recruits scheduled to attend the March 4, 2024, basic police training academy at Niagara County Community College, and

WHEREAS, there is an overlap in time between Deputy DeMuth's resignation date and the academy start date prohibiting the Sheriff's Office from enrolling a fourth Deputy Sheriff in this academy without creating a temporary Deputy Sheriff position for the period of March 1, 2024, through April 14, 2024, and

WHEREAS, after discussion between the Sheriff, Undersheriff, and Human Resources Director, it has been determined to be in the best interest of the Sheriff's Office to request the creation of a temporary Deputy Sheriff position for the period of March 1, 2024, through April 14, 2024, at a cost not to exceed \$15,587.25, and

WHEREAS, the Committees of Public Service and Ways & Means did review this request and do recommend approval at this time. Now, therefore, be it

RESOLVED, that the Human Resources Director is hereby authorized and directed to amend the 2024 Employee Salary Schedule by creating a temporary, full-time Deputy Sheriff Grade 12 position for a period beginning March 1, 2024, through April 14, 2024, at a cost not to exceed \$15,587.25.

Budget Impact: Due to the three (3) Deputy Sheriff vacancies, there are funds available in the Sheriff's personnel line item to cover the cost (not to exceed \$15,587.25) associated with this additional, temporary Deputy Sheriff position.

BY-LAWS REVISION - CRIMINAL JUSTICE ADVISORY COUNCIL (CJAC) – APPROVAL OF

WHEREAS, the Criminal Justice Advisory Council (CJAC), created pursuant to Resolution #293 in the year 1981, is comprised of a wide array of member agencies that promote public good and safety through improved coordination and cooperation among criminal justice agencies and other organizations in the community concerning criminal justice issues, and

WHEREAS, the Criminal Justice Advisory Council (CJAC) does advise the Legislature on matters concerning Criminal Justice in Genesee County, and

WHEREAS, the Corfu Police Department expressed an interest in becoming a member of the Council, and

WHEREAS, at its January 10, 2024, meeting, the Council discussed and approved adding Corfu Police Department as a member. Additionally, the structure of the Genesee County Youth Bureau has been reorganized with it now falling under the supervision of the Genesee County Department of Social Services, which is currently a member of CJAC. Commissioner Mindler confirmed that there is no longer a need for a separate representative for the Youth Bureau on CJAC. She, or her designee, will represent both departments, and

WHEREAS, there have also been agency name changes to current members: Genesee/Orleans Council on Alcoholism & Substance Abuse (GCASA) is now UConnectCare Behavioral Health Services and Genesee County Magistrates' Association is now Genesee County Magistrates' and Court Clerks' Association, and

WHEREAS, the Committees of Public Service and Ways & Means do recommend revising the by-laws by appointing Corfu Police Department as a member, removing the Youth Bureau as a member, and approving the recent agency name changes. Now, therefore, be it

CONTRACT APPROVAL- SHERIFF'S OFFICE/ JAIL/PRIMECARE MEDICAL OF NY-APPROVAL OF

WHEREAS, pursuant to Resolution 306, dated July 26, 2023, Genesee County awarded PrimeCare Medical with a contract (RFP 2023-11) to provide medical services at the Genesee County Jail beginning September 1, 2023, through December 31, 2023, with the intent of both parties to enter into a new contract January 1, 2024, for a one-year period, and

WHEREAS, after careful review by the County Attorney, Jail Superintendent, and Sheriff, it is recommended that the County of Genesee enter into an agreement with PrimeCare Medical of NY for January 1, 2024, through December 31, 2024, at a monthly cost not to exceed \$65,412.71, with the option to renew for four (4) additional one-year periods upon mutual, written consent by both parties, and

WHEREAS, the Committees of Public Service and Ways & Means did review this request and do recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature and Sheriff are hereby authorized to enter into an agreement with PrimeCare Medical of NY (located at 3940 Locust Lane, Harrisburg, Pennsylvania 17109) to provide medical services at the Genesee County Jail for January 1, 2024, through December 31, 2024, at a monthly cost not to exceed \$65,412.71 with the option to renew for four (4) additional one-year periods upon mutual, written consent by both parties.

Budget Impact: Funds are allocated in the Jail's 2024 adopted budget to cover 2024 medical expenses.

CONTRACT – JUSTICE FOR CHILDREN ADVOCACY CENTER/INTERNATIONAL INSTITUTE OF BUFFALO-APPROVAL OF

WHEREAS, the Justice for Children Advocacy Center wishes to enter into a contract with the International Institute of Buffalo for interpreting and translation services, and

WHEREAS, the Justice for Children Advocacy is required by grant funding and National Children's Alliance accreditation to provide language access for all clients, and

WHEREAS, the Committee on Public Service and Ways and Means did review the recommendation and does concur. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a contract with the International Institute of Buffalo, located at 864 Delaware Ave., Buffalo, NY 14209 for foreign language interpreting and translation services at the Justice for Children Advocacy Center.

Budget Impact: Interpreting and translation services are fully covered by grants from the NYS Office of Children and Family Services and the NYS Office of Victim Services.

RESOLUTION NO. 80

CONTRACTUAL AGREEMENT-JUSTICE FOR CHILDREN ADVOCACY CENTER/MORGAN QUINN - APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the Coordinator of the Justice for Children Advocacy Center did submit for approval a contractual agreement for a community educator for the Justice for Children Advocacy Center, and

WHEREAS, this contract will allow the JFCAC to meet the growing need for high-quality, evidence-based child abuse preventions training for students and the community, and

WHEREAS, the Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature and the Genesee County Sheriff are hereby authorized and directed to enter a contractual agreement with Morgan Quinn with residence at 6247 Main Road, Stafford, NY for provision of child abuse prevention programming for students and the community for the period of March 1, 2024 through September 30, 2024 at a cost of \$25.00 per hour not to exceed \$1,200.

Budget Impact: Contractual services for a community educator are fully funded by a grant from the NYS Office of Children and Family Services.

WHEREAS, Genesee Justice received a 2023-2024 Pretrial Services Grant from the NYS Division of Criminal Justice Services in the amount of \$129,903 to be used to support certified pretrial services, and

WHEREAS, the Genesee Justice Program Coordinator did evaluate the staffing needs of the department and the increased work load of court-ordered, pretrial supervision cases, and

WHEREAS, after discussions between the Sheriff, Genesee Justice Program Coordinator, and Human Resources Director, it was determined that another full-time Case Manager – Genesee Justice position would enhance the service level and efficiency of the program, and

WHEREAS, after careful review and discussion with the Sheriff, the Genesee Justice Program Coordinator respectfully requests a budget amendment within the 2024 Genesee County budget, and

WHEREAS, the Committees on Public Service and Ways and Means did review this request and do recommend approval. Now, therefore, be it

RESOLVED, that the Genesee County Treasurer and Human Resources Director are hereby authorized and directed to amend the 2024 Genesee County Employees Salary Schedule by creating one full-time, 37.5 hours/week Case Manager – Genesee Justice, CSEA-General Grade 16, position. Be it Further

RESOLVED, that the Genesee County Treasurer is hereby authorized and directed to amend the 2024 budget by increasing revenue account A.3151.3322 State Aid-Dept of Criminal Justice in the

amount of \$59,816, offset by in an increase in expense accounts as follows:

Budget Impact: This position and additional pretrial expenses listed, will be fully funded by the 2023-2024 Pretrial Services Grant received on January 9, 2024, from the NYS Division of Criminal Justice Services. Balance of grant to be appropriated in 2025 Genesee County Budget to fund the remainder of the new position. This position will be for a minimum of one year, with subsequent years dependent on future grant funding.
