# GENESEE COUNTY LEGISLATURE BATAVIA, NEW YORK WEDNESDAY, MARCH 23, 2022

#### OLD COURT HOUSE, LEGISLATUE CHAMBERS

The Genesee County Legislature met in Regular Session on Wednesday, March 23, 2022 at 5:30 PM in the Legislative Chambers of the Old Courthouse. Zoom video conferencing was made available. Legislature Hawley offered to assist with the audit. The prayer was offered by Legislator Maha followed by the Pledge to the Flag.

Clerk of the Legislature Lisa Casey announced a proclamation for the National Women's History Month. Madam Chair Stein offered the proclamation to Assistant County Manager Tammi Ferringer and Executive Assistant to the County Manager Vicky Muckle whom accepted on behalf of all women.

Minutes of the March 9, 2022 Legislature meeting were approved upon motion of Legislator Maha seconded by Legislator Yunker, carried unanimously.

Committee and Special Assignment reports: Legislator Maha mentioned he and Chair Stein attended the NYSAC Conference in Albany. He is a member of the NYSAC Traffic Safety Committee and reviewed six resolutions that were approved by NYSAC. Taxing Districts, Bail Reform, Reimburse Counties Probation, NYS Invest 911 Funding, State Funding New Jail Mandates, Reform Civil Service. Chair Stein, mentioned as a member of the NYSAC Agricultural and Rural Affair Committee. NYS is the second highest State of food contributions by farmers to the Food bank throughout NYC. Also, Nourish NY Program is the primary supported by NYS farmers. NYSAC approved the resolution for Stay at the Threshold of 60-hours for Farmworkers. Also resolution approved by NYSAC for Land use and energy production, there is unfair advantage being supported by State Tax Dollars for energy production. Asked the Climate Action Committee to look past year 2030 for our 70% of all energy being used in the State being derived from renewal energy. County Manager Matt Landers and Madam Chair Stein attended the NYSAC Intergovernmental Committee where a resolution for Fair Equitable Chargebacks for Community Colleges were discussed. Madam Chair Stein stated in all, the NYSAC conference was well done, provided key contacts to discuss important items that our County has in the que. Legislator Yunker discussed Jail Transition workshop meeting that was well attended, reviewed in detail how the project will proceed. Appreciation was given to all those involved.

Communications and Petitions: Legislature Clerk Lisa Casey presented an out-of-state travel request for Deputy County Attorney Paul Campbell to attend ABA National Conference on Access to Justice for Children and Families in the amount of \$635.75. Motioned by Legislator Torrey and seconded by Legislator Deleo, which was approved by 283 votes, Dibble (43) absent.

County Managers Matt Landers Report: Governors budget is not perfect but is one of the better ones that he has seen since working for the Genesee County. Less of it shifting mandates on the counties. A direct reflection of the financial position that the State finds projected budget surpluses. The County should be seeing some increased funding in areas. One important campaign discussed is Keep Local Tax Local. NYSAC Committees passed many resolutions which were well received. County Manager Landers stated Madam Chair Stein did a great job with the wording of the Community Colleges resolution. County Manager Landers also mentioned the Jail Transition Team meeting, a big task ahead of them and these four individuals will know the jail inside and out, he has confidence in these individuals. Legislator Maha mentioned the Commissioner having to approve all change orders regarding the Jail. Does it have to go through the commissioner? Manager Landers stated any change order that has design change, will have the approval of the commissioner. Cost, related overrun cost not going to need to approval from Commissioner. Committee: Madam Chair called for a Consent Agenda, the first consent agenda for Genesee County Legislature per the adopted rules on March 9, 2022. Ways and Means Committee Chair/Legislator Clattenburg referred resolutions to be placed on the consent agenda. Legislator Clattenburg motion for adoption, Legislator Hawley seconded, carried unanimously for resolutions 1-15. Legislature Clerk read resolution titles 1 through 15. Committee Chair Clattenburg requested to remove resolution (#12).

AMENDMENT/RESTATEMENT TO THE CERTIFICATE OF INCORPORATION-THE GENESEE COUNTY FUNDING CORPORATION / AUTHORIZING THE COUNTY MANAGER TO EXECUTE AND DELIVER ANY AND ALL DOCUMENTS NECESSARY AND INCIDENTAL THERE TO – APPROVAL OF

Legislator Clattenburg offered the following resolution: **WHEREAS**, Genesee County, New York, acting by and through its County Manager, ex officio is the Member (the "Member") of The Genesee County Funding Corporation (the "Corporation"), and

WHEREAS, the Corporation desires to expand its mission and public objective to include lessening the burdens of government and promoting economic development initiatives in other counties within New York State to the extent a for-profit or nonprofit business enterprise in Genesee County has operations directly or through affiliated entities in other counties in New York State, as of the date bonds are or are expected to be issued by the Corporation for the benefit of such company, the Corporation is authorized to issue bonds for the benefit of such for-profit or nonprofit business enterprise and/or its affiliates in any county in New York as if such bonds are issued on behalf of Genesee County, in addition to Genesee County, New York, and WHEREAS, the Corporation desires to expand the jurisdictional reach of the territory in which the operations of the Corporation are principally to be conducted to include counties within New York State to the extent a for-profit or nonprofit business enterprise in Genesee County has operations directly or through affiliated entities in other counties in New York State, as of the date bonds are or are expected to be issued by the Corporation for the benefit of such company, the Corporation is authorized to issue bonds for the benefit of such for-profit or nonprofit business enterprise and/or its affiliates in any county in New York as if such bonds are issued on behalf of Genesee County, and

**WHEREAS,** it is contemplated that the member will approve the restatement to the Corporation's Certificate of Incorporation, by executing a unanimous written consent in substantially the form attached hereto as **Exhibit A**, and

**WHEREAS**, the Ways and Means Committee did review the request and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** the Genesee County Legislature hereby authorizes the County Manager, a member of the Genesee County Funding Corporation to execute and deliver the unanimous written consent in substantially the form known as **Exhibit A**: **THE GENESEE COUNTY FUNDING CORPORATION**MEETING of the MEMBER byUNANIMOUS WRITTEN CONSENT March \_\_\_\_, 2022 The Member of The Genesee County Funding Corporation (the "Corporation"), a not-for-profit local development corporation organized pursuant to Section 1411 of the Not-For-Profit Corporation Law of the State of New York, hereby takes the following actions which the Member is permitted to take without a meeting pursuant to Section 614 of the New York Not-for-Profit Corporation Law:

1. Approval of a Restated Certificate of Incorporation.

Matthew Landers, Member of The Genesee County Funding Corporation Be it further **RESOLVED**, the Genesee County Legislature hereby approves the Restated Certificate of Incorporation of the Corporation to be signed by the Chairman of the Genesee County Funding Corporation, known as **Exhibit B**. **EXHIBIT B:RESTATED CERTIFICATE OF INCORPORATION** OF THE GENESEE COUNTY FUNDING CORPORATION A Not-For-Profit Local Development Corporation under Section 1411 of the Not-For-Profit Corporation Law of the State of New York THE **UNDERSIGNED**, being an authorized person of The Genesee County Funding Corporation, hereby certifies: I. The name of the corporation shall be "The Genesee County Funding Corporation" (the "Corporation"). II. The Corporation's Certificate of Incorporation was filed by the Department of State on the 30<sup>th</sup> day of October 2009. III. The Corporation is a corporation as defined in subparagraph (a)(5) of Section 102 of the Not-For-Profit Corporation Law of the State of New York and, as provided in Section 1411 of the Not-For-Profit Corporation Law, a Type C Corporation as defined in Section 201 of the Not-For-Profit Corporation Law. The Corporation serves as a supporting organization for, but operate separate and apart from Genesee County, New York. IV. The Corporation's Certificate of Incorporation is hereby amended in the following respects: To amend the FOURTH paragraph to expand the Corporation's mission and public objective to include lessening the burdens of government and promoting economic development initiatives in other counties within New York State to the extent a for-profit or nonprofit business enterprise in Genesee County has operations directly or through affiliated entities in other counties in New York State, as of the date bonds are or are expected to be issued by the Corporation for the benefit of such company, the Corporation is authorized to issue bonds for the benefit of such for-profit or nonprofit business enterprise and/or its affiliates in any county in New York as if such bonds are issued on behalf of Genesee County; and To amend the FIFTH paragraph to expand the operations of the Corporation to include counties within New York State to the extent a for-profit or nonprofit business enterprise in Genesee County has operations directly or through affiliated entities in other counties in New York State, as of the date bonds are or are expected to be issued by the Corporation for the benefit of such company, the Corporation is authorized to issue bonds for the benefit of such for-profit or nonprofit business enterprise and/or its affiliates in any county in New York as if such bonds are issued on behalf of Genesee County; and To intentionally omit the THIRTEENTH paragraph as the names and addressed of the initial Directors of the Corporation were required only at formation. To amend the SIXTEENTH paragraph to update the address for service of process to be 99 MedTech Drive, Batavia, New York 14020. V. The text of the Incorporation, as amended, is hereby restated to read as hereinafter set forth in full. The name of the corporation shall be "The Genesee County Funding Corporation" (the "Corporation"). Corporation is a corporation as defined in subparagraph (a)(5) of Section 102 of the Not-For-Profit Corporation Law of the State of New York and, as provided in Section 1411 of the Not-For-Profit

Corporation Law, a Type C Corporation as defined in Section 201 of the Not-For-Profit Corporation Law.

The Corporation serves as a supporting organization for, but operate separate and apart from Genesee County, New York (the "County"). The purposes for which the Corporation is formed and operated are exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, to relieve and reduce unemployment, promote and provide for additional and maximum employment, improve and maintain job opportunities, and lessen the burden of government and act in the public interest. In furtherance of said purposes, the Corporation's powers include: To foster the creation, retention and expansion of jobs and economic opportunities for the benefit of the County, State and local economies; To construct, acquire, rehabilitate and improve for use by others, facilities in the territory in which its operations are principally to be conducted, to assist financially in such construction, acquisition, rehabilitation and improvement, to maintain and/or lease such facilities on its behalf or for others in such territory; to disseminate information and furnish advice, technical assistance and liaison with federal, state and local authorities with respect thereto; To acquire by purchase, lease, gift, bequest, devise or otherwise real or personal property or interests therein; To apply for loans and borrow money without limit as to amount; to make, draw, accept, endorse, execute and issue negotiable bonds, debentures, notes and other obligations therefor; To sell, lease, mortgage or otherwise dispose of or encumber any such facilities or any of its real or personal property or any interest therein upon such terms as it may determine; To enter into covenants and agreements and to comply with all the terms, conditions and provisions thereof, and otherwise to carry out its corporate purposes and to foster and encourage the location or expansion of facilities and related businesses in the territory in which the operations of the Corporation are principally to be conducted; To apply for and make grants and loans and to execute any and all documents necessary in connection therewith: To do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its members, directors, officers or any private person. In general, to perform any and all acts and things, and exercise any and all powers which may now or hereafter be lawful for the Corporation to do or exercise under and pursuant to the laws of the State of New York for the purpose of accomplishing any of the foregoing purposes of the Corporation. The Corporation's mission and public objective, which the Corporation's purposes will achieve, include, but are not limited to, the lessening of the burdens of government by undertaking and promoting economic development initiatives in Genesee County, New York and other counties within New York State, to the extent a for-profit or nonprofit business enterprise in Genesee County has operations directly or through affiliated entities in other counties in New York State, as of the date bonds are or are expected to be issued by the Corporation for the benefit of such company, the Corporation is authorized to issue bonds for the benefit of such for-profit or nonprofit business enterprise and/or its affiliates in any county in New York as if such bonds are issued on behalf of Genesee County, that will include real estate leasing, acquisition, development and management, real estate project finance, and other community-based economic development activities permissible under the Not-For-Profit Corporation Law. The operations of the Corporation will be principally conducted within the territory of Genesee County, New York and other counties within New York State, to the extent a for-profit or nonprofit business enterprise in Genesee County has operations directly or through affiliated entities in other counties in New York State, as of the date bonds are or are expected to be issued by the Corporation for the benefit of such company, the Corporation is authorized to issue bonds for the benefit of such for-profit or nonprofit business enterprise and/or its affiliates in any county in New York as if such bonds are issued on behalf of Genesee County. Pursuant to the requirements of Section 1411(e) of the Not-For-Profit Corporation Law: All income and earnings of the Corporation shall be used exclusively for its corporate purposes with the intent being that all income and earnings will be expended or deposited in appropriate reserves for corporate purposes; to the extent not so used, the income and earnings will accrue and be paid to the Job Development Authority to the extent required by Section 1411 of the Not-for-Profit Corporation Law. The property of the Corporation

is irrevocably dedicated to charitable purposes. No part of the income or earnings of the Corporation shall inure to the benefit or profit of, nor shall any distribution of its property or assets be made to, any member, director or officer of the Corporation, or private person, corporate or individual, or to any other private interest, except that the Corporation may repay loans made to it and may repay contributions (other than dues) made to it to the extent that any such contribution may not be allowable as a deduction in computing taxable income under the Internal Revenue Code of 1986, as amended. If the Corporation accepts a mortgage loan or loans from the New York Job Development Authority, the Corporation shall be dissolved in accordance with the provisions of paragraph (g) of Section 1411 of the Not-For-Profit Corporation Law upon the repayment or other discharge in full by the Corporation of all such loans. The Corporation shall not: Attempt to influence legislation by propaganda or otherwise, or participate in or intervene, directly or indirectly, in any political campaign on behalf of or in opposition to any candidate for public office. Engage in any activities not permitted to be carried on by an organization exempt from federal income taxation pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and the regulations promulgated thereunder. In the event of the dissolution of the Corporation or the winding up of its affairs, the Board of Directors shall, after paying or making provision for the payment of all debts and liabilities of the Corporation of whatsoever kind or nature, distribute all of the remaining assets and property of the Corporation to the County for furtherance of the purposes set forth in Section 1411 of the Not-for-Profit Corporation Law. Any of such assets not so disposed of shall be disposed of by order of the Supreme Court of the State of New York pursuant to Section 1008 of the Not-For-Profit Corporation Law. The office of the Corporation is located in Genesee County, New York. The offices of the Corporation are functionally separate from those of the County or any of its affiliated entities (collectively, the "County Entities") (although such office may be in a facility leased from the County or any of its affiliates on arms-length terms). The Corporation at all times shall: maintain separate accounting records and other corporate records from those of the County Entities; not divert the Corporation's funds to any other person or for other than the use of the Corporation and not commingle any of the Corporation's assets with those of the County Entities: pay any employee, consultant or agent of the Corporation, or any other operating expense incurred by the Corporation, from the assets of the Corporation and not from the assets of any of the County Entities; maintain its own deposit account or accounts, separate from those of the County Entities, with commercial banking institutions and/or trust companies; to the extent that the Corporation contracts or does business with vendors or service providers where the goods and services provided are partially for the benefit of any other person, the costs incurred in so doing shall be fairly allocated to or among the Corporation and such persons for whose benefit the goods and services are provided, and the Corporation and each such person shall bear its fair share of such costs; conduct its business in its own name and conduct all material transactions between the Corporation and the County Entities only on an arm's-length basis; observe all necessary, appropriate and customary corporate formalities, including, but not limited to, holding all regular and special members' and directors' meetings appropriate to authorize all corporate action, keeping separate and accurate minutes of such meetings, passing all resolutions or consents necessary to authorize actions taken or to be taken, and maintaining accurate and separate books, records, and accounts, including, but not limited to, intercompany transaction accounts. Regular members' and directors' meetings shall be held at least annually; ensure that decisions with respect to its business and daily operations shall be independently made by the Corporation (although the officer making any particular decision also may be an employee, officer or director of the County Entities); act solely in its own corporate name and through its own authorized officers and agents, and use its own stationery; other than as expressly provided herein, pay all expenses, indebtedness and other obligations incurred by it; not enter into any guaranty, or otherwise become liable, with respect to any obligation of the County Entities; cause any financial reports required of the Corporation to be prepared in accordance with generally accepted accounting principles and be

audited annually and be issued separately from, although they may be consolidated with, any reports prepared for any member of the County Entities; and ensure that at all times it is adequately capitalized to engage in the transactions contemplated herein. The types or classes of Membership in the Corporation and the number of Members of the Corporation shall be described in the By-laws. The Corporation is managed by a Board of Directors consisting of three to nine Directors. Any subsequent increase or decrease in the size of the Board of Directors will require the unanimous approval of the Members and the affirmative vote of a majority of the Directors. Intentionally omitted. The duration of the Corporation shall be perpetual. The Corporation shall indemnify each Member, each Director, each officer, and, to the extent authorized by the Board of Directors, each other person authorized to act for the Corporation or on its behalf, to the full extent to which indemnification is permitted under the Not-For-Profit Corporation Law. The Secretary of State of the State of New York is designated as agent of the Corporation upon whom process against it may be served. The post office address to which the Secretary of State shall mail a copy of any process against the Corporation served upon him is as follows: The Genesee County Economic Development Center c/o the Genesee County Funding Corporation, 99 MedTech Drive, Batavia, New York 14020. The By-laws of the Corporation may be adopted, amended or repealed by a majority of the Directors of the Corporation. The Corporation will not do any of the following: Without the affirmative vote of all Members of the Corporation and the affirmative vote of a majority of the Directors, increase or decrease the number of Members of the Corporation or increase or decrease the number of Directors of the Corporation. Without the affirmative vote of a majority of the Directors of the Corporation and all of the Corporation's members, (i) dissolve or liquidate, in whole or in part, or institute proceedings to be adjudicated bankrupt or insolvent, (ii) consent to the institution of bankruptcy or insolvency proceedings against it, (iii) file a petition seeking or consenting to reorganization or relief under any applicable federal or state law relating to bankruptcy or insolvency, (iv) consent to the appointment of a receiver, liquidator, assignee, trustee, or other similar official of the Corporation or a substantial part of its property, (v) make a general assignment for the benefit of creditors, (vi) admit in writing its inability to pay its debts generally as they become due or (vii) take any corporate action in furtherance of the actions set forth in clauses (i) through (vi) of this paragraph. Without the affirmative vote of all of the Directors of the Corporation and all of the Corporation's members, merge or consolidate with any other corporation, company or entity or, except to the extent contemplated by paragraph THIRD hereof, sell all or substantially all of its assets or acquire all or substantially all of the assets or capital stock or other ownership interest of any other corporation, company or entity. This Restated Certificate of Incorporation was authorized by the written consent of the Sole Member. WHEREOF, this certificate has been subscribed this day of March, 2022. The cost of booth space for the Wyoming County Fair is \$240.00 and was included in GLOW's 2022 Administrative Budget. One half of this amount will be funded by an NYSDEC MWR&R grant. AGREEMENT RENEWAL – SHERIFF'S OFFICE / SECURUS TECHNOLOGIES, INC. FOR INMATE COMMUNICATION SERVICES – APPROVAL OF

WHEREAS, the Agreement entered into per Resolution 170, dated May 23, 2018, with Securus Technologies, LLC, 4000 International Parkway, Carrollton, TX 75507, for inmate communication services provided to the Genesee County Jail included an option to renew the agreement for three (3) additional one-year periods, and both parties have expressed an interest in renewing the Agreement for the third one-year period (May 1, 2022, through April 30, 2023) under the same terms and conditions as the original Agreement, and

**WHEREAS**, the Committee on Public Service did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a Renewal Agreement for Jail inmate communication services with Securus Technologies, LLC, 4000 International Parkway, Carrollton, Texas 75007, for the period of May 1, 2022, through April 30, 2023, under the same terms and conditions as the original Agreement.

Budget Impact: Inmate communication costs have been budgeted for in the 2022 budget.

AWARD OF BIDS-HIGHWAY/CONSTRUCTION MATERIALS – APPROVAL OF

**WHEREAS**, The Genesee County Highway Superintendent advertised specifications for the various construction materials used by Genesee County for highway and bridge maintenance and construction, and **WHEREAS**, The Highway Superintendent did review these bids and does recommend their award at this time, and

**WHEREAS**, The Committees on Public Service did review this request and does recommend an award at this time. Now, therefore, Be it

**RESOLVED**, That the Genesee County Highway Superintendent is hereby authorized and directed to award bids to the various vendors on the annual construction materials bid as allowed for under the specifications for each item and as budgeted for within the 2022 County Budget and capital projects as established.

Budget Impact: This annual bid allows the Highway Superintendent to purchase materials in compliance with the General Municipal Law. The cost of most asphalt related materials are expected to increase through the construction season. The purchase of materials is limited by budgeted amounts within the County Road Fund and the various capital projects in place for the repair and replacement of highways and bridges. The

Highway Superintendent uses low bid, as adjusted by the contract hauling formula. The Highway Superintendent also reserves the right to award bids in the best value for the County based on availability of product, equipment failures and long wait times.

Legislator Deleo seconded the resolution, which was adopted by 283 votes, Dibble (43) absent.

RENEWAL OF BIDS-HIGHWAY/ PAVEMENT MARKINGS – APPROVAL OF

WHEREAS, The contractors and the Highway Superintendent mutual agree to renew the terms of the current agreement as allowed for under the original request for bid, and

WHEREAS, The Highway Superintendent does recommend renewing the contract at this time, and

**WHEREAS**, The Committee on Public Service did review this request and does recommend renewing the contract at this time. Now, therefore, Be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to renew a contract with Seneca Pavement Markings, Inc., 23 Hunters Run, Horseheads, NY 14845 for the application of pavement markings as bid under Item Groups A and B, as per specifications, effective June 1, 2022 through May 31, 2023 in an amount not to exceed budgeted amounts, and be it further

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to renew a contract with Accent Stripe, Inc., 3275 North Benzing Rd, Orchard Park, NY 14127 for the application of epoxy pavement markings as bid under Item Groups C as per specifications, effective June 1, 2022 through May 31, 2023 in an amount not to exceed budgeted amounts.

**Budget Impact**: The cost of pavement markings are scheduled to rise at a negotiated 25% increase. This is the first increase since 2020.

Legislator Yunker seconded the resolution, which was adopted by 283 votes, Dibble (43) absent.
