SIXTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, MARCH 24, 2021

The Genesee County Legislature met in Regular Session on Wednesday, March 24, 2021 at 5:30 PM in the Legislative Chambers of the Old Courthouse and remotely using ZOOM. The Genesee County Legislature has begun a phased-in process of resuming in-person meetings. Beginning Monday, March 1, 2021, Legislators and those presenting to a Standing Committee or the Legislature will meet in-person with others participating via Zoom Videoconference. Legislator Yunker assisted with the audit. The prayer was offered by Legislator Dibble followed by the Pledge to the Flag.

Legislature Chair Stein presented a commendation commemorating Livingston County's Bicentennial to Board of Supervisors Chair David LeFeber and Historian Amie Alden. Celebratory activities are planned throughout the year. Former Genesee County Historian Sue Conklin is chair of the bicentennial committee.

Minutes of the March 10, 2021 Legislature Meeting were approved upon motion of Legislator Clattenburg seconded by Legislator Torrey, carried unanimously.

Chair Stein related that COVID-19 vaccine eligibility is expanding, the filing deadline for income tax was extended to May 17, 2021, the State's re-opening plan includes changes to amusement activities, sports and arts events, and discussion pertaining to an Empire Passport with more information to follow.

United Way County Campaign Co-Chairman Tim Hens explained the fundraising goal for the 2021 campaign is \$20,000. Funds raised are used for local United Way funded programs. This year, United Way funded programs have provided critical assistance to many local families and children. Donors may use paper pledge forms or register on-line.

Legislature Clerk Pamela LaGrou stated the following correspondence was received in the Legislature Office; The annual Law Day Observance & Criminal Justice Awards will be held later in April or early May and nominations are sought for the Criminal Justice Awards, Fulton County sent a copy of their resolution calling upon NYS Legislature to curtail Governor Cuomo's emergency powers authority and the Town of Barre is holding a public hearing on April 14th pertaining to their zoning ordinance referencing solar energy systems.

County Manager Matt Landers explained that the County Health Department website is where citizens can register for a vaccine and/or COVID rapid test. He asked that everyone remain vigilant and continue to follow guidelines to reduce the spread of COVID. He discussed the state budget proposal to eliminate VLT revenue with Senator Rath who pledged to continue to fight for the restoration.

Vice Chair Clattenburg stated her opposition to the elimination of the VLT funds. She thanked County Manager Landers for his continued discussions with our State representatives.

Legislature Chair Stein stated this is the last week of the rapid COVID test clinics held at the Fire Training Center. Future testing will be available at the Health Department. Heartfelt thanks were extended to the County Health Department employees, Emergency Management employees, Highway workers, volunteers and legislators for their dedication and commitment to conducting a well-run rapid testing clinic for the past three months for our residents.

The Clerk proceeded with the resolutions:

RESOLUTION NO. 102 BATAVIA WELLFIELD EXPANSION - DETERMINATION OF NO SIGNIFICANT ENVIRONMENTAL IMPACT – APPROVAL OF

Legislator Yunker offered the following resolution:

WHEREAS, In accordance with Article 8 of the Environmental Conservation Law of the State of New York and the State Environmental Quality Review Act regulations (SEQRA), the Genesee County Legislature announced its intention to serve as lead agency for the purpose of conducting an environmental review of the Batavia Wellfield Expansion and received no objections to this designation from the other involved agencies, and

WHEREAS, The aforementioned statute and regulations require that the designated lead agency make determinations of significance regarding the actions upon completion of the environmental reviews, and

WHEREAS, The Genesee County Legislature has determined that the wellfield expansion is an "Unlisted Action" as defined under SEQRA, and

WHEREAS, Genesee County, in conducting the project review, has prepared and evaluated a Full Environmental Assessment Form (EAF) for this action, Now therefore, Be it

RESOLVED, That upon consideration and review of the EAF, the Genesee County Legislature, as lead agency, hereby finds and declares that the Batavia wellfield expansion which involves drilling and permitting a third groundwater well (well C), including the installation of a test well, final production well, wellhouse, associated piping and permitting, will not have a significant impact on the environment as defined by Article 8 of the Environmental Conservation Law and its underlying regulations, and Be it further

RESOLVED, That the Genesee County Legislature directs that a Negative Declaration - Notice of Determination of Non-Significance be filed pursuant to Article 8 of the Environmental Conservation Law and its underlying regulations.

Budget Impact: Funds to be allocated from County Water Fund. The cost to engineer/design Well C is \$80,000. Estimate to develop the new well is estimated at \$250,000. Negative impacts may result from not having Well C developed due to groundwater issues or high creek turbidity. This would result in the County not being able to produce up to 1.2 MGD at the City Water plant with a loss of revenue of approximately \$2,000 per day in surcharge and water plant operational surplus. In addition, there would be far reaching economic and health impact across the County to government, businesses and private citizens due to a water shortage. Legislator Klotzbach seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 103 SETTING PUBLIC HEARING ON INCLUSION OF VIABLE AGRICULTURAL LAND INTO AGRICULTURAL DISTRICTS NO. 1 & NO. 3

Legislator Torrey offered the following resolution:

WHEREAS, The Genesee County Legislature established by Resolution No. 399 of 2003 the annual thirty-day period to consider inclusion of new parcels to existing Agricultural Districts to run from January 26th to February 24th, and

WHEREAS, During the 2021 Annual Enrollment Period one parcel in the Town of Alexander (Tax Map Parcel No. 4.-1-53.2) was requested to be included into Agricultural District No. 1, and

WHEREAS, During the 2021 Annual Enrollment Period one parcel in the Town of LeRoy (Tax Map Parcel No. 26.-1-60) was requested to be included into Agricultural District No. 3, and

WHEREAS, Article 25AA of the New York State Agriculture and Markets Law, Section 303-b specifies that the County Legislative Body shall hold a public hearing regarding the proposed request. Now, therefore, Be it

RESOLVED, That a Public Hearing shall be held on the requests to be included into the Agricultural Districts on Wednesday, April 28, 2021 at 5:30 PM at the Genesee County Old Courthouse, Batavia, New York.

Budget Impact: The only direct budget impact will be the cost for printing the legal ad itself. Legislator Yunker seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 104 CONTRACT AMENDMENT- PUBLIC DEFENDER/NYS OFFICE OF INDIGENT LEGAL SERVICES/GENESEE COUNTY - APPROVAL OF Legislator Clattenburg offered the following resolution:

WHEREAS, The Public Defender does recommend the acceptance of the amended five year contract between Genesee County and the New York State Office of Indigent Legal Services (ILS), Contract Number: CSTWIDEHH18, (Statewide Expansion of *Hurrell-Harring*). This contract now includes the Year 2 budget and work plan for the Public Defender and the Assigned Counsel Program approved by ILS. This amended contract continues to fund Genesee County's plan for its use of the previously approved five year contract grant funds provided to extend the benefits of the *Hurrell-Harring* settlement reforms, those being ensuring that all eligible defendants are represented by counsel at arraignment, that we fully comply with ILS' caseload standards and that we implement and continue initiatives to improve the quality of indigent defense.

WHEREAS, the Public Service Committee did review the amended contract and does recommend acceptance at this time. Now, therefore, be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute Amended Contract Number: CSTWIDEHH18, Statewide Expansion of *Hurrell-Harring*, a contract between our county and the New York State Office of Indigent Legal Services, located at the A. E. Smith Building, 11th Floor, 80 South Swan Street, Albany, New York 12210.

BUDGET IMPACT STATEMENT: Total Public Defender contract revenue for 2021 in the amount of \$283,260 is contained within the 2021 adopted budget in its line A.1170.3025 Indigent Legal Services offset by like amounts in expenses.

Legislator Dibble seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 105 CONTRACT EXTENSION- PUBLIC DEFENDER/NYS DEFENDERS ASSOCIATION-APPROVAL OF

Legislator Dibble offered the following resolution:

WHEREAS, The Public Defender is recommending the (PDCMS) Public Defense Case Management System Maintenance and Software Support Agreement between Genesee County and New York State Defenders Association, Inc. be extended for a one-year period, May 3, 2021, to May 3, 2022, and

WHEREAS, the Public Service Committee did review the amended contract and does recommend acceptance at this time. Now, therefore, be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary documents to extend the Public Defense Case Management System Maintenance and Software Agreement between Genesee County and New York State Defenders Association, Inc., Albany, New York for a one-year period, May 3, 2021 to May 3, 2022, at a cost of \$500 per license for thirteen (13) licenses with a contract price of \$6,500.

Budget Impact: Funds for this contract in the amount of \$6,500 are budgeted in the 2021 Budget under lines A1170.3025 Revenue and A1170.4880.0000 Program Expense. Legislator Hawley seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 106 SPECIAL EVENT- GENESEE COUNTY PARK & FOREST/ INDEPENDENT LIVING 5K WALK– APPROVAL OF

Legislator Maha offered the following resolution:

WHEREAS, A Special Events application was received from Independent Living of the Genesee Region to use DeWitt Park for a 5K Walk fundraiser on July 26, 2021, and

WHEREAS, The Highway Superintendent did review and recommends approval of, and WHEREAS, The Committee on Public Service does concur with this requests. Now, therefore,

Be it

RESOLVED, That the Genesee County Legislature does herby grant permission to Independent Living of the Genesee Region to use DeWitt Park for a 5K Walk fundraiser on July 26, 2021 as per the Special Events Policy and Procedures for Community Events for the Parks and Recreation Areas.

WHEREAS, The Committees on Public Service and Ways and Means did review this request and does recommend the change be implemented at this time. Now, therefore, Be it,

RESOLVED, That the Genesee County Human Resources Director is hereby authorized and directed to amend the 2021 Employee Salary Schedule to increase the less than full-time Senior Building Maintenance Mechanic position, AFSCME, Grade 14 from 32 hours per week to 40 hours per week effective April 5, 2021.

Budget Impact: None, the full-time position was included and approved in the 2021 budget in anticipation of retirement. The funds are in A1620 1010.0000

RESOLUTION NO. 109 AWARD OF BIDS – HIGHWAY/ CONSTRUCTION MATERIALS – APPROVAL OF

Legislator Dibble offered the following resolution:

WHEREAS, The Genesee County Highway Superintendent advertised specifications for the various construction materials used by Genesee County for highway and bridge maintenance and construction, and

WHEREAS, The Highway Superintendent did review these bids and does recommend their award at this time, and

WHEREAS, The Committees on Public Service did review this request and does recommend an award at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Highway Superintendent is hereby authorized and directed to award bids to the various vendors on the annual construction materials bid as allowed for under the specifications for each item and as budgeted for within the 2021 County Budget and capital projects as established.

Budget Impact: This annual bid allows the Highway Superintendent to purchase materials in compliance with the General Municipal Law. The cost of most asphalt related materials are expected to increase slightly through the construction season. The purchase of materials is limited by budgeted amounts within the County Road Fund and the various capital projects in place for the repair and replacement of highways and bridges. The Highway Superintendent uses low bid, as adjusted by the contract hauling formula. The Highway Superintendent also reserves the right to award bids in the best value for the County based on availability of product, equipment failures and long wait times.

Legislator Maha seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 110 AWARD OF BIDS – SIGN MANUFACTURING EQUIPMENT – APPROVAL OF

Legislator Dibble offered the following resolution:

WHEREAS, The Genesee County Highway Superintendent advertised specifications for various sign manufacturing equipment, and

WHEREAS, The Highway Superintendent did review these bids and does recommend their award at this time, and

WHEREAS, The Committees on Public Service did review this request and does recommend an award at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Highway Superintendent is hereby authorized and directed to award the following listed sign manufacturing equipment as provided in the bid specifications to Grant Graphics, LLC, 610 Maple Ave, Saratoga Springs, NY 12866 in an amount not to exceed \$56,939.

RESOLUTION NO. 111 CONTRACT STATEMENT OF WORK AMENDMENT – SHERIFF'S OFFICE / PERICLE COMMUNICATIONS COMPANY – PUBLIC SAFETY RADIO COVERAGE ANALYSIS – APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, Genesee County approved a contract with Pericle Communications, from Colorado Springs, CO, to provide an independent coverage impact study of the new Public Safety P25 800 MHz Radio System by Harris Corporation pursuant to resolution 259, dated July 11, 2013, and amendments to the contract pursuant to resolution 180, dated May 29, 2014; resolution 73, dated February 26, 2015; and resolution 21, dated January 21, 2016; and

WHEREAS, Genesee County anticipates FY20 New York Statewide Interoperable Communications Grants to improve the Genesee County Public Safety Radio System; and

WHEREAS, Genesee County has designated Pericle Communications as a sole source consultant for the planning and coverage assessment of the public safety radio system upgrades; and

WHEREAS, After careful review by the Sheriff, County Attorney, and Director of Emergency Communications, it is recommended the County execute the amendment to the contract for a total cost of a statement of work not to exceed \$81,154.75; and

WHEREAS, The Committee on Public Service did review this proposal and does recommend approval at this time. Now, therefore, be it

RESOLVED, That the Genesee County Legislature does hereby approve a proposed "Fourth Amended Agreement for Consulting Services" with Pericle Communications Company, 7222 Commerce Center Drive, Suite 180, Colorado Springs, CO 80919, for the planning and coverage assessment of the radio system upgrades for a cost not to exceed \$81,154.75, and the Chair of the Genesee County Legislature is hereby authorized and directed to execute this document on behalf of the County of Genesee.

BUDGET IMPACT: The cost of this project will be offset by FY20 New York Statewide Interoperable Communications Grant revenues allocated to the Public Safety Communications Tower Capital project.

WHEREAS, the Agreement entered into per Resolution 170, dated May 23, 2018, with Securus Technologies, LLC, 4000 International Parkway, Carrollton, TX 75507, for inmate communication services provided to the Genesee County Jail included an option to renew the agreement for three (3) additional one-year periods, and both parties have expressed an interest in renewing the Agreement for the second one-year period (May 1, 2021, through April 30, 2022) under the same terms and conditions as the original Agreement, and

WHEREAS, the Committee on Public Service did review this request and does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a Renewal Agreement for Jail inmate communication services with Securus

Technologies, LLC, 4000 International Parkway, Carrollton, Texas 75007, for the period of May 1, 2021, through April 30, 2022, under the same terms and conditions as the original Agreement. **BUDGET IMPACT**: *Inmate communication costs have been budgeted for in the 2021 budget*. RESOLUTION NO. 113 SURPLUS EQUIPMENT – SHERIFF'S OFFICE -APPROVAL OF

WHEREAS, the Genesee County Sheriff's Office has taken ownership of a 2006 Toyota Avalon (Vehicle Identification Number 4T1BK36B96U144608), pursuant to a court order as the result of a tax law forfeiture, requiring the vehicle to be used for law enforcement purposes, and

WHEREAS, the Genesee County Highway Department inspected the vehicle for safety purposes and needed repairs, it was determined that the vehicle is in need of an engine replacement, and

WHEREAS, the Genesee County Sheriff did request this 2006 Toyota Avalon be declared surplus property, and

WHEREAS, the Committees on Public Service and Ways & Means did review this request and do recommend this vehicle be declared surplus property at this time. Now, therefore, be it

RESOLVED, that the Genesee County Legislature does hereby declare the 2006 Toyota Avalon (Vehicle Identification Number 4T1BK36B96U144608) surplus property to be disposed of through auction or scrap processing, and be it further,

RESOLVED, that the proceeds from the sale or scrap of this vehicle be appropriated to Sheriff's Revenue Account A3110.2626 (Forfeiture of Crime Proceeds).

Budget Impact: Revenue from the sale of this vehicle to be appropriated to Sheriff's Revenue Account A3110.2626 (Forfeiture of Crime Proceeds)

RESOLUTION NO. 114 CONTRACT RENEWAL – SHERIFF / ORLEANS COUNTY PRISONER HOUSING – APPROVAL OF

WHEREAS, the Sheriff did present a prisoner housing contract with Orleans County Jail, and WHEREAS, the County Attorney has reviewed and approved the terms of this Contract, and WHEREAS, the Committee on Public Service did review this contract renewal and does

recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature and the Genesee County Sheriff are authorized and directed to execute the contract between the County of Genesee and the County of Orleans for the provision of jail space in the Orleans County Jail at a rate of \$90.00 per day for each prisoner housed retroactively between January 1, 2021, through December 31, 2023.

Budget Impact: Funds have been appropriated to the 2021 budget.

Legislator Torrey seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 115 SURPLUS EQUIPMENT – SHERIFF'S OFFICE - APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the Sheriff's Office has a 2008 Jeep Grand Cherokee (Vehicle Identification Number 1J8GR48K88C217980) which is in need of repair, and

WHEREAS, the Genesee County Highway Department inspected the vehicle for safety purposes and needed repairs, it was determined that due to the year and mileage of the vehicle it is not fiscally sound to repair, and

WHEREAS, the Genesee County Sheriff did request this 2008 Jeep Grand Cherokee be declared surplus property, and

WHEREAS, the Committees on Public Service and Ways & Means did review this request and do recommend this vehicle be declared surplus property at this time. Now, therefore, be it **RESOLVED**, that the Genesee County Legislature does hereby declare the 2008 Jeep Grand Cherokee (Vehicle Identification Number 1J8GR48K88C217980) surplus property to be disposed of through auction or scrap processing, and be it further,

RESOLVED, that the proceeds from the sale or scrap of this vehicle be turned over the County Treasurer.

Budget Impact: Proceeds from the sale of this surplus vehicle will be turned over to the County Treasurer.

Legislator Deleo seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 116 GRANT AWARD-GENESEE JUSTICE/NYS DIVISION OF CRIMINAL JUSTICE SERVICES-APPROVAL OF

Legislator Dibble offered the following resolution:

WHEREAS, The Program Coordinator of the Genesee Justice Program did receive notification of the award of grant funding from the New York State Division of Criminal Justice Services for the continuation of the Community Service Sentencing Program and the Pre-Trial Services Program for a one-year contract term starting July 1, 2020 through June 30, 2021, and

WHEREAS, The Public Service Committee did review and does recommend acceptance of the grant funding at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature does hereby accept grant funding from the New York State Division of Criminal Justice Services in the amount of \$41,876 for the continuation of the Community Service Sentencing Program and the Pre-Trial Services Program for 2020 - 2021, and Be it further,

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary form for the acceptance of funds for the period of July 1, 2020 through June 30, 2021 in the amount of \$41,876.

Budget Impact: A 2021 Budget Amendment is not necessary at this time as it was requested to reduce our budget by 20% for DCJS funds. There was no reduction in amount of the full grant award.

Legislator Clattenburg seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 117 ADOPTION OF IMPLEMENTATION PLAN PER EXECUTIVE ORDER #203, NEW YORK STATE POLICE REFORM AND REINVENTION COLLABORATIVE

Legislator Clattenburg offered the following resolution:

WHEREAS, Executive Order #203, New York State Police Reform and Reinvention Collaborative, requires the chief executive officer of the municipality to perform a

comprehensive review of deployments, policies, procedures, and practices of its respective police agency and to develop an improvement plan, and

WHEREAS, the Genesee County Legislature Chair, Sheriff and County Manager, formed a task force in October of 2020 with diverse local representation for the purpose of reviewing Sheriff

Office operations and soliciting community input with the intent to develop a plan for any needed improvements of this office, and

WHEREAS, the local Task Force for Police Reform and Reinvention in Genesee County, as defined by Executive Order #203, convened for the first time October 28, 2020 and met again November 2, November 16, December 7, December 21, January 4, January 19, February 1, February 23 and March 2, 2021to discuss and consider evidence based policing strategies including but not limited to, use of force policies, procedural justice; any studies addressing systemic racial bias or racial justice in policing; implicit bias awareness training; de-escalation training and practices; law enforcement assisted diversion programs; restorative justice practices; community-based outreach and conflict resolution; problem-oriented policing; hot spots policing; focused deterrence; crime prevention through environmental design; violence prevention and reduction interventions; model policies and guidelines promulgated by the New York State Municipal Police Training Council; and standards promulgated by the New York State Law Enforcement Accreditation Program, and

WHEREAS, the draft report was made public for comment and feedback February 5, 2021, and **WHEREAS**, on March 2, 2021, the Task Force, upon consideration of all public and internal comments, finalized a draft report, entitled Genesee County Police Reform and Reinvention Report, and

WHEREAS, on March 15, 2021, the Report was submitted to the Public Service Committee for consideration with a recommendation for approval by the Committee, now, therefore, Be it **RESOLVED**, that the Genesee County Legislature, by way of resolution, has adopted the Genesee County Police Reform and Reinvention Plan Report and authorizes the Legislature Chair to execute Appendix B – New York State Police Reform and Reinvention Collaborative Plan Certification Form.

Legislator Maha seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 120 SUPPORT ENACTMENT OF CIVIL SERVICE REFORMS Legislator Maha offered the following resolution:

WHEREAS, Governor Andrew M. Cuomo signed Executive Order 203 (E.O. 203), the "New York State Police Reform and Reinvention Collaborative"; and

WHEREAS, counties continue to develop plans in the spirit of this executive order through community engagement and stakeholder involvement, a series of civil service reforms are necessary to effectuate meaningful reform; and

WHEREAS, the New York State Department of Civil Service, an institution first created in 1883, mission is "to build tomorrow's workforce today by promoting a diverse, inclusive, and talented workforce;" and

WHEREAS, county government wants to partner with the Department of Civil Service to advance this mission.

NOW, THEREFORE, BE IT RESOLVED, that the Genesee County Legislature encourages the Governor and State Legislature to implement the following civil service reforms:

• Ease the "rule of three" for appointments. The state should consider a simple pass/fail test for deputy sheriffs, correction officers, public safety telecommunicators, and police officers. If this is unachievable, the state should consider band-scoring to a wider band than 5 points to allow for a more robust pool of eligible applicants.

• Ease or suspend the restrictions on hiring former police officers as it applies to Section 58 (4) CSL.

• Ease the restrictions on hiring part-time police officers, especially retired members or retired troopers on a non-competitive basis. Forcing retired state troopers to have to take a civil service test is unreasonable, especially for a 209-V GML peace officer position.

• Reform civil service rules and regulations to ensure reasonable probationary periods for all transferees of at least six months.

• Reform civil service rules and regulations to ensure that a previous test disqualification should prevent an individual from re-taking a test for a period of time.

• Grant counties the authority to enact "continuous recruitment" options for correction officers. The state already has continuous recruitment for state correctional officers at DOCCS facilities.

BE IT FURTHR RESOLVED, that copies of this resolution be sent to Governor Andrew Cuomo, Senator Edward Rath, Assemblyman Stephen Hawley, Speaker of the Assembly Carl Heastie, Senate Majority Leader Andrea Stewart-Cousins, New York Association of Counties and Inter-County Association of Western New York.
