#### SIXTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, March 25, 2020

The Genesee Legislature met in Regular Session on Wednesday, March 25, 2020 at 5:30PM. Because of the Novel Coronavirus (COVID-19) Pandemic and the State and Federal bans on large meetings or gatherings and pursuant to Governor Cuomo's Executive Order 202.1 issued March 12, 2020 suspending the Open Meeting Law, the Genesee County Legislature meeting scheduled for March 25, 2020 was held electronically via ZOOM video conference instead of a public meeting open for the public to attend in person. Legislator Hilchey assisted with the audit. Prayer was offered by Legislator Clattenburg followed by the Pledge to the Flag.

Roll call; Legislators Hilchey and Deleo did not respond to roll call.

Legislator Young read a proclamation naming Public Health Week April 6-12, 2020 and commended Public Health Director Paul Pettit for his work and the work of his department employees during this COVID-19 Pandemic.

Minutes of the March 11, 2020 Legislature Meeting were approved upon motion of Legislator Clattenburg seconded by Legislator Dibble, carried unanimously. Legislators Hilchey and Deleo joined the meeting.

Minutes of the March 18, 2020 Special Legislature Meeting were approved upon motion of Legislator Maha seconded by Legislator Torrey, carried unanimously.

Legislator Young commented that Genesee County Economic Development Center staff and board members are working on mitigating the impact of the executive order to have non-essential business temporarily closed due to COVID-19 Pandemic. Legislator Maha extended appreciation and thanks to Public Health Director Paul Pettit and county departments that are working diligently during the COVID-19 Pandemic. Legislature Chair Shelley Stein thanked all department heads and employees for making necessary adjustments and ensuring work is completed.

County Manager Jay Gsell commented on the Federal Stimulus Package approved by the Senate to provide a jolt to the economy reeling from the coronavirus pandemic. Information and details on the historic \$2 Trillion stimulus package will be forthcoming. The House still needs to vote on the measure and that is expected later in the week. FEMA is working with state and local governments to execute a thorough response to help protect the public. Genesee County is tracking FEMA covered expenses related to the Pandemic.

The Clerk proceeded with the resolutions:

#### RESOLUTION NO. 141 BUDGET AMENDMENT - SHERIFF/DELIVERY AND SET-UP MRAP VEHICLE-APPROVAL OF

Legislator Dibble offered the following resolution:

**WHEREAS**, The City of Batavia Police Department has acquired a MRAP MaxxPro vehicle that will be used by the joint Emergency Response Team with the Genesee County Sheriff's Office, and

**WHEREAS,** The Sheriff has agreed to cover half the cost of the delivery and set-up of the MRAP Vehicle at a cost of \$5,407, and

**WHEREAS,** Funds are available in the deferred forfeiture of crime proceeds revenue, and **WHEREAS,** The Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to amend the 2020 budget as follows:

\$5,407 to A3110.4340.0000 (Vehicle Maintenance and Repair)

To be offset by increasing the following revenue account:

\$5,407 to A3110.2626 (Forfeiture of Crime Proceeds), with funds to come from A899.3 (Restricted Account) State Asset Forfeitures.

**Budget Impact Statement:** Increase in Sheriff's 2020 appropriations in the amount of \$5,407; offset by an increase in revenue in a like amount, with funds to come from the restricted account for state asset forfeitures.

Legislator Hilchey seconded the resolution which was adopted by 326 votes.

**RESOLUTION NO. 142** 

AGREEMENT RENEWAL – SHERIFF'S OFFICE / SECURUS TECHNOLOGIES, LLC FOR INMATE COMMUNICATION SERVICES – APPROVAL OF

Legislator Yunker offered the following resolution:

WHEREAS, the current Agreement entered into per Resolution 170, dated May 23, 2018, with Securus Technologies, LLC, 4000 International Parkway, Carrollton, TX 75507, for inmate communication services provided to the Genesee County Jail will expire April 30, 2020, and WHEREAS, there is an option to renew this Agreement for three (3) additional one-year periods, and both parties have expressed an interest in renewing the Agreement for the first one-year period (May 1, 2020, through April 30, 2021) under the same terms and conditions as the original Agreement, and

**WHEREAS**, the Committee on Public Service did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a Renewal Agreement for Jail inmate communication services with Securus Technologies, LLC, 4000 International Parkway, Carrollton, Texas 75007, for the period of May 1, 2020, through April 30, 2021, under the same terms and conditions as the original Agreement. **BUDGET IMPACT**: *Inmate communication costs have been budgeted for in the 2020 budget*. Legislator Dibble seconded the resolution which was adopted by 326 votes.

### RESOLUTION NO. 143 REVISED AGREEMENT – SHERIFF'S OFFICE-JAIL / MEDICAL PROVIDER – APPROVAL OF

Legislator Maha offered the following resolution:

**WHEREAS**, Genesee County entered into an Agreement pursuant to Resolution 478, dated December 9, 2015, with Dr. Alan Barcomb, One Dennis Drive, Batavia, NY 14020, to provide medical services for inmates incarcerated in the Genesee County Jail, and

**WHEREAS**, in order to maintain Dr. Barcomb's services, he has requested a revision to the payment schedule in which he will be paid \$5,000 per 12-month calendar year, retroactive to January 1, 2020, paid quarterly; and also, an increase from \$100 to \$150 per diem for any direct patient care services provided on site at the Jail, billed and paid on a monthly basis, and

**WHEREAS**, after discussions between the Genesee County Sheriff, County Attorney, and Jail Superintendent, it has been determined to be in the best interest of all parties to approve this revised payment schedule, and

**WHEREAS**, the Committee on Public Service did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a revised Agreement for Jail inmate medical services with Dr. Alan Barcomb, One Dennis

Drive, Batavia, NY 14020, compensation retroactive to January 1, 2020, through December 31, 2020, under the same terms and conditions as the original Agreement.

**BUDGET IMPACT**: Funds to cover the additional inmate medical services costs are available in the current budget due to a decrease in the inmate population.

Legislator Yunker seconded the resolution which was adopted by 326 votes.

### RESOLUTION NO. 144 AMENDMENT TO EMERGENCY MANAGEMENT SERVICES TASK FORCE – APPROVAL OF

Legislator Hilchey offered the following resolution:

**WHEREAS,** Upon recommendation of the Genesee County 2000 Comprehensive Plan, Resolution No. 117-2000 adopted on March 22, 2000 established the Emergency Management Services Task Force, and

**WHEREAS**, The Emergency Management Coordinator did request the size and representation of the Task Force be modified to meet current needs and challenges facing the volunteer fire service, and

**WHEREAS**, the Task Force will identify the current fire capabilities, capacity and sustainability in Genesee County and develop a plan to ensure efficient and qualified fire/EMS protection to the communities of Genesee County, and

**WHEREAS**, the Committees on Public Service and Ways and Means did review this request and do concur with the Emergency Management Services Coordinator's recommendation, Now therefore be it

**RESOLVED,** That the Emergency Management Services Task Force is amended to include the following representatives to study and evaluate recruitment, retention and utilization of resources that presently affect volunteer emergency fire response within the County of Genesee, and Be if further

**RESOLVED**, That the Task Force will be made up of the following representative groups and members:

**RESOLVED,** the Genesee County Treasurer is hereby authorized and directed to amend the 2020 budget by Increasing Revenue A.1352.4389 Federal Aid/ Public Safety in the amount of \$21,121 and Increase Expenditures A.3152.4550.0000 Training in the amount of \$4,105, A3152.4560.0000 Travel in the amount of \$3,135, A.3152.4660.000 Contracted Other in the amount of \$12,040 and A.3152.4800.0000 Program Expense in the amount of \$1,841.

**Budget Impact:** Grant funding from the National Children's Alliance will fund 100% of the cost of establishing a Parent-Child Interaction Therapy program at the Justice for Children Advocacy Center. This increases expenditures and offsetting revenues of \$21,121.00

### RESOLUTION NO. 146 2020 BUDGET AMENDMENT – PUBLIC DEFENDER ASSIGNED COUNSEL – APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, Genesee County received an Indigent Legal Services Grant to cover expenses related to continuing legal education and trainings, mileage and travel, investigators/experts/interpreters/Social Workers, transcription services, legal resource materials, legal reference subscriptions for criminal defense attorneys and phone services to contact incarcerated clients, etc., and

**WHEREAS**, The Assistant County Manager and County Treasurer request a budget amendment in order to utilize the grant funds, and

**WHEREAS**, The committees of Public Service and Ways and Means do concur. Now, therefore, Be it

**RESOLVED**, That the Genesee County Treasurer is hereby authorized and directed to amend the 2020 Budget by increasing A1171.4800.0000 – Program Expense by \$66,335 offset by an increase in A1171.3025 – Indigent Legal Services in a like amount

**Budget Impact:** Increase in expenses to the Assigned Counsel Program to be offset fully by grant revenue Legislator Deleo seconded the resolution which was adopted by 326 votes.

Legislator Torrey made a motion to send Resolution "Establish Capital Projects/Budget Amendment-Approval Of" back to the Public Service Committee seconded by Legislator Maha, carried unanimously.

### RESOLUTION NO. 147 CONSULTANT AGREEMENT – 8-BAY T-HANGAR DEVELOPMENT – AIRPORT -- APPROVAL OF

Legislator Dibble offered the following resolution:

**WHEREAS,** Genesee County has been awarded a state grant to develop additional T-Hangars at the Genesee County Airport, and

**WHEREAS**, Genesee County received a proposal from C&S Engineers for the design of the facility and preparation of bid specifications according to state and federal guidelines, and **WHEREAS**, The Genesee County Highway Superintendent has reviewed this proposal and recommends its approval, and

**WHEREAS,** The Committees on Public Service and Ways and Means have reviewed this request and do concur at this time. Now, therefore, be it

**RESOLVED,** That the Chairperson of the Genesee County Legislature is hereby authorized to approve a consultant agreement with C&S Companies, 499 Eileen Collins Blvd., Syracuse, NY 13212 for the design and bidding services for the 8-Bay T-Hangar in an amount not to exceed \$24,950.

**Budget Impact:** The agreement is for \$24,950. A capital project has been established for this work that is funded with state aid (75%) and local match (25%) in the amount of \$875,000

Legislator Clattenburg seconded the resolution which was adopted by 326 votes.

### RESOLUTION NO. 148 DONATION ACCEPTANCE – SHED - GENESEE COUNTY PARKS – APPROVAL OF

Legislator Yunker offered the following resolution:

WHEREAS, The County has a policy for accepting donations of value over \$1,000, and

**WHEREAS,** The ACORNS, County Parks volunteer organization has donated a shed for use at the Genesee County Park & Forest Interpretive Center valued at \$3,511.29 and

**WHEREAS,** The Highway Superintendent does request the approval of accepting the above mentioned donation, and

**WHEREAS,** The Committee on Public Service does concur with this request, Now, therefore, Be it

**RESOLVED,** That the Genesee County Legislature accepts the donated shed from the ACORNS.

Budget Impact: None.

### AWARD OF BIDS – HIGHWAY CONSTRUCTION MATERIALS – APPROVAL OF

Legislator Clattenburg offered the following resolution:

**WHEREAS**, The Genesee County Highway Superintendent advertised specifications for the various construction materials used by Genesee County for highway and bridge maintenance and construction, and

**WHEREAS**, The Highway Superintendent did review these bids and does recommend their award at this time, and

**WHEREAS**, The Committees on Public Service did review this request and does recommend an award at this time. Now, therefore, Be it

**RESOLVED**, That the Genesee County Highway Superintendent is hereby authorized and directed to award bids to the various vendors on the annual construction materials bid as allowed for under the specifications for each item and as budgeted for within the 2020 County Budget and capital projects as established.

**Budget Impact**: This is an annual bid that allows the Highway Superintendent to purchase materials in compliance with the General Municipal Law. The cost of most asphalt related materials are expected to remain fairly flat through the construction season. The purchase of materials is limited by budgeted amounts within the County Road Fund and the various capital projects in place for the repair and replacement of highways and bridges. The Highway Superintendent uses low bid, as adjusted by the contract hauling formula. The Highway Superintendent also reserves the right to award bids in the best value for the County based on availability of product, equipment failures and long wait times.

Legislator Yunker seconded the resolution which was adopted by 298 votes, Legislator Hilchey (28) Abstain.

### RESOLUTION NO. 150 AWARD OF BID-HIGHWAY/ DRY BRIDGE RD SHEET PILING

Legislator Hilchey offered the following resolution:

**WHEREAS**, The Genesee County Highway Superintendent advertised specifications on engineering services, furnishing, and installing sheet piling on the Dry Bridge Road Bridge in Alexander; and

WHEREAS, The Genesee County Highway Superintendent reviewed the accuracy of these bids and does recommend award at this time, and

**WHEREAS**, The Committee on Public Service did review this recommendation and do concur. Now, therefore, be it

**RESOLVED,** The Genesee County Legislature does hereby award the Dry Bridge Road Sheet Piling contract in the amount of \$144,887.00 to The L.C. Whitford Co., Inc. 164 North Main Street, Wellsville NY 14895.

**Budget Impact**: The contract will be funded from the Large Span Culverts Capital Project. The capital project has an available balance of \$430,143.21 when factoring all current obligations.

WHEREAS, The County's Fair Housing Plan recognizes that public knowledge of fair housing provisions is the first step in expanding equal opportunity by appointing a Fair Housing Officer, providing information to the public, and promoting Fair Housing Activities and available resources as well as designate the month of April as Fair Housing Month, Now, therefore, Be it **RESOLVED.** The Genesee County Legislature hereby designates the month of April as Fair Housing month

**Budget Impact Statement**: None

Legislator Clattenburg seconded the resolution which was adopted by 326 votes.

#### RESOLUTION NO. 155 FAIR HOUSING- OCR/CDBG-SETTING PUBLIC HEARING Legislator Torrey offered the following resolution:

WHEREAS, As a recipient of OCR/CDBG grant funds the County is required to hold an annual public meeting on fair housing to identify any concerns and issues with fair housing practices in the County, and

WHEREAS, The Committee on Ways and Means does recommend setting a public hearing on Fair Housing. Now, therefore, Be it

**RESOLVED,** That a Public Hearing on Fair Housing Practices will be held on Wednesday, April 8, 2020 at 5:30 p.m. at the Old County Courthouse, 7 Main Street, in the City of Batavia, New York.

**Budget Impact Statement:** None

Legislator Clattenburg made a motion to amend the resolution to reflect a public hearing date of May 27, 2020 due to the Coronavirus pandemic seconded by Legislator Yunker, carried unanimously. Legislator Maha seconded the resolution which was adopted by 326 votes.

### RESOLUTION NO. 156 CONTRACT – DIRECT ENERGY BUSINESS FIXED PRICE AGREEMENT – APPROVAL OF

Legislator Young offered the following resolution:

**WHEREAS**, The Purchasing Office did sponsor a bid through MEGA in 2018, and **WHEREAS**, As result of this bid Direct Energy was awarded the contract for supplying natural gas to Genesee County buildings, and

**WHEREAS,** Direct Energy Business, LLC has offered us a fixed price contract for the supply of natural gas in concordance with the MEGA contract, and

WHEREAS, The EnergyNext Consultant for MEGA determined that this 36-month fixed price contract will insulate Genesee County from price spikes and provide it with budget certainty. At this time, the natural gas market is at historic lows. As of 2/11/2020, the 3-year commodity price (upon which the retail rate of \$3.606/Dth is based) is \$2.44/Dth. Compared to the 10-year average rate of \$3.32/Dth, this is an estimated 31% discount in price. The market has since dropped even further, so the 3-year commodity price to be locked in at is \$3.526/Dth. providing even greater anticipated savings,

**WHEREAS**, The Genesee County Attorney and the EnergyNext Consultant have both reviewed and approved the contract, and

WHEREAS, The Committee on Ways and Means did review the fixed price contract with Direct Energy Business and do recommend approval at this time. Now, therefore, Be it RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a three-year fixed price contract with Direct Energy Business, LLC, 194 Wood Avenue South, Second Floor, Iselin, NJ 08830 Attn: Contract Administration, to provide Genesee County with a fixed price contract for natural gas service to take us through the remainder of the MEGA contract, from the period of April 1, 2020 through March 31,2023. The MEGA contract contains the option for an additional three (3) one-year renewal periods upon written agreement of both parties.

**Budget Impact:** Genesee County is currently on variable natural gas rate with National Fuel (local natural gas distribution company), whereas this contract is fixed price and will not vary based on the market. Our Energy consultant informed us that currently the natural gas market is at historic lows. As of 2/11/2020, the 3-year commodity price (upon which the retail rate of \$3.606/Dth is based) is \$2.44/Dth. Compared to the 10-year average rate of \$3.32/Dth, this is a 31% discount in price. Based on 2019 expenditures, this could be a savings of approximately \$43,000/year, or \$129,000 over the 36 month contract. The 3-year fixed commodity price has since dropped to \$3.526/Dth, providing even greater anticipated savings.

Prior to the vote Chair Stein commented on the 3-year commodity price dropping to a lower rate of \$3.526/Dth.

Legislator Hilchey seconded the resolution which was adopted by 326 votes.

## RESOLUTION NO. 157 CONTRACT RENEWAL – COST-PER-COPY PROGRAM – APPROVAL OF

Legislator Hilchey offered the following resolution.

**WHEREAS**, the Director of Purchasing did present a contract renewal with Eagle Systems, Inc. for the provision of copy equipment under the Cost-Per-Copy program for the second additional one-year period,

**WHEREAS**, the Committee on Ways and Means did review the contract and does recommend approval at this time. Now, therefore, be it

**RESOLVED**, that the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a contract with Eagle Systems Inc. of Buffalo, NY for the provision of copy equipment under the Cost-Per-Copy program for the period of May 1, 2020 through April 30, 2021 at the cost of \$0.0060 per black and white copy and \$0.0350 for color copies.

**Budget Impact:** Funds were allocated in departmental budgets for 2020.

Legislator Yunker seconded the resolution which was adopted by 326 votes.

## RESOLUTION NO. 158 AUTHORIZATION FOR HOME RULE REQUEST – SALES TAX INCREASE RENEWAL EXTENSION - APPROVAL OF

Legislator Clattenburg offered the following resolution:

## RESOLUTION NO. 162 CELEBRATING THE 100TH ANNIVERSARY OF THE PASSAGE AND RATIFICATION OF THE 19TH AMENDMENT TO THE U.S. CONSTITUTION

**WHEREAS**, Congress passed the 19<sup>th</sup> Amendment to the Constitution of the United States on August 18, 1920 to declare, "The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of sex"; and

**WHEREAS**, New York women were on the front lines in the fight for suffrage, including Susan B. Anthony, Alva Vanderbilt Belmont, and Carrie Chapman Catt; and

**WHEREAS**, the ratification of the 19<sup>th</sup> Amendment represented a major victory and a turning point in the women's rights movement, ensuring women could more fully participate in our democracy and fundamentally changing the role of women in the civic life of our nation; and **WHEREAS**, this amendment changed the face of the American electorate forever and opened the door to women serving in local government; and

**WHEREAS**, August 26, 2020 marks the centennial of the 19<sup>th</sup>Amendment becoming a part of the United States Constitution, and this historical milestone is to be lauded and celebrated. **NOW, THEREFORE, BE IT RESOLVED**, that Genesee County celebrates the 100<sup>th</sup> anniversary of the passage and ratification of the 19th Amendment to the Constitution of the United States; and

**BE IT FURTHER RESOLVED**, that the Genesee County Legislature honors the role of the ratification of the 19<sup>th</sup> Amendment in further promoting the core values of our democracy as promised by the Constitution of the United States; and
