#### SIXTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, March 27, 2019

The Genesee Legislature met in Regular Session on Wednesday March 27, 2019 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Dibble assisted with the audit. Prayer was offered by Legislator Deleo followed by the Pledge to the Flag.

Minutes of the March 13, 2019 meeting were approved upon motion of Legislation Stein seconded by Legislator Maha, carried.

Legislator Stein stated GAM passed a resolution in support of the County and City request for special legislation authorizing a 40 year sales tax allocation. The resolution will be forwarded to Assemblyman Hawley and Senator Ranzenhofer who have introduced legislation authoring the Comptroller to approve a term of no more than 40 years for a sales tax allocation agreement. GAM members were provided with information from Highway Superintendent Hens regarding the cost of County bridges and culverts. The data was provided as an informational piece and included total actual cost and projected replacement cost. The next Inter County Association meeting is April 19<sup>th</sup> and Genesee County is host. The meeting will be held at the Iroquois National Wildlife Refuge in Alabama and all legislators are invited to attend. Legislator Stein also announced that Soil & Water Conservation District is adding a position that will incorporate planning. She attended the Celebrate Ag dinner and commented that Assemblyman Hawley and Senator Ranzenhofer attended and stayed for the entire evening. She noted that Water Resources Agency GAM representative Dave Hagelberger was reappointed to another term as the GAM rep on Water Resources Agency but he is not running for Supervisor therefore his term will end December 31 when he retires. Legislator Maha stated he attended the E911 board meeting and they are looking into the Connect 211 program that provides residents with an alternative to 911. Connect 211 is for non-emergency calls-callers can obtain information on resources. He also held another Water Resources Agency Sub-Committee meeting. Legislator Maha further reported that he attended a Jail Committee meeting and a May 16<sup>th</sup> presentation is planned by SMRT Architects.

Legislature Clerk LaGrou stated correspondence was received from Assemblyman Steve Hawley and NYSAC acknowledging receipt of our resolution opposing cuts to AIM funding.

Vice Chair Clattenburg stated the Youth Bureau Awards dinner is March 28<sup>th</sup>. She attended the Holland Land Office meeting and was updated on their plans for their antique show and the support they are getting from GCC. She also attended the GLOW Workforce Development meeting where discussion included the shortage of skilled labor.

County Manager Jay Gsell stated the State Legislature and Governor are reportedly working to ensure an on-time state budget. He has heard that cuts to AIM funding are being restored and legalization of Cannabis is not included in the budget. April is County Government Month and this year's theme is "Connecting the Unconnected". Legislator Stein commented that she understood that state legislators are due for a raise if the state budget is adopted on-time.

The Clerk proceeded with the resolutions:

# RESOLUTION NO. 100 CONTRACT –PUBLIC DEFENDER/ NYS OFFICE OF INDIGENT LEGAL SERVICES-2<sup>ND</sup> UPSTATE QUALITY IMPROVEMENT AND CASELOAD REDUCTION GRANT-APPROVAL OF

Legislator Torrey offered the following resolution:

**WHEREAS,** The Public Defender does recommend the acceptance of a contract (Second Upstate Quality Improvement and Caseload Reduction, Contract No.: C2ND618) between the Genesee County Public Defender's Office and the New York State Office of Indigent Legal Services, in the amount of \$300,000 for the provision of the three (3) year contract between Genesee County and The Legal Aid Bureau of Buffalo, Inc. to provide appellate services

WHEREAS, the Public Service Committee did review the contract and does recommend acceptance at this time. Now, therefore, Be it

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the (Second Upstate Quality Improvement and Caseload Reduction, Contract No.: C2ND618) with the New York State Office of Indigent Legal Services for the period of July 1, 2017 through June 30, 2020, and Be it further

**BUDGET IMPACT STATEMENT:** Total contract revenue for 2019 in the amount of \$100,000 is within the 2019 Adopted Budget in line A.1170.3025 Indigent Legal Services.

Legislator Maha seconded the resolution which was adopted by 281 votes, Legislator Bausch (45) absent.

#### RESOLUTION NO. 101 BUDGET AMENDMENT - SHERIFF/K-9 PROGRAM-APPROVAL OF

Legislator Hilchey offered the following resolution:

**WHEREAS,** Sheriff's Deputy Erion, will be participating in a K-9 training program with his new K-9 partner Frankie, at a cost of \$5,000, and

**WHEREAS,** Additional funds are also needed to cover the projected cost of supplies, vet services, boarding, and food for Frankie for the remainder of the year, with a projected cost of \$1,000, and

**WHEREAS,** Funds are available in the K-9 Donations Reserve Account from the gifts and donations that have been made to the K9 Program to cover these costs, and

**WHEREAS,** The Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it

**RESOLVED**, That the Genesee County Treasurer is hereby authorized and directed to amend the 2019 budget as follows:

\$6,000 to A3110.4800.3317 (Program Exp-Canine Program)

To be offset by increasing the following revenue account:

\$6,000 to A3110.2705 (Gifts and Donations), with funds to come from A915.6 (K-9 Assigned Unappropriated Funds)

**Budget Impact Statement**: Increase in Sheriff's 2019 appropriations in the amount of \$6,000; offset by an increase in revenue in a like amount. Funds will come from the K9 Donations Reserve Account.

Legislator Dibble seconded the resolution which was adopted by 281 votes, Legislator Bausch (45) absent.

### RESOLUTION NO. 102 GRANT AWARD-GENESEE JUSTICE/NYS DIVISION OF CRIMINAL JUSTICE SERVICES-APPROVAL OF

Legislator Maha offered the following resolution:

WHEREAS, The Program Coordinator of the Genesee Justice Program did receive notification of the award of grant funding from the New York State Division of Criminal Justice Services for the continuation of the Community Service Sentencing Program and the Pre-Trial Services Program for a one-year contract term starting July 1, 2019 through June 30, 2020, and

**WHEREAS,** The Public Service Committee did review and does recommend acceptance of the grant funding at this time. Now, therefore, Be it

**RESOLVED,** That the Genesee County Legislature does hereby accept grant funding from the New York State Division of Criminal Justice Services in the amount of \$41,876 for the continuation of the Community Service Sentencing Program and the Pre-Trial Services Program for 2019-2020, and Be it further,

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary form for the acceptance of funds for the period of July 1, 2019 through June 30, 2020 in the amount of \$41,876.

**Budget Impact:** There is no amendment for the 2019 County Budget as we receive this grant yearly, and we have already placed monies in our 2019 county budget. There was no change in amount of the grant award.

Legislator Stein seconded the resolution which was adopted by 281 votes, Legislator Bausch (45) absent.

#### RESOLUTION NO. 103 AWARD OF BID – HIGHWAY – PAVEMENT MARKINGS – APPROVAL OF

Legislator Stein offered the following resolution:

**WHEREAS,** The Genesee County Highway Superintendent and the Purchasing Department did receive bids for the painting of pavement markings on county roads and airport, and,

**WHEREAS**, The Genesee County Highway Superintendent has reviewed the bids and the qualifications of bidders and does recommend awarding contracts at this time, and

**WHEREAS,** The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a renewal contract with Seneca Pavement Markings, Inc., 23 Hunters Run, Horseheads, NY 14845 for the application of pavement markings as bid under Item Groups A and B as per specifications, effective June 1, 2019 through May 31, 2020 in an amount not to exceed budgeted amounts.

**Budget Impact Statement**: The County Road Fund includes \$165,000 for highway pavement markings. Legislator Torrey seconded the resolution which was adopted by 281 votes, Legislator Bausch (45) absent.

### **RESOLUTION NO. 104**

### AWARD OF BIDS – HIGHWAY/ CONSTRUCTION MATERIALS – APPROVAL OF

Legislator Maha offered the following resolution:

**WHEREAS**, The Genesee County Highway Superintendent advertised specifications for the various construction materials used by Genesee County for highway and bridge maintenance and construction, and

**WHEREAS,** The Highway Superintendent did review these bids and does recommend their award at this time, and

**WHEREAS**, The Committee on Public Service did review this request and does recommend an award at this time. Now, therefore, Be it

**RESOLVED**, That the Genesee County Highway Superintendent is hereby authorized and directed to award bids to the various vendors on the annual construction materials bid as allowed for under the specifications for each item and as budgeted for within the 2019 County Budget and capital projects as established.

**Budget Impact**: This is an annual bid that allows the Highway Superintendent to purchase materials in compliance with the General Municipal Law. The cost of most asphalt related materials are expected to remain fairly flat

through the construction season. The purchase of materials is limited by budgeted amounts within the County Road Fund and the various capital projects in place for the repair and replacement of highways and bridges. The Highway Superintendent uses low bid, as adjusted by the contract hauling formula. The Highway Superintendent also reserves the right to award bids in the best value for the County based on availability of product, equipment failures and long wait times.

Prior to the vote Legislator Hilchey disclosed that he works for a company that the County purchases construction materials from and will abstain from the vote.

Legislator Dibble seconded the resolution which was adopted by 253 votes, Legislator Bausch (45) absent, Legislator Hilchey (28), abstain.

# RESOLUTION NO. 105 AWARD OF BID – GENESEE COUNTY JAIL/ FIRE ALARM CONTROL PANEL – APPROVAL OF

Legislator Torrey offered the following resolution:

**WHEREAS,** The Genesee County Highway Superintendent did obtain contract pricing from the New York State Office of General Services for the replacement and upgrade of the Fire Alarm Control Panel at the Genesee County Jail, and,

**WHEREAS,** The Genesee County Highway Superintendent has reviewed the proposal and does recommend awarding a contract at this time, and

**WHEREAS,** The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a contract with Johnson Controls, 90 Goodway Dr, Rochester, NY 14623 in an amount not to exceed \$27,571.28.

**Budget Impact Statement**: A capital project has been established for this purpose in the amount of \$45,000. Legislator Maha seconded the resolution which was adopted by 281 votes, Legislator Bausch (45) absent.

Legislator Stein offered the following resolution:

WHEREAS, Genesee County completed a Master Plan for the advancement of Phase 2 of the

Countywide Water Project and initiated project engineering, and,

**WHEREAS**, Permanent easements are being obtained for the construction of the project and bids are being prepared for construction, and

WHEREAS, The Genesee County Legislature desires to advance these projects, and

**WHEREAS**, Temporary funding for the advancement of land acquisition and construction are available in the Infrastructure Reserve, and

**WHEREAS,** The Genesee County Highway Superintendent and the Assistant County Treasurer have recommended the temporary use of \$5 million in funding to be replaced by future bonding when made available, and

**WHEREAS,** The Committees on Public Service and Ways and Means did review this recommendation and do concur. Now, therefore, Be it

**RESOLVED**, That the Genesee County Legislature does hereby authorize and direct the Genesee County Treasurer to establish a capital project for the Countywide Water System – Phase 2 in the amount of \$5 million with funding from the County Infrastructure Reserve, and further

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to amend the 2019 County Budget by increasing H.8397 2080.0000 Water Capital Projects - Equipment & Capital Outlay in the amount of \$5,000,000 offset by increasing H.8397 5031 Interfund Transfer in the amount of \$5,000,000 and by increasing A.9950 9000.0000 Transfer to Capital in the amount of \$5,000,000 offset by increasing A.1000.9999 Balancing utilizing the Building and Equipment - Roads and Bridges Reserve in the amount of \$5,000,000.

**Budget Impact Statement**: The County Infrastructure Reserve will be used to establish a capital project in the amount of \$5,000,000. It is required that future MCWA bonding for Phase 2 will refund or replace the Infrastructure Reserve Funds.

**WHEREAS,** Permanent easements are being obtained for the construction of the transmission mains, pump stations and other appurtenances required for the advancement of Phase 2 of the Genesee County Countywide Water Project, and

**WHEREAS,** The Genesee County Highway Superintendent and the County Attorney recommend the approval of the easements required for Phase 2 Water, and

**WHEREAS,** The Committees on Public Service and Ways and Means did review this recommendation and do concur. Now, therefore, Be it

**RESOLVED,** That the Genesee County Legislature does hereby authorize and direct the Chairperson of the Legislature to execute any and all land acquisition agreements and easements required for the construction of water infrastructure as required by Phase 2 of the Countywide Water Project.

**Budget Impact Statement**: It is estimated that acquisition of easements will cost approximately \$49,604. These costs will be borne by the Capital Project Established for the Countywide Water Project – Phase 2.

Legislator Deleo seconded the resolution which was adopted by 281 votes, Legislator Bausch (45) absent.

#### **RESOLUTION NO. 109**

#### ESTABLISH CAPITAL PROJECT/BUDGET AMENDMENT – AIRPORT – GROUND SERVICE EQUIPMENT – APPROVAL OF

Airport Ground Service Equipment \$475,000

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to amend the 2019 County Budget by increasing H.5997 2080.0000 Other Transportation Capital Projects -Equipment & Capital Outlay in the amount of \$475,000 offset by increasing H.5997 3897 State Aid in the amount of \$356,250 and H.5997 5031 Interfund Transfer in the amount of \$118,750 and by increasing A.9950 9000.0000 Transfer to Capital in the amount of \$118,750 offset by increasing A.1000 1110.1 1% Sales Tax in the amount of \$118,750.

**Budget Impact Statement**: The total project cost is \$475,000, which is funded by a state aviation grant in the amount of \$356,250 and a local match from the 1% sales tax in the amount of \$118,750.

**RESOLVED,** The Genesee County Legislature hereby adopts the Genesee County Fair Housing Policy as the official Plan for compliance with Community Development Block Grant, and Be it Further

**WHEREAS**, certain laws, rules and regulations and edicts legislated by the State of New York have resulted in a trend of Genesee County residents leaving because they do not reflect the culture of Genesee County, thus resulting in less citizens on the tax rolls to support the efforts of said County, and

WHEREAS, Certain State of New York laws, rules, regulations and edicts are not applicable in Genesee County because of the culture found within Genesee County, now therefore Be it **RESOLVED**, that the County of Genesee of the State of New York proclaimed the intension of invoking "Home Rule" within the parameters set forth by the NYS constitution to decide which laws, rules, regulations and edicts set forth by the State of New York are beneficial to Genesee County and support the Rights, Liberties and general well-being of its residents, and Be it Further

**RESOLVED**, that this resolution be forwarded to Governor Cuomo, NYS Senate Leader, NYS Assembly Speaker, Senator Michael Ranzenhofer, Assemblyman Steve Hawley, GAM, NYSAC and Inter County Association and any other interested parties.

## RESOLUTION NO. 124 AUTHORIZATION FOR HOME RULE REQUEST – TO REQUEST SPECIAL LEGISLATION FOR A FORTY YEAR SALES TAX ALLOCATION AGREEMENT BETWEEN THE COUNTY OF GENESEE AND THE CITY OF BATAVIA - APPROVAL OF

Legislator Stein offered the following resolution:

**WHEREAS**, The County of Genesee and the City of Batavia have negotiated an "Amended and Restated Sales Tax Allocation Agreement between the County of Genesee and the City of Batavia" herein after "Amended and Restated Agreement" which is acceptable to both parties, and

**WHEREAS**, Genesee County and the City of Batavia are desirous of making a long term commitment to Capital Project funding and controlling their respective property tax rate under the New York State Property Tax Cap Mandate, and

**WHEREAS**, this Amended and Restated Agreement is authorized by Section 1262<sup>©</sup> of the New York State Tax Law subject to approval of the Office of the Comptroller, and

**WHEREAS**, the Comptroller's Office has had a long standing policy to deny approval of any Sales Tax Allocation Agreements for a period in excess of ten years, and

WHEREAS, the forty year length of the Amended and Restated Agreement is necessary for both the County of Genesee and the City of Batavia to provide long term sales tax stability that will allow both municipalities to enter into a forty year sharing agreement to maintain an affordable water supply with increased capacity; as well as to provide revenue for future respective infrastructure and capital projects. Now, therefore, Be it

**RESOLVED**, That the Genesee County Legislature hereby requests the New York State Legislature to support and pass Senate Bill No. Bill No. S.04247 and Assembly Bill No. A.6590 which is the legislation necessary for the County of Genesee and City of Batavia to enter into an agreement pursuant to the authority of subdivision (c) of Section 1262 to allocate and distribute a portion of net collections due the county from its taxes imposed pursuant to the authority of subdivision (a) of Section 1262, which will make the agreement for a term not to exceed forty years and the state comptroller shall not disapprove such agreement based on the length of its term, provided that such term shall not exceed forty years, and Be it further

**RESOLVED**, That the Chair of the Genesee County Legislature is authorized and directed to sign the necessary Home Rule Request, and Be it further

**RESOLVED**, That a copy of this resolution for Home Rule Message be sent to Governor Andrew Cuomo, Senator Michael Ranzenhofer and Assemblyman Stephen Hawley.

Legislator Maha seconded the resolution which was adopted by 281 votes, Legislator Bausch (45) absent.
