The Genesee County Legislature met in Regular Session on Wednesday, April 13, 2022 at 5:30 p.m. in the Legislature Chamber of the Old Court House. Zoom video conferencing was made available. Legislator Maha offered to assist with the audit. The prayer was offered by Legislator Dibble followed by the Pledge to the Flag.

Clerk of the Legislature announced the following: Proclamations & Commendations

Human Services Committee Chair, Legislator Torrey presented the National Public Health Week April 4-10, 2022 Proclamation – accepted was Brenden Bedard, Deputy Director.

E-911 Advisory Board Liaison/Legislator Klotzbach presented the National Public Safety Telecommunications April 10-16, 2022 Proclamation – accepted Steven Sharpe and Asst Director Frank Riccobono and Shelby Turner of Emergency Service Dispatchers.

Human Services Committee Member, Legislator Dibble presented the Animal Care and Control Appreciation Week April 11-17, 2022 proclamation - accepted Sarah Fountain and Catherine Seward (Dog Control Officers). Sheriff Sheron was also present for the proclamations.

Minutes of the March 23, 2022 Legislature meeting were approved upon motion of Legislator Klotzbach seconded by Legislator Clattenburg, carried unanimously.

Committee & Special Assignment Reports: Legislator Maha discussed Water Resources Agency Meeting. The figures for Phase 3 is in the amount of upwards of \$135 Million, in order to move forward will need outside funding and grant funding so that it is not falling on the tax payers backs. Madam Chair mention Highway Superintendent Tim Hens who wears many hats. Tim educated the attendees at the meeting on where this Phase 3 is. The County is determined to have a dedicated team to address the needs especially the grant applications and other funding. It was stated it is important to approach this all hands on as a team. More information to come to the Public Service Committee in the near future. Legislator Clattenburg stated consultants, grant writers and highway team working hard and will leave no stone unturned.

Communications & Petitions - United Way Campaign – Tim Hens spoke on the campaign and how important it is to give back to the community. United Way supports 23 agencies throughout the County. Campaign runs to the end of April. This year increased the goal to 22K. Mr. Hens handed out Oliver's chocolate cookies to the legislators and asked for their support.

Legislator Comments – Legislator Clattenburg stated Legislator Deleo and Hawley and herself attended the Youth Bureau Breakfast and it was great to be back in person. Well deserved awards given out to many youth in our community. Madam Chair discussed the American Public Works Association (APWA) awarded Laura Wadhams our Assistant County Engineer with the Young Leader Award. County Manager Report – Mr. Landers discussed the NYS Budget and NYSAC updates on highlights of the budget. AIM diversion was scheduled to end, but it made the budget. \$550,000 will help Genesee County and also the City of Batavia as a share and sales tax that this is a big positive. Help Distressed Health care Diversion win, another big plus. Removal of the right of way fees for Broadband, this was a large cost of the installations. Broadband potential to be in residential areas into Genesee County. Keeping Local Sales Tax Local was passed as well. Huge plus. ACCEPTANCE/BUDGET AMENDMENT-PUBLIC HEALTH/ NEHA-FDA RETAIL FLEXIBLE FUNDING MODEL GRANT - APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the Public Health Department applied for funds to support costs associated with updating the self-assessment of all of the nine standards as part of the Retail Standards Grant Program, and

WHEREAS, the Association of Food and Drug Officials has awarded the Genesee County Public Health Department \$1,500 funded by the Food and Drug Administration, and

WHEREAS, the Committees on Human Services And Ways and Means did review this award and does recommend approval at this time. Now therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized to accept this award for \$1,500 as specified in Federal statutes and regulations. Be it further **RESOLVED,** that the Genesee County Treasurer is hereby authorized and directed to amend the 2022 Genesee County Budget to reflect an increase of \$1,500 in Appropriations A 4010 4800.0000 to be offset by an increase of \$1,500 in A 4010 4401.60 FDA Self-Assessment

Budget Impact: An increase in expenditures in the amount of \$1,500 to be offset by an increase in revenue of \$1,500. No county cost.

RESOLUTION NO. 166

PLANNING INITIATIVE - YOUTH BUREAU AND DEPARTMENT OF SOCIAL SERVICES/2022 YOUTH BUREAU RESOURCE ALLOCATION PLAN – APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, the Genesee County Youth Bureau and Department of Social Services have developed a joint plan to be eligible for state aid from the New York State Office of Children and Family Services under the Child and Family Services Planning Guidelines, and

WHEREAS, the Genesee County Youth Board, Youth Bureau and Department of Social Services are desirous of continuing county comprehensive youth services planning efforts during 2022 which includes the allocation of resources to municipalities and community based agencies to the extent said funding is provided by NYS and with no expectation of direct Genesee County appropriation, and

WHEREAS, guidelines provided by the Office of Children and Family Services for applying for said eligibility have been satisfactorily completed by the Genesee County Youth Bureau and the Committee on Human Services does recommend approval at this time. Now, therefore, Be it

RESOLVED, that the Genesee County Legislature does hereby authorize the Chair to execute such documents as are deemed necessary to effect the 2022 Genesee County Youth Bureau Resource Allocation Plan and the Child and Family Services Plan with the New York State Office of Children and Family Services.

Budget Impact: Resource allocation to contract programs is included in the 2022 department budget. Allocations are completely offset by revenue. All payments to programs/agencies are subject to availability of state aid.

Legislator Dibble seconded the resolution which was adopted by 279 votes Hawley (47) absent.

RESOLUTION NO. 167

BID REJECTION-PUBLIC HEALTH/LAB EQUIPMENT – APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, Genesee County advertised specifications and receive bids for Bid 2021-17 Lab Equipment, and

WHEREAS the Genesee and Orleans County Public Health Director did review this bid and recommends that the County reject all bids at this time, and

WHEREAS the Committee of Human Services did review this recommendation and does concur at this time. Now, therefore, be it

RESOLVED, that the Genesee County Legislature does hereby reject all bids received for the lab equipment as specified in Bid 2021-17 Lab Equipment.

Budget Impact: The bids received were more than the anticipated amount budgeted. The Public Health Department will re-evaluate for lab equipment.

RESOLUTION NO. 168

FUNDING AGREEMENT -GENESEE COUNTY CHAMBER OF COMMERCE AGREEMENT/ BUSINESS EDUCATION ALLIANCE - APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, the 1989 "Genesee 2000" strategic planning process resulted in the formation of the Business Education Alliance as an adjunct of the Genesee County Chamber of Commerce, and

WHEREAS, the Business Education Alliance provides services and programs that promote the formation of partnerships among businesses and schools for the continuous improvement of education and employment readiness within Genesee County, and

WHEREAS, the County is desirous of supporting such a program, and

WHEREAS, the Committee on Human Services did review the agreement and does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature be and hereby is authorized and directed to execute an agreement by and between the County of Genesee and the Genesee County Chamber of Commerce, 8276 Park Road, Batavia, NY for the Business Education Alliance program during the contract term of January 1, 2022 through December 31, 2022 in the amount of \$3,107.00 regular funding and \$6,000 summer camp funding.

Budget Impact: \$3,107 regular appropriation /\$6,000 summer camp funding – \$9,107 Total Funding

RESOLVED, that the Chairman of the Genesee County Legislature be and hereby is authorized and directed to execute the necessary documents to implement a contract between the County of Genesee and GLOW OUT for the provision of LGBTQ Community Supports/Programs at a cost not to exceed \$4,000 for the period January 1, 2022 through December 31, 2022 in accordance with the terms of said contract. Be it further

RESOLVED, that the county agrees to contribute a total sum not to exceed \$4,000 in accordance with the terms of the contract attested to by the President of the Genesee County Community Services Board and the Chairman of the Board of Director for GLOW OUT, approved as to form by the Genesee County Attorney.

Budget Impact: Funding included in 2022 approved budget – \$4,000.
