EIGHTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, April 24, 2019

The Genesee Legislature met in Regular Session on Wednesday April 24, 2019 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Maha assisted with the audit. Prayer was offered by Legislator Maha followed by the Pledge to the Flag.

Minutes of the April 10, 2019Legislature Meeting were approved upon motion of Legislator Clattenburg seconded by Legislator Torrey, carried unanimously.

Legislator Stein reported that she attended the April GAM meeting where there following was discussed; the first Jail public input meeting is May 16th, a review of the mandate monitor tool provided GAM members with information relating to the cost and percentage of County dollars for state mandated programs and services, the Town of Bethany recently joined MEGA. A summary of the April Inter County Association meeting included an update from NYSAC President Chuck Nesbitt, Veterans Director Bill Joyce regarding the planned National Cemetery in Pembroke, NYSAC Legislative Director Mark Levine and a powerpoint presentation from Biologist Paul Hess who runs the Iroquois National Wildlife Refuge. Chairman Bausch commented on the beautiful facility at the Refuge and the value of information from Veterans Director Joyce and the pre-determination process for burial in a National Cemetery. Chairman Bausch reported that he attended the Regional Planning Council meeting and shared that there is an upcoming webinar on election reform sponsored by NYSAC.

Legislature Clerk Pamela LaGrou indicated a letter was received by Legislators Stein and Torrey from the Town of Bethany regarding their opposition to a State bill that if passed will adversely impact farms, farmworkers and the Ag industry. Of specific concern was if farms leave who will be left to pay debt service on water. It was stated that the Town of Bethany is aware that the Legislature passed a resolution opposing the Farm bill.

County Manager Jay Gsell stated the County received notification the Comptroller's office scheduled an entrance conference for next week and will focus on the County's Ethics oversight. Legislators will receive notification directly from the Comptroller's office but are not able to attend the entrance conference.

WHEREAS, Article 25AA of the New York State Agriculture and Markets Law, Section 303-a specifies that the County Legislative Body shall review any agricultural district created under this section eight years after the date of its creation and every eight years thereafter, and

WHEREAS, Article 25AA of the New York State Agriculture and Markets Law, Section 303-a specifies that the County Legislative Body shall hold a public hearing to review any modifications and recommendations proposed as a result of this review. Now, therefore, Be it

RESOLVED, That a Public Hearing shall be held as part of the eight-year review of Agricultural District No. 3 on Wednesday, May 8, 2019 at 5:30 PM at the Genesee County Old Courthouse, 7 Main Street, Batavia, New York.

Budget Impact: Funds were allocated in Planning departmental budget for 2019 including Postage \$320, Copier Cost/Copy \$100, and Printing \$50.

WHEREAS, the Public Service Committee did review the contract and does recommend acceptance at this time. Now, therefore, Be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute Contract Number: CAFA218, with the New York State Office of Indigent Legal Services for the period January 1, 2017 through December 31, 2019.

BUDGET IMPACT STATEMENT: Total contract revenue for 2019 in the amount of \$144,750 is within the 2019 Adopted Budget in line A.1170.3025 Indigent Legal Services.

supplemental agreement and amending the capital project for the replacement of the bridge, and

WHEREAS, The Committees on Public Service and Ways and Means did review this recommendation and do concur. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature hereby approves the above subject Project; and be it further

RESOLVED, That Genesee County Legislature does hereby authorize the County Treasurer to pay in the first instance 100% of the federal and non-federal share of the cost of the Project or portions thereof; and be it further

RESOLVED, That the Genesee County Legislature hereby agrees that the County of Genesee shall be responsible for all costs of the Project which exceed the amount of the BRIDGE-NY Funding awarded to the County of Genesee; and be it further

RESOVLED, That a Capital Project for the Pratt Road Bridge over Tonawanda Creek be increased in the amount of \$1,842,050, with \$1,469,650 funded from federal aid and \$389,400 funded by state aid; and be it further

RESOLVED, that the Genesee County Legislature does hereby direct and authorize the Genesee County Treasurer to make the following budget amendment: Increase H5197 4592 Federal Aid in the amount of \$1,469,650 and Increase State Aid H1000.5997.3897 in the amount of \$389,200. RESOLVED, That the Genesee County Legislature hereby agrees that construction of the Project shall begin no later than eighteen (18) months after award and that the project shall be completed within three years of commencing construction; and be it further

RESOLVED, That the Chairperson of the Genesee County Legislature be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or State Aid on behalf of the County of Genesee with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of Project costs and permanent funding for the local share of the federal aid and state-aid eligible Project costs and all project costs within appropriations therefore that are not so eligible; and be it further

Budget Impact: A capital project for the Pratt Road Bridge over Tonawanda Creek be increased to a total amount of \$2,033,050 with federal aid share at \$1,651,100, state share at \$389,200 and local match from 1% sales tax at \$9,550.

Legislator Hilchey offered the following resolution:

WHEREAS, a Project for the replacement of Judge Road over Whitney Creek (BIN: 3314960), Towns of Alabama, P.I.N. 4GN0.02 (the "Project"), County of Genesee is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ration of 80% Federal Funds, 15% State Funds and 5% Local Match; and

WHEREAS, Genesee County desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of the total project, Now, therefore, be it

RESOLVED, that the Genesee County Legislature does hereby approve all future supplemental agreements and the federal aid master agreement for the Project; and it is hereby further

RESOLVED, that the Genesee County Legislature hereby authorizes the Chairperson to pay in the first instance 100% of the federal and non-federal share of the cost of the Project or portions thereof; and it is further

RESOLVED, that the Chairperson hereby is authorized and directed to execute all agreements, supplemental agreements and reimbursement requests on behalf of the County towards the execution of the project, and it is further

RESOLVED, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the Genesee County Legislature shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the New York State Department of Transportation thereof, and it is further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project, and it is further

RESOLVED, that the Genesee County Legislature does hereby direct and authorize the Genesee County Treasurer to establish a capital project Judge Road over Whitney Creek in the amount of \$1,183,000 with federal aid of \$946,400, state aid of \$177,450 and a local match from 1% sales of \$59,150

RESOLVED, That Genesee County Legislature does hereby authorize and direct the County Treasurer to make the following amendments to the 2019 Budget:

RESOLUTION NO. 159

CONSULTANT AGREEMENT - FEDERAL AID BRIDGE - JUDGE RD

Legislator Hilchey offered the following resolution:

WHEREAS, Genesee County has been awarded a federal aid grant to replace the Judge Road Bridge over Whitney Creek in the Town of Alabama, and

WHEREAS, Superintendent of Highways has reviewed and evaluated engineering proposals submitted for this work under a qualification based selection, and

WHEREAS, The Superintendent of Highways has negotiated a contract with Lu Engineers and recommends approval of a consultant agreement with them at this time, and

WHEREAS, The Committee on Public Service has reviewed this request and does concur at this time, Now, therefore, be it

RESOLVED, That the Chairperson of the Genesee County Legislature is hereby authorized to approve a consultant agreement with Lu Engineers, 339 East Ave, Suite 200, Rochester, NY 14604 for the design of the Judge Road Bridge over Whitney Creek in an amount not to exceed \$162,063.91.

Budget Impact: The agreement is for \$162,063.91. The capital project established for this project has \$1,183,000. The capital project is federally funded with 80% federal aid, 15% state match and 5% local share. Legislator Clattenburg seconded the resolution which was passed by 326 votes.

RESOLUTION NO. 160

CONTRACT RENEWAL FOR SHARED SERVICES/HIGHWAY-APPROVAL OF

Legislator Maha offered the following resolution:

WHEREAS, The Genesee County Superintendent of Highways reported that the Genesee County Highway Department currently shares equipment, materials and services with other Genesee County municipalities and neighboring counties on an informal basis and to be in compliance with New York State Highway Law and General Municipal Law, Genesee County is required to adopt an agreement formalizing this arrangement, and

WHEREAS, the Superintendent of Highways reported that municipalities, including the County of Genesee, have the power and authority to contract for the purpose of renting, leasing, exchanging, borrowing or maintaining of machinery and equipment, with or without operators, with other municipalities, and

WHEREAS, the Superintendent of Highways reported that it has been determined that the County of Genesee and other municipalities have machinery and equipment which are not used during certain periods and have stored materials and supplies which are not immediately needed, and

WHEREAS, it is hereby determined that by renting, borrowing, exchanging, leasing or maintaining highway machinery and equipment and the borrowing or lending of materials and supplies, the County of Genesee and other municipalities may avoid the necessity of purchasing certain needed highway machinery and equipment and the purchasing of or storing a large inventory of certain extra materials and supplies, thereby saving the taxpayers money, and WHEREAS, it is the intent of the County of Genesee to give the Superintendent of County Highways the authority to enter into renting, exchanging, borrowing, lending or maintaining arrangements with the persons serving in similar capacities in other municipalities without the necessity of obtaining approval of the City/County/Town/Village governing board prior to the making of each individual arrangements, and

WHEREAS, Genesee County authorized such arrangements with other municipalities on February 27, 2006 and the Superintendent of Highways is requesting that such an arrangement be continued through an extension of the original agreement, and

WHEREAS, The Committees on Public Service and Ways and Means has determined that it will be in the best interests of the County of Genesee to continue to be a party to such shared service arrangements, and does concur with this recommendation. Now, therefore, Be it RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the Highway Shared Services Agreement which shall be effective immediately through February 2020, and Be it Further

RESOLVED, The Legislative Clerk is authorized and directed to file a copy of the contract set forth in this resolution with the Supervisors/Mayors/Board Presidents of the municipalities within Genesee County.

Budget Impact Statement: None. Sharing municipal services is a cooperative effort to save money.

Legislator Maha seconded the resolution which was passed by 326 votes.

RESOLUTION NO. 161 AWARD OF BIDS

AWARD OF BIDS -HIGHWAY/GENESEE COUNTY CULVERTS (PH3)

Legislator Torrey offered the following resolution:

WHEREAS, the Genesee County Highway Superintendent commissioned a comprehensive bridge and culvert inventory and assessment that identified a significant number of bridges and large culverts that need to be replaced; and

WHEREAS, construction documents and specifications were prepared, advertised for the precasting of concrete culvert components to be used during bridge replacements and the County received two bids, and

WHEREAS, the bids were reviewed for accuracy and the Genesee County Highway Superintendent recommends the award of bid items; and

Budget Impact: The total cost of the bid award is \$158,756 which will be paid from the Capital Project for Large Span Culverts. Budget Impact: This is a transfer within divisions of the County Road Fund.

WHEREAS, Genesee County desires to advance certain portions of water improvements being made by the Town of Alexander Water District #5 which benefits the County and are described in the Master Plan and Engineering Report for Phase 2 of the Countywide Water Project, and WHEREAS, the Genesee County Highway Superintendent and the County Attorney have prepared an agreement that provides an annual reimbursement to the Town of Alexander under terms acceptable to the County and recommend its approval at this time, and

WHEREAS, the Genesee County Water Resources Agency recommends approval of the Intermunicipal Agreement with the Town of Alexander, and

WHEREAS, the Committees on Public Service and Ways and Means have reviewed this request and do concur at this time. Now, therefore, Be it

RESOLVED, that Genesee County Legislature does hereby authorize the Chairperson of the Genesee County Legislature to approve the Intermunicipal Agreement between Genesee County and the Town of Alexander related to the Phase 2 Water Improvements.

Budget Impact Statement: Per the agreement, the County Water Fund will reimburse the Town of Alexander \$158,081 for 30 years. This annual reimbursement represents the amortized cost of the approximately \$2.7 million in improvements that the Town of Alexander is making on behalf of Genesee County.

Budget Impact Statement: Per the agreement, the County Water Fund will reimburse the Town of Elba up to \$995,000 for upsizing transmission mains and water storage tower that benefit the countywide system. Reimbursements will be made as the Town of Elba completes the project upgrades and they are certified complete by their Engineer. These costs will be funded from the Capital Project established for the Phase 2 Countywide Water System.

WHEREAS, The Genesee County Highway Superintendent did negotiate a contract price based on the scope provided an does recommend entering into a consultant agreement for this work, and

WHEREAS, The Committee on Public Service did review this recommendation and does concur at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature does hereby authorize and direct the Chairperson of the Genesee County Legislature to enter into a consultant agreement with Clark Patterson Lee, 250 St Paul Street, Suite 500, Rochester, NY 14623 in an amount of \$900,000 for the purposes of Construction Management and Construction Support.

Budget Impact: The consultant agreement is for \$900,000 and is funded from the Capital Project for Countywide Water PH2. The capital project is expected to be reimbursed from local and MCWA bond proceeds. Legislator Torrey seconded the resolution which was passed by 326 votes.
