The Genesee County Legislature met in Regular Session on Wednesday, May 8, 2024 at 5:30 PM in the Legislative Chambers of the Old Courthouse.

Legislator Klotzbach offered the audit, the prayer and the Pledge to the Flag.

**WHEREAS,** the American Rescue Plan Act (ARPA) was signed into law March 11, 2021 with Genesee County scheduled to receive a total of \$11,125,969 Million in Coronavirus State and Local Fiscal Recovery Funds, and

**WHEREAS,** Treasury issued a Final Rule for ARPA Fiscal Recovery Funds effective April 1, 2022 and ARPA provides that Coronavirus State and Local Fiscal Recovery Funds may be used to respond to the public health emergency or its negative economic impacts including assistance to non-profits, and

WHEREAS, Genesee County Chamber of Commerce, County's designated tourism promotion Agency, reported a loss of revenue as a direct result of the COVID-19 pandemic and submitted a request to the County for \$240,000 to conduct a comprehensive County-wide destination assessment, establish a new brand that identifies Genesee County's unique qualities and assets and create and implement a five (5) year strategic tourism plan, and

WHEREAS, the County of Genesee desires to enter into an Agreement with the Genesee County Chamber of Commerce for the purpose of assisting the County in meeting goals of the ARPA, and WHEREAS, the County Manager, County Attorney and County Treasurer have reviewed and approve of the American Rescue Plan Act Coronavirus State and Local Fiscal Recovery Fund 21.027 Agreement between the County of Genesee and the Genesee County Chamber of Commerce, and WHEREAS, the Ways & Means Committee did review the Agreement and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Chair of the Genesee County Legislature is hereby authorized and directed to execute the American Rescue Plan Act Coronavirus State and Local Fiscal Recovery Fund 21.027 Agreement between the County of Genesee and the Genesee County Chamber of Commerce, and be it further

WHEREAS, the Housing and Urban Development agency has awarded the Genesee County Public Health Department \$1,182,681. This funding will be used to support costs to address health and safety hazards in privately owned/rented housing populations of low income families in Genesee, Livingston, Orleans and Wyoming Counties, and

**WHEREAS**, the Committees on Human Services and Ways and Means did review this award and do recommend approval at this time. Now, therefore, be it

**RESOLVED**, that the Chair of the Genesee County Legislature is hereby authorized and directed to execute an Agreement with the Housing and Urban Development Agency for the acceptance of the Healthy Homes Grant, in the amount of \$1,182,681, for the period May 15<sup>th</sup>, 2024 through November 15<sup>th</sup>, 2027, and to execute any and all other documentation related to this funding.

WHEREAS, said Acts' sponsoring memos provide very limited justification for this legislation by mentioning only concerns regarding IDA applicants "shopping around" amongst IDA;s with overlapping jurisdiction to attempt to obtain the "best deal" and,

**WHEREAS**, local IDA members have vested interests in the communities in which they live and are far more knowledgeable of the local economic development priorities as comparted to a 15 member regional agency spanning counties, and

**WHEREAS**, many of these 15 appointed members of the regional agency could not be expected to be familiar with Genesee County and the communities served by our existing local IDA, and

WHEREAS, accountability for actions taken by industrial development agencies should be vested in individuals who live and work in affected communities and understand the local economic development landscape, and

**WHEREAS**, the Genesee County Legislature agrees with the Genesee County IDA that keeping local decision making on important economic development priorities is imperative and a pillar of local government control accountable to its residents. Now, therefore, be it

**RESOLVED**, that the Genesee County Legislature hereby opposes Senate Bill S4545 and Assembly Bill 3069 that attempt to consolidate all 109 local Industrial Development Agencies into ten Regional Industrial Development Agencies, and be it further

WHEREAS, the RAPID Act has moved the Office of Renewable Energy Siting ("ORES") from the Department of State to the Department of Public Service, to consolidate and expedite permitting procedures for major renewable energy and electric transmission facilities under a new Article VIII of the Public Service Law; and

**WHEREAS,** the RAPID Act undermines sound environmental review of major electric transmission facilities by requiring ORES to render a permit decision within a single year, otherwise the facility shall be automatically approved, regardless of project size or impact on private property or conservation lands; and

**WHEREAS**, the RAPID Act constitutes a significant deprivation of Private Property Rights by extended the power of Eminent Domain to the construction of major electric transmission facilities by large-scale solar and wind developers, said power being currently limited to regulated utilities granted a certificate of environmental compatibility and public need; and

WHEREAS, the RAPID Act will undermine the protection of natural resources by allowing conservation easements to be extinguished anywhere in the state, for the construction of major electric transmission facilities by large-scale solar and wind developers, said authority being currently limited to regulated utilities granted a certificate of environmental compatibility and public need; and

WHEREAS, the RAPID Act further erodes home rule and local decision-making enshrined in the New York State Constitution, Local Government Bill of Rights, Statute of Local Governments, and Municipal Home Rule law, seizing the rights of local governments to determine how communities and property within their jurisdictions develop, and contravening the purpose of comprehensive planning. Now, therefore, be it

**RESOLVED,** the Genesee County Legislature strongly opposes the passage of Part O contained in the Governor's Article VII Revenue Bill relating to the expedited siting of major electric transmission facilities, the use of Eminent Domain, and the extinguishing of conservation easements; be it further **RESOLVED,** the Genesee County Legislature opposes the Governor's recent action which was taken that weakens or eliminates New York's long-standing tradition of Home Rule and local government authority; be it further,

**RESOLVED,** the Clerk of Genesee County is hereby directed to provide a copy of this resolution to Governor Kathy Hochul, Lieutenant Governor Antonio Delgado, members of the State Senate, members of the State Assembly, the New York State Association of Counties, Inter-County
