GENESEE COUNTY LEGISLATURE

The meeting was opened on June 5, 2024 at 4:30 p.m. Meeting location was at 7 Main Street in Batavia, New York at the Old Courthouse in the Legislative Conference room.

Committee Chair Clattenburg announced a quorum was established.

Committee Chair Clattenburg amended the agenda to add a permission to apply for grant-FY2024 Emergency Management Performance Grant and a permission to apply for grant-FY2024 SHSP/SLETPP Grant Program under Emergency Management Coordinator Tim Yaeger. Also amended to remove Calling on Members of the New York State Senate and Assembly to Reform the State's Competency Restoration Process and Support the Passage of S.1874 (Brouk)/ A.5063 (Gunther) from County Manager Matt Landers. Amended to add Travel out of State request for Patrick Reeves, Sheriff's Office for SRO Chaperone with Pembroke Central School, June 17-19 to Washington, DC at no cost to the County. Legislator Maha motioned to approve the amended agenda seconded by Legislator Torrey, carried unanimously.

Minutes of the May 15, 2024 Ways and Means Committee meeting were stand approved by the Committee Chair.

Genesee Community College President/CEO Dr. James Sunser and Genesee Community College CFO Gina Weaver prepared a proposed operating budget for academic year 2024-2025 in the amount of \$37,750,000 with a sponsor share of \$2,836,374. Dr. Sunser and Ms. Weaver recommended for the Legislature to approve of a public hearing held for the proposed operating budget for Genesee Community College for academic year 2024-2025 at 5:30 PM on Wednesday, June 26, 2024 at the Old Courthouse, 7 Main Street, Batavia, New York. This was approved for placement on the next Legislature Agenda upon motion of Legislator Stein seconded by Legislator Maha, carried unanimously.

Genesee Community College President/CEO Dr. James Sunser and Genesee Community College CFO Gina Weaver presented to the Genesee County Legislature the proposed operating budget of Genesee Community College for the academic year 2024-2025 for \$37,750,000 and request approval of the sponsor's share of the operating budget for the fiscal year September 1, 2024 through August 31, 2025 for \$2,836,374 and cause the same to be included in the County Tax levy for the year 2024. This was approved for placement on the next Legislature Agenda upon motion of Legislator Torrey seconded by Legislator Stein, carried unanimously.

County Clerk Michael Cianfrini reported the office is in need of an adjustable desk and available

funds can be transferred within the County Clerk budget to accommodate the requested expense. Mr. Cianfrini requested authorization to make the following 2024 transfer: \$619. This was approved for placement on the next Legislature Agenda upon motion of Legislator Maha seconded by Legislator Torrey, carried unanimously.

GENESEE COUNTY LEGISLATURE

Public Communications and Wed Design Specialist Steven Falitico presented a Website Design and recap of the website project. The presentation provided the Legislature with visuals of the new website layout, features and services.

Emergency Management Coordinator Tim Yaeger presented a permission to apply for grant request for the FY2024 Emergency Operations Center Grant Program Application to improve emergency management and preparedness capabilities. Legislator Maha moved to approve the request seconded by Legislator Stein.

Mr. Landers recommended for the Legislature to execute the contract amendment with Assured Partners, 90A John Muir Drive, Suite 100, Amherst, NY, 14228, for the coordination of CMS prescription drug data collection at a cost not to exceed \$2,000 annual effective May 1, 2024 for the term of the Agreement.
