TWELFTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, June 24, 2020

The Genesee County Legislature met in Regular Session on Wednesday, June 24, 2020 at 5:30PM at the Old Courthouse, 7 Main Street, Batavia, New York. Legislator Clattenburg assisted with the audit. Prayer was offered by Legislator Young followed by the Pledge to the Flag.

Legislator Yunker presented a proclamation designating July as Park and Recreation Month to Highway Superintendent Tim Hens, Deputy Superintendent Paul Osborn and members of the ACORNS. The County Park and DeWitt Recreation area have seen a 300% increase in visitors this spring. Park availability and outdoor recreation is of greater importance to residents during the global COVID-19 pandemic. Mr. Hens acknowledged the support of the Legislature and commended the dedication and commitment of Paul Osborn. ACORNS contributed nearly \$500,000 in volunteer hours, money gifts and equipment.

Minutes of the June 10, 2020 Legislature meeting were approved upon motion of Legislator Young seconded by Legislator Deleo, carried unanimously.

Legislator Dibble stated he and Legislator Torrey attended the first fire service task force meeting where an historical update was provided by EMS Coordinator Tim Yaeger. Legislator Maha reported on attendance at Inter County Association where there were 46 in attendance via Zoom. Genesee County is scheduled to host the August meeting at Draves Arboretum in Darien. Chairperson Stein reported on discussions with Sheriff Sheron pertaining to the plan and timetable for the newly required state mandate for local law enforcement to engage in the re-innovation, collaboration and review process. The Sheriff's department is undergoing the certification process which will be concluded later this year. With the CJAC committee already in place Genesee County is better prepared to engage appropriate segments of our community. Chairperson Stein thanked community members who worked on the front lines caring for COVID-19 virus patients and all who have worked through Pause NY to ensure community members in need of food or meals were cared for, essential businesses remained open all while following guidelines and safe practices. County Manager Jay Gsell was commended and thanked for his dedication to ensuring county business was conducted and guidelines and protocols were followed these past three months. Chairperson Stein acknowledged the support of vice-chair Clattenburg and thanked her for service during this unprecedented pandemic.

County Manager Jay Gsell commented that the economic recovery committee has been meeting and discussing ideas and options. Finger Lakes region is expected to move into Phase 4 of reopening June 26. The governor continues to determine which activities and businesses will be included in each phase. Today, the governor issued a travel advisory concerning people who have visited States with a resurgence of COVID-19 positives. People are expected to self-quarantine for 14-days. Newly appointed district #1 legislator Chad Klotzbach had a tour of several county departments and met with department heads.

ACCEPTANCE OF BVP FUNDING/BUDGET AMENDMENT/SHERIFF – BODY ARMOR -APPROVAL OF

Legislator Young offered the following resolution:

WHEREAS, The Sheriff's Office is requesting to accept funding in the amount of \$11,956 from the Office of Justice Bulletproof Vest Program, for the purchase of body armor for Sheriff's Deputies and Correction Officers, and

**WHEREAS**, There are also funds available in the Restricted Account-Uniform Vests, as well as individual uniform allowances, for the purchase of body armor, and

**WHEREAS,** The Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it,

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to amend the 2020 budget as follows:

Increase Sheriff's Account A3110.4580.0000 (Personal Uniforms) in the amount of \$16,572; To be offset by an increase of \$9,156 to Sheriff's Revenue Account A3110.4515 (Federal Aid Bulletproof Vests), and an increase of \$7,416 to Sheriff's Revenue Account A3110.2831 (Contributions From Other Funds) to be transferred from the Restricted Account-Uniform Vests A899.6, and

Increase Jail Account A3150.4580.0000 (Personal Uniforms) in the amount of \$4,893; To be offset by an increase of \$2,800 to Jail Revenue Account A3150.4515 (Federal Aid Bulletproof Vests), and an increase of \$2,093 to Jail Revenue Account A3150.2831 (Contributions From Other Funds) to be transferred from the Restricted Account-Uniform Vests A899.6.

**Budget Impact:** Increase in Sheriff's 2020 appropriation in the amount of \$16,572, for the purchase of body armor, offset by an increase in revenue in a like amount, with funds provided by the OJP Bulletproof Vest Program, and a transfer from the Restricted Account-Uniform Vests.

Increase in Jail 2020 appropriation in the amount of \$4,893, for the purchase of body armor, offset by an increase in revenue in a like amount, with funds provided by the OJP Bulletproof Vest Program, and a transfer from the Restricted Account-Uniform Vests. Legislator Maha seconded the resolution which was adopted by 326 votes.

#### RESOLUTION NO. 240 2020 BUDGET AMENDMENT - PUBLIC DEFENDER-APPROVAL OF

Legislator Yunker offered the following resolution:

**WHEREAS,** The Public Defender is requesting an amendment to the 2020 Public Defender Budget to pay for an additional seven (7) PDCMS licenses in the amount of \$3,500, utilizing unspent ILS grant funds, and

**WHERE AS**, The Committees on Public Service and Ways and Means did review the request and recommend approval at this time. Now, therefore, Be it

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to amend the 2020 Genesee County Budget by Increasing Revenue A.1170.3025 Indigent Legal Services in the amount of \$3,500 and Increasing Appropriations A.1170.4800.0000 Program Expense in a like amount.

**Budget Impact:** Increase in Public Defenders 2020 appropriations in the amount of \$3,500 with funds coming from Indigent Legal Services, Distribution Grant # 8, Project # 10000-2100, offset by revenue in a like amount.

Legislator Klotzbach seconded the resolution which was adopted by 326 votes.

## RESOLUTION NO. 241 MODIFIED CONTRACT EXTENSION- PUBLIC DEFENDER/PDCMS-Approval of

Legislator Dibble offered the following resolution:

WHEREAS, The Public Defender is recommending the (PDCMS) Public Defense Case Management System Maintenance and Software Support Agreement between Genesee County and New York State Defenders Association, Inc. be extended for a one-year period, May 3, 2020, to May 3, 2021, with a modification of the contract to increase the number of its software licenses from eight (8) to fifteen (15), resulting in a new one-year contract price of \$7,500, Be it

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary documents to extend the Public Defense Case Management System Maintenance and Software Agreement between Genesee County and New York State Defenders Association, Inc., Albany, New York for a one-year period, May 3, 2020 to May 3, 2021, with a modification to the contract to increase the number of its software licenses from eight (8) to fifteen (15), resulting in a new one-year contract price of \$7,500.

**Budget Impact:** Funds for this contract in the amount of \$4,000 are budgeted in the 2020 Budget under lines A1170.3025 Revenue and A1170.4880.0000 Program Expense. A budget amendment is also being requested to increase the revenue and the publications expense lines in the amount of \$3,500.

WHEREAS, The Public Defender does recommend the acceptance of a contract for grants amendment between Genesee County and the New York State Office of Indigent Legal Services for Contract No.: C2ND618, Second Upstate Quality Improvement and Caseload Reduction Grant, to extend the original contract terms for a one (1) year period of June 30, 2020 to June 30, 2021.

WHEREAS, the Committees on Public Service and Ways and Means did review the contract for grants amendment and do recommend acceptance at this time. Now, therefore, Be it

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute The contract for grants amendment Contract No.: C2ND618, Second Upstate Quality Improvement and Caseload Reduction Grant, to extend the original contract terms for one (1) year period of June 30, 2020 to June 31, 2021, and it be further

**Budget Impact:** The contract for grants extensions will have no effect on the budget. Legislator Dibble seconded the resolution which was adopted by 326 votes.

### RESOLUTION NO. 243 AWARD OF BID – HIGHWAY – FIRE ALARM – APPROVAL OF

Legislator Yunker offered the following resolution:

**WHEREAS,** The Genesee County Highway Superintendent and the Purchasing Officer did research New York State Office of General Services Contracts relating to fire alarm replacements, and

**WHEREAS**, The Highway Superintendent does recommend awarding the contract to Johnson Controls, Inc for a cost of \$97,083.39, and

**WHEREAS**, The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it,

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to enter into an agreement with Johnson Controls, Inc, 90 Goodway Drive, Rochester, NY 14623 as per the terms of proposal #P37849-000407 under NYSOGS Contract PT68816.

**Budget Impact Statement:** The Highway Fire Alarm Capital Project was established April 22, 2020 (Resolution #181) using 1% Sales Tax for \$97,161.

Legislator Young seconded the resolution which was adopted by 326 votes.

AWARD OF BID – BRIDGE DECKING MATERIALS/McCLERNON RD – HIGHWAY -- APPROVAL OF

Legislator Torrey offered the following resolution:

**WHEREAS**, Genesee County advertised bid specifications for the replacement of bridge decking required for the McClernon Rd Bridge in the Town of Bethany, and

**WHEREAS**, The Genesee County Highway Superintendent researched bids and does recommend an award at this time, and

**WHEREAS,** The Committees on Public Service and Ways and Means have reviewed this request and do concur at this time. Now, therefore, be it

**RESOLVED,** That the Chairperson of the Genesee County Legislature is hereby authorized to execute a contract with Chemung Supply Corporation, 2420 Corning Rd, Elmira, NY 14903 as per the Genesee County IFB #2020-12 in an amount not to exceed \$47,766.25.

**Budget Impact:** The contract is for \$47,766.25. A capital project has been established for McClernon Rd and the local share of \$50,600 will be used to cover the cost of this award.

## RESOLUTION NO. 245 CHANGE ORDERS – COUNTYWIDE WATER PROJECT/PHASE 2 – APPROVAL OF

Legislator Clattenburg offered the following resolution:

**WHEREAS,** Genesee County has begun construction on Phase 2 of the Countywide Water System which secures additional water supply for the County, and

**WHEREAS**, These projects have encountered changes in requirements and unexpected conditions which have increased costs required to complete the projects, and

**WHEREAS,** The Genesee County Highway Superintendent and the CPL Team have reviewed these change requests for need and accuracy of pricing, and

**WHEREAS,** The Genesee County Highway Superintendent recommends approval of the change orders at this time, and

**WHEREAS**, The Committees on Public Service and Ways and Means have reviewed this request and do concur at this time. Now, therefore, be it

**RESOLVED,** That the Chairperson of the Genesee County Legislature is hereby authorized to and directed to approve the following change orders:

Contract 1 Vallance/North Rd Water Mains Randsco Inc. \$190,285 Contract 3A New Pump Stations (General Construction) C.P.Ward Inc. \$143,791 + 31 Days

**Budget Impact:** The total amount for the two change orders is \$334,076. Phase 2 bonding accounted for \$1 million in contingency funds to handle change orders throughout the project. The Vallance Rd change order is a price adjustment for zinc-coated pipe on the 16" and 36" water mains. The Pump Station change orders cover Temporary Pumps needed as backup to meet peak water demands, foundation stabilization, removable bollards and an upgrade on the pump station roofing from asphalt to metal.

Legislator Torrey seconded the resolution which was adopted by 326 votes.

2020 BUDGET AMENDMENT & GRANT ACCEPTANCE – CAPITAL PROJECT/ DEWITT IMPROVEMENTS PHASE IV – APPROVAL OF

Legislator Yunker offered the following resolution:

WHEREAS, The Genesee County Highway Superintendent does request an amendment to the 2020 Genesee County Budget to allow the acceptance of grant funds from the Rotary Club of Batavia, and

**WHEREAS,** The budget increase will allow the Deputy Highway Superintendent to use the funding to purchase 2 extra-large surface mount message boards and eight 6' benches and hardware for the Ellicott Trail, and

**WHEREAS**, The Committees on Public Service and Ways and Means did review this request and recommend approval at this time. Now, therefore, Be it

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to amend the 2020 Genesee County Budget by increasing the Capital Project DeWitt Improvement Phase IV by increasing H1997 2705, Gifts and Donations, in the amount of \$5,265.21 to be offset by an increase in H1997 2080.0000, Capital Project Expense in like amount.

**Budget Impact**: Increase to 2020 budget expense in amount of \$5,265.21. Cost to County \$0.

Legislator Maha seconded the resolution which was adopted by 326 votes.

## RESOLUTION NO. 247 AGREEMENTS -TAX EXEMPT STATUS FOR COUNTY OWNED PARCELS

Legislator Maha offered the following resolution:

WHEREAS, on February 25, 2020, Genesee County purchased two parcels of land, the first one with dimension of 180 feet by 200 feet, which was part of land owned by Edward and Linda Snyder, residing at 280 Molasses Hill Road, East Bethany, New York 14054, within the Town of Attica and the County of Wyoming, being newly designated with Tax Map No. 8.-1-25; and the second one being an adjacent parcel of land with dimensions of approximately 120 feet by 30.06 feet, which was part of land owned by Thomas Snyder, residing at 276 Molasses Hill Road, East Bethany, New York 14054, within the Town of Attica, and the County of Wyoming, being newly designated with Tax Map No. 8.-1-27, (hereinafter "Parcels), and

WHEREAS, it would be in the best interest of the citizens of Genesee County to obtain tax exempt status for both of these Parcels, and

**WHEREAS,** pursuant to Section 406(3) of the Real Property Tax Law, in order to obtain wholly tax exempt status, it is necessary for the County of Genesee to enter into separate Agreements with the County of Wyoming, the Town of Attica and the Attica Central School District, and

WHEREAS, the Genesee County Attorney has drafted the Tax Exempt Agreements for the County of Wyoming, the Town of Attica, and the Attica Central School District, and WHEREAS, the Tax Exempt Agreements have been reviewed and approved by the Attorneys and the Boards for the County of Wyoming, the Town of Attica, and the Attica Central School District, and

**WHEREAS**, the Committees on Public Service and Ways and Means did review this request and do concur with the County Attorney's recommendation. Now, therefore, Be it

**RESOLVED**, that the Tax Exempt Agreements are hereby approved, and the Chair of the Legislature is hereby authorized and directed to execute the Tax Exempt Agreements with the County of Wyoming, the Town of Attica and the Attica Central School District; together with such other and further agreements or documents that will be necessary to allow the above named parcels to be wholly exempt from any taxes and assessments with regards to Wyoming County, the Town of Attica, and the Attica Central School District. Legislator Klotzbach seconded the resolution which was adopted by 326 votes.

## RESOLUTION NO. 248 EASEMENT APPROVAL – SHERIFF'S OFFICE / PUBLIC SAFETY TOWER UTILITY EASEMENT – APPROVAL OF

Legislator Dibble offered the following resolution:

**WHEREAS**, Genesee County is constructing a new Public Safety Communications Tower at 268 Molasses Hill Rd, Attica NY pursuant to Resolution 385, dated October 24, 2019, and

**WHEREAS**, Niagara Mohawk Power Corporation, with offices at 144 Kensington Avenue, Buffalo, New York 14214, requires a utility easement to provide electric service to the new tower, and

WHEREAS, Genesee County received a NYS Statewide Interoperable Communications Grant which included funds for the provision of utilities for communications towers, and WHEREAS, After careful review, the Genesee County Sheriff, County Attorney, Highway Superintendent, and Director of Emergency Communications recommend the County approve the utility easement with Niagara Mohawk Power Corporation, and WHEREAS, The Committee on Public Service did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED**, That the Legislature does hereby approve the proposed Easement for the benefit of Niagara Mohawk Power Corporation, and the Chair of the Legislature is hereby authorized and directed on behalf of the County of Genesee to sign this Easement and any documents necessary to record it.

#### **Budget Impact: None.**

Legislator Yunker seconded the resolution which was adopted by 326 votes.

## RESOLUTION NO. 249 HOUSEHOLD HAZARDOUS WASTE COLLECTION CONTRACT-GLOW SOLID WASTE MGMT. COMMITTEE-APPROVAL OF

Legislator Deleo offered the following resolution:

**WHEREAS**, The GLOW Region Solid Waste Management Committee (herein referred to as "GLOW") anticipates being awarded funding from the New York State Department of Environmental Conservation in 2020 for Household Hazardous Waste Collection Program; and

**WHEREAS**, This funding is to be used to pay for eligible expenses at a single collection planned for September 19 of 2020; and

**WHEREAS,** An RFP (Request for Proposals) was issued and two (2) prospective vendors submitted proposals; and

**WHEREAS,** The GLOW Region Solid Waste Committee does recommend Environmental Enterprises, Inc. for award of the contract for the 2020 HHW Collection Program. Now, Therefore Be It

**RESOLVED,** That the Genesee County Legislature authorizes the Chairperson to enter into this contract with the other GLOW Counties and Environmental Enterprises, Inc. Lab Pack Services Division, 4650 Spring Grove Dr., Cincinnati, Ohio 45232 for the GLOW Household Hazardous Waste Collection Program at a cost not to exceed \$33,000.

**Budget Impact Statement:** Funds are available in the 2020 GLOW Budget for this expense and are in line with past expenditures. In January 2021 GLOW will apply for and expects to receive the NYS DEC Grant the HHW Collection that will cover one-half of "eligible" expenses.

Legislator Dibble seconded the resolution which was adopted by 326 votes.

INSURANCE CERTIFICATE – OFFICE FOR THE AGING/GENESEE COUNTRY FARMERS' MARKET, BATAVIA IMPROVEMENT DISTRICT, CITY OF BATAVIA- 2020 APPROVAL OF

### RESOLUTION NO. 251 PLAN AMENDMENT- HUMAN RESOURCES DEPARTMENT/FLEXIBLE SPENDING ACCOUNT

Legislator Clattenburg offered the following resolution:

**WHEREAS**, Genesee County employees have the opportunity to enroll in a Health Flexible Spending Account program that allows employees to set aside a portion of his or her earnings to pay for qualified medical and/or dependent care expenses, and

**WHEREAS,** As part of its response to the COVID-19 pandemic, the IRS announced on May 12, 2020 that it is permitting increased flexibility for mid-year changes to Health Flexible Spending Account program, and

**WHEREAS**, The Human Resources Director recommends amending the County's Flexible Spending Account Program to include:

- Mid-year election changes particularly to allow employees to revoke an
  election, make a new election, decrease or increase an existing election to
  both medical and/or dependent care program.
- Increase flexibility by extending the grace period to give employees an additional 75 days to use unused amounts that remain in the medical and/or dependent care program at the end of the plan year ending in 2020.

This will allow employees to reap the most benefit from the Health Flexible Spending Account program; and the Committee on Ways & Means does concur. Now, therefore, be it

**RESOLVED,** that the Genesee County's Health Flexible Spending Account Program will be amended to allow mid-year changes due to the COVID-19 pandemic.

Budget Impact Statement: There is a plan amendment cost of \$100 which will come out of the Human Resources 2020 budget. Legislator Torrey seconded the resolution which was adopted by 326 votes.

# RESOLUTION NO. 252 AGREEMENT FOR COUNTY TREASURER TO COLLECT 2021 TOWN/COUNTY TAXES FOR THE TOWN OF STAFFORD - APPROVAL OF

Legislator Young offered the following resolution:

WHEREAS, A recommendation was made by the auditing firm of Freed Maxick in Batavia to the Town Board in Stafford NY to find an alternate method of collecting taxes for the near future, and

**WHEREAS**, the Genesee County Treasurer has offered to collect the 2021 Town/County taxes on behalf of the Town of Stafford for a fee of \$5,000 plus expenses, and

**WHEREAS**, the County Attorney drafted such agreement and the Town of Stafford Supervisor has signed the agreement, and

**WHEREAS**, The Committee on Ways and Means does concur. Now, therefore Be it **RESOLVED**, The Chair of the Genesee County Legislature is hereby authorized and directed to sign the agreement allowing the County Treasurer to collect the 2021 Town/County taxes on behalf of the Town of Stafford.

**Budget Impact:** An increase in revenue of \$5,000 in Treasurer's fees. Legislator Deleo seconded the resolution which was adopted by 326 votes.

**RESOLUTION NO. 253 EXEMPTION OF TAX PARCEL -APPROVAL OF** Legislator Young offered the following resolution:

**WHEREAS,** Article 11 of the Real Property Tax Law Section 1138(1)(c) allows a municipality to withdraw a parcel due to bankruptcy, and

**WHEREAS**, There is a parcel in the Town of Batavia that has been in bankruptcy since 2008 and recently was discharged from bankruptcy and for many reasons the likelihood of getting paid in full is unlikely, and

WHEREAS, There is currently an executive order forbidding tax foreclosures, and

**WHEREAS**, It is the recommendation of the County Treasurer and Real Property Tax Director and the Committee on Ways and Means concurs that in an effort to minimize any further accruing of taxes the property should be made exempt until the property can be foreclosed on or is sold, now therefore be it

**RESOLVED**, That pursuant to Real Property Tax Law Section 1138(6)(d) the Genesee County Legislature does hereby determine that there is no practical method to enforce the collection of delinquent tax liens arising thereafter against this parcel, and Be it further

**RESOLVED**, That Tax Map # 2.-1-21.1 in the Town of Batavia is hereby declared exempt until the parcel transfers or the property can be foreclosed on or is sold.

**Budget Impact:** None, this makes the parcel exempt and will stop the accumulation of additional taxes. The delinquent taxes will not be written off yet.

Legislator Clattenburg seconded the resolution which was adopted by 326 votes.

# RESOLUTION NO. 254 CONTRACT RENEWAL –INFORMATION TECHNOLOGY/ SOFTWARE AND HARDWARE SUPPORT SERVICES LINSTAR- APPROVAL OF

Legislator Maha offered the following resolution:

**WHEREAS**, The Director of Information Technology did present a contract agreement with Linstar for software and hardware support services for the Security Systems and,

**WHEREAS,** The County Attorney and the Committee of Ways and Means did review the request and does recommend approval at this time. Now, therefore, Be it

**BUDGET IMPACT STATEMENT:** The contract cost of \$60,778.04 for Linstar is included in the 2020 Information Technology Budget line A.1680.4600.0000. The contract provides for a maximum 3% increase in the subsequent years of the contract.

## RESOLUTION NO. 255 SET PUBLIC HEARING-GENESEE COMMUNITY COLLEGE/2020-2021 BUDGET-APPROVAL OF

Legislator Torrey offered the following resolution:
