THIRTEENTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, July 22, 2020

The Genesee County Legislature met in Regular Session on Wednesday, July 22, 2020 at 5:30PM at the Old Courthouse, 7 Main Street, Batavia, New York. Legislator Maha assisted with the audit. Prayer was offered by Legislator Torrey followed by the Pledge to the Flag.

In addition to our regular meeting Chair Stein opened a public hearing on the Genesee Community College proposed operating budget and sponsor share for 2020-2021 academic year. All interested parties were invited to be heard.

Resident John Sackett signed up to speak on various agenda items. He shared his views of spending county taxpayer dollars and urged legislators to be conservative in spending.

Legislature Chair Stein stated this is County Manager Jay Gsell's last legislative meeting before his retirement date of August 14, 2020 and presented him with a retirement proclamation. Vice Chair Clattenburg presented Mr. Gsell with a County plaque and thanked him for his years of dedicated service to the citizens of Genesee County. Mr. Gsell served as Genesee County manager for nearly 27 years. He immersed himself in the community where he joined the Rotary Club, served on United Way Board of Directors and was a volunteer for several schools serving as a judge for senior exit projects. He lead the County through the sale of the nursing home, county-wide water project, new court facility, airport enhancements and a forty-year sales tax agreement. Mr. Gsell commented that he has worked with a good team of department heads and is confident Assistant County Manager Matt Landers will step right into the position of county manager.

Minutes of the June 24, 2020 Legislature meeting were approved upon motion of Legislator Maha seconded by Legislator Deleo, carried unanimously.

Legislator Maha reported on the July Inter County Association meeting where the NYSAC representative shared an update on stimulus package negotiations. Legislator Clattenburg attended the E911 meeting and watched an App demonstration and got an update on the emergency communications towers. Legislature Chair Stein commented on recent reports that within the Finger Lakes region 11 people in their 20's diagnosed with Covid-19 are hospitalized and intubated. She asked that continued attention be paid to the recommended distancing, mask-wearing and hand washing. The County continues to host a weekly phone call with supervisors and village officials to keep lines of communication open and provide updates on revenue sharing, cuts to state aid and advocacy with federal representatives for stimulus money.

County Manager Jay Gsell commented that many people in Genesee County have not yet completed the census. Every person needs to be counted to ensure representation and access to state and federal grant funding for future projects. Chris Jacobs has been sworn in as our new congressman and Rep. Tom Reed and staff doesn't need to serve as our adopted representative any longer. More states have been added to the Governor's list of states with high COVID-19 positive cases that require 14-day quarantine upon return or entry into New York.

Legislator Deleo offered the following resolution:

WHEREAS, The Committee on Human Services and Ways & Means recommends approval of a contract with Susan Gagne, Suicide Prevention Coalition Coordinator as presented by the Director of Community Mental Health Services. Now, therefore, Be it RESOLVED, That the Chairman of the Genesee County Legislature be and hereby is authorized and directed to execute the necessary documents to implement a contract between the County of Genesee and Susan Gagne for the provision of Suicide Prevention Coalition Coordinator services at a rate of \$25 per hour for a maximum of 180 hours, not to exceed \$4,500.00 for the period of August 1, 2020 through December 31, 2020 in accordance with the terms of said contract. Funding for this position was allocated in the 2020 budget; this resolution is to create the mechanism for payment.

Budget Impact Statement: Rate – \$25 per hour; not to exceed \$4,500; funds are available in contractual services due not a contracted practitioner being out on medical leave for several months.

WHEREAS, The Justice for Children Advocacy Center has been unable to find a suitable candidate for a vacant Licensed Mental Health Therapist position; and WHEREAS, This contract will allow the Justice for Children Advocacy Center to continue to meet the mental health needs of our clients until an appropriate candidate is selected; and

WHEREAS, The Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now, therefore, be it

RESOLVED, That the Chair of the Genesee County Legislature and the Genesee County Sheriff are hereby authorized and directed to enter into a contractual agreement with Julie A. Budget Impact Statement: The cost per mile for the 2021 snow and ice season is \$6,521 and the cost per mile for mowing is \$474. This represents a 1.1% increase in the rate for snow and ice over the 2020 season and a 2% increase in the cost for mowing. The County Road Fund budgets \$1,492,975 for contractual snow and ice control and \$105,997 for contractual roadside mowing. These contracts cover approximately 223 miles of the 260 miles of county roads.

WHEREAS, Genesee County desires to advance certain portions of water improvements being made by the Town of Bethany Water District #5 which benefits the County and are described in the Master Plan and Engineering Report for Phase 2 of the Countywide Water Project, and

WHEREAS, the Genesee County Highway Superintendent and the County Attorney have prepared an agreement that provides an annual reimbursement to the Town of Bethany under terms acceptable to the County and recommend its approval at this time, and

WHEREAS, the Genesee County Water Resources Agency recommends approval of the Intermunicipal Agreement with the Town of Bethany, and

WHEREAS, the Committees on Public Service and Ways and Means have reviewed this request and do concur at this time. Now, therefore, Be it

RESOLVED, that Genesee County Legislature does hereby authorize the Chairperson of the Genesee County Legislature to approve the Intermunicipal Agreement between Genesee County and the Town of Bethany related to the Phase 2 Water Improvements. **Budget Impact Statement:** Per the agreement, the County Water Fund will reimburse the Town of Bethany \$152,825 for 28 years. This appeal reimbursement represents the amortized cost of the

Bethany \$152,835 for 38 years. This annual reimbursement represents the amortized cost of the approximately \$4.5 million in improvements that the Town of Bethany is making on behalf of Genesee County.

Legislator Clattenburg seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 269 CHANGE ORDERS –HIGHWAY/ DRY BRIDGE RD SHEET PILING – APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, Genesee County recently completed work on the Dry Bridge Rd over the NSX Railroad bridge in the Town of Alexander, and

WHEREAS, This projects have encountered changes in requirements and unexpected conditions which have increased costs required to complete the projects, and

WHEREAS, The Genesee County Highway Superintendent has reviewed this change request for need and accuracy of pricing, and

WHEREAS, The Genesee County Highway Superintendent recommends approval of the change order at this time, and

WHEREAS, The Committees on Public Service and Ways and Means have reviewed this request and do concur at this time. Now, therefore, be it

RESOLVED, That the Chairperson of the Genesee County Legislature is hereby authorized to and directed to approve a change order to the contract with LC Whitford for the installation of sheet piling for the Dry Bridge Rd over NSX railroad in the amount of \$23.590.

Budget Impact: The total amount for the change order is \$23,590. The change order was necessary due to a spring that was encountered during excavation. The spring required additional drainage and 271 square feet of sheet piling in excess of the 975 square feet allowed for in the original contract documents. The cost of the change order are being funded by the Large Span Culvert capital project.

Legislator Maha seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 270

CONSULTANT AGREEMENT – HIGHWAY/SOUTH LYONS STREET BRIDGE REPLACEMENT –APPROVAL OF

Legislator Maha offered the following resolution:

WHEREAS, The Genesee County has received federal aid for the replacement of the South Lyons Street Bridge over the Tonawanda Creek in the City of Batavia, and **WHEREAS,** This road project has been found by the Genesee County Legislature not to be subject to SEQR, as it is a Type II (4) Action, and

WHEREAS, The County requested letters of interest from consultant firms on the Local Design Services Agreement list as approved by NYSDOT and NYSCHSA and received proposals from 12 firms, and

WHEREAS, The Genesee County Highway Superintendent and the City of Batavia DPW Superintendent did review and rate these proposals and did make a recommendation on selecting the best qualified firm for the project, and

WHEREAS, The Genesee County Highway Superintendent did review a fee proposal and negotiate a price according to the Procedures for Locally Administered Federal Aid Projects, and

WHEREAS, The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a consultant agreement with Fisher Associates, 180 Charlotte St, Rochester, NY 14607 in an amount not to exceed \$617,000.

Budget Impact Statement: This consultant agreement funds the preliminary engineering and final design work needed to progress the project under the federal aid program. The cost of the consultant agreement is \$617,000 and the design work and right of way acquisition is anticipated to take 12-18 months. Construction is scheduled for the spring of 2023. The capital project has a budget of \$623,000 for this phase of the project.

Legislator Klotzbach seconded the resolution which was adopted by 326 votes.

GRANT ACCEPTANCE/ESTABLISH CAPITAL PROJECT/BUDGET AMENDMENT- AIRPORT – HANGAR DEMOLITION- APPROVAL OF –

WHEREAS, Genesee County is anticipating an Airport Improvement Program (AIP) grant from the Federal Aviation Administration for the demolition of an existing T-Hangar at the Genesee County, and

WHEREAS, The County Superintendent of Highways expects this grant agreement to require a rapid approval and turnaround to the FAA and does recommend accepting the grant to plan for the demolition of the old T-Hangars, and

WHEREAS, The County Superintendent of Highways recommends establishing a capital project contingent upon receipt and execution this grant, and

WHEREAS, The Committees on Public Service did review these requests and does recommend approval at this time. Now, therefore, Be it

RESOLVED, That the Chairperson of the Genesee County Legislature is hereby authorized to approve the grant offer as prepared by the Federal Aviation Administration, and Be it further **RESOLVED**, That, upon successful receipt and execution of the grant offer, the Genesee County Treasurer is hereby authorized and directed to establish a capital project, Hangar Demolition (Construction) for a total of \$172,335 with 100% federal funding.

RESOLVED, That, upon successful receipt and execution of the grant offer, the Genesee County Legislature does hereby authorize and direct the Genesee County Treasurer to make the following amendments to the 2020 Budget:

WHEREAS, The Superintendent of Highways has negotiated a contract with C&S Engineers and recommends approval of a consultant agreement with them at this time, and

WHEREAS, The Committees on Ways and Means and Public Service have reviewed this request and do concur at this time. Now, therefore, be it

RESOLVED, That, upon successful receipt and execution of a grant offer from the Federal Aviation Administration, the Chairperson of the Genesee County Legislature is hereby authorized to approve consultant agreements with C&S Engineers, 499 Col. Eileen Collins Blvd.

Syracuse, NY 13212 for the Construction Observation and Administration of the T-Hangar Demolition in an amount not to exceed \$29,000.

Budget Impact: The total of the consultant agreement is \$29,000. The capital project established for this project is budgeted for \$172,335.

WHEREAS, MEGA has asked Genesee County, as a partner and in recognition of the County's commitment to competitive markets in energy supplies, to serve in the role of the Procuring Municipality, a designation that allows other municipalities to enjoy the same terms and conditions as are provided to the Procuring Municipality, but that does not obligate Genesee County to enter into any energy purchase agreement unless authorized by the County Legislature, and

WHEREAS, the Genesee County Legislature strongly supports the efforts of MEGA to foster the development of renewable energy and recognizes the widespread benefits of the plan that has been put forward by MEGA, and

WHEREAS, this Legislature wishes to reflect this support by serving as the Procuring Municipality, including directing the release of all relevant bid documents for the procurement, and authorizing the County Manager to execute any agreements necessary to fulfill the responsibilities of the Procuring Municipality, recognizing that specific authority must be provided by this Legislature to enter into a specific power purchase agreement between the County and an energy supplier, and
