The Clerk of the Legislature Lisa Casey read a letter. The Oakfield Betterment Committee sent the letter expressing some concern with the overlapping dates between Labor Daze and the Airshow.

They would like to work with the Airshow coordinators with future dates to avoid overlapping event dates. In attendance were Jamie Lindsey and Jaden Ohlson.

<u>Legislator Comments:</u> Legislator Maha commented that the County Legislature is not sponsoring the Airshow; they are allowing them to use the Airport. Also noted that Legislature did not come up with the dates of the show. Legislature Yunker commented that the Planning Committee did consider that Labor Daze was the weekend, the Airshow choose these dates based on the availability of the Acts. The Airshow would bring in more people from outside the community and would positively enhance Labor Daze. Legislator Dibble commented that the Legislature could help promote Labor Daze by advertising during the Airshow and handing out their materials to people at the Airshow.

Chair Stein thanked those who helped with the Food Stand at the Genesee County Fair. Legislature believes in what they do for the Ag Society and being able to show their commitment to the Community.

<u>County Manager Report:</u> County Manager Matt Landers announced that the sales tax extenders is on the Governor's desk and has until August 2 to be signed. Memo went out to department heads for budget instructions. Will be setting up meetings with departments as they submit their budgets. Few noted dates coming up are August 10th employee recognition at DeWitt Park where food is provided by Red Osier and an ice cream truck, for all County Employees. On September 12th the employee luncheon for employee milestone recognition. This year will be smaller and a traditional luncheon at Terry Hills.

CONTRACT RENEWAL - INFORMATION TECHNOLOGY / MAINTENANCE AGREEMENT FOR HISTORY DEPARTMENT IMAGING EQUIPMENT - APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the Director of Information Technology did present a 36-month agreement with Empire Access to provide unlimited Local and Long Distance phone service to the Genesee County Child Advocacy Center (1 line), Genesee County Highway Department (3 lines), and Genesee County Job Development (1 line) to replace the existing Verizon phone service that is being phased out, and

WHEREAS, the Committee on Ways and Means did review the request and does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to execute the agreement with Empire Access, 34 Main Street, Prattsburgh, NY 14873 for a 36-month phone service agreement effective August 1, 2023 through July 31, 2026 at a cost of \$99.75 a month based on 5 lines of service at \$19.95 per line.

Budget Impact: \$99.75 monthly charge from A.1680 4290.0400 NY Phone-Basic Svc. County IT will eliminate the Verizon services to these locations and the difference in cost is negligible. Legislator Yunker seconded the resolution, which was adopted by 200 votes.

CONTRACT RENEWAL - INFORMATION TECHNOLOGY / FOR SOFTWARE AND HARDWARE SUPPORT SERVICES – APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the Director of Information Technology did present a contract agreement with Linstar for software and hardware support services for the Security Systems, and

WHEREAS, the County Attorney and the Committee of Ways and Means did review the request and do recommend approval at this time. Now, therefore be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to execute the agreement with Linstar Inc. 430 Lawrence Bell Dr., Buffalo NY 14221 for a period of 1-year beginning June 17, 2023 through June 16, 2024 in the amount of \$71,718.67.

AGREEMENT FOR COUNTY TREASURER TO COLLECT 2024 TOWN/COUNTY TAXES FOR THE TOWN OF BETHANY - APPROVAL OF

WHEREAS, the Supervisor for the Town of Bethany has asked the County Treasurer for assistance in collecting the 2024 Town/County tax bills due to an illness of the Bethany Town Clerk, and

WHEREAS, the Genesee County Treasurer has agreed to collect the 2024 Town/County taxes on

behalf of the Town of Bethany for a fee of \$7,500 plus expenses, and

WHEREAS, the County Attorney has approved such agreement and the Town of Bethany Supervisor and Town Clerk has signed the agreement, and

WHEREAS, the Committee on Ways and Means does concur. Now, therefore be it

RESOLVED, the Genesee County Treasurer is hereby authorized and directed to sign the agreement allowing the Treasurer to collect the 2024 Town/County taxes on behalf of the Town of Bethany for the amount of \$7,500.00.

Budget Impact: An increase in revenue of \$7,500.00 in Treasurer's fees.

RELEVY OF UNPAID SCHOOL AND VILLAGE TAXES-TREASURER – APPROVAL OF

WHEREAS, the Real Property Tax Law requires that, by November 15, 2023, all rural Genesee County School Districts return their respective unpaid 2023-2024 school taxes to the County Treasurer for inclusion in the following year's town and county levy, and

WHEREAS, the Legislature entered into an agreement with the various villages within the county that upon notification to the county by the villages, within the time period as defined in the agreement, the unpaid village taxes will be relevied as part of the town and county levy, and

WHEREAS, the Committee on Ways and Means does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Genesee County Legislature does hereby authorize all unpaid school taxes and unpaid village taxes be relevied against the various towns in the County of Genesee immediately upon receipt by the County Treasurer's Office.

Budget Impact: None

RESOLUTION NO. 283

CONTRACT RENEWAL-TREASURER/M&T BANK P CARD PROGRAM – APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, Resolution No. 373 of 2020 authorized a two year contract with M&T Bank to provide a Purchasing Card Program with three 1 year optional renewals, and

WHEREAS, Resolution No. 280 of 2022 authorized a one year contract renewal through September 7, 2023, and

WHEREAS, the Genesee County Treasurer and Director of Purchasing wish to renew the contract for one more year utilizing the second of three renewal options, and

WHEREAS, M&T Bank wishes to renew the contract for one more year, and

WHEREAS, the Committee on Ways and Means did review this request and does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to sign a one year contract renewal with M&T Bank located at One Fountain Plaza, Buffalo, New York continuing with the same terms and conditions as the original contract with the renewal expiring on September 7, 2024.

Budget Impact: No cost to the county, the county receives a yearly rebate based on the annual purchase amount.

WHEREAS, the Trustees of Columbia University has awarded the Genesee County Health Department \$573,151, to use this funding to support costs associated with wave 2 of the HEALing Communities study, and

WHEREAS, the Committees on Human Services and Ways and Means did review this award and does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to execute the Addendum to the HEALing Communities Study with the Trustees of Columbia University for the acceptance of the Healing Communities Grant contract for the period April 1, 2023 through March 31, 2024, in the amount of \$573,151, and to execute any and all other documentation related to this funding.

Budget Impact: Revenue and expenses in the amount of \$573,151, have been appropriated in the 2023 and 2024 4010 budgets. All revenue and expenses offset. The county cost is \$0.

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to execute a contract with Southtowns Children's SLP, PT and OT Associates, having its principal location of business at 3755 Abbott Road, Orchard Park, NY 14127, the for the provision of Related Services (SP, OT & PT) in the Preschool Supportive Health Services Program (PSSHSP), from September 1, 2023 through June 30, 2025 per the 2023-2025 PSSHSP rate schedule.

Budget Impact: Revenue and expenses are included in the 2023 A 2960 3-5 Preschool Budget and will be included in the 2024 and 2025 Budgets. These services qualify for NYS reimbursement at the rate of 59.5% less any Medicaid payment on Medicaid eligible children.

GRANT ACCEPTANCE/BUDGET AMENDMENT – HEALTH DEPARTMENT/PUBLIC HEALTH INFRASTRUCTURE, WORKFORCE & DATA SYSTEMS GRANT - APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the Public Health Department was awarded funding from the Center for Disease Control & Prevention that was passed through the NYS Health Department totaling \$658,674, allocated over a five year period. The purpose of the Public Health Infrastructure, Workforce & Data Systems Grant is to address long-standing weaknesses due to chronic underinvestment in New York's public health system and strengthens preparedness to address new challenges and better meet the ongoing and future public health needs of New Yorkers, and

WHEREAS, the NYS Health Department has awarded \$658,674 to the Genesee County Public Health Department for expenses related to the Public Health Infrastructure, Workforce & Data Systems Grant. The Genesee County Health Department will be using the funds in accordance with the required grant deliverables to provide retention payments to staff, provide training and professional growth opportunities to all staff, and provide office setting improvements. The grant funding will be evaluated each budget year to identify the best use of the grant funds, and

WHEREAS, the Committees on Human Services and Ways and Means did review this award and does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized to accept this award of \$658,674 for the time period of 12/1/2022 - 11/30/2027 as specified in Federal statutes

and regulations including applicable parts of 45 CFR Parts 74 and 92, be it further

RESOLVED, that the Genesee County Treasurer is hereby authorized and directed to amend the 2023 Genesee County Budget to reflect an increase of:

\$99,000 in Appropriations A4010 1060.0600 Special Pay – Retention

\$5,774 in Appropriations A4010 4560.0000 Personnel Travel

\$5,000 in Appropriations A4010 4550.0000 Personnel Training

\$3,500 in Appropriations A4010 2010.0020 Desks

\$6,140 in Appropriations A4010 8010.0000 Social Security Tax

\$1,434 in Appropriations A4010 8011.0000 Medicare Tax

\$10,890 in Appropriations A4010 8020.0000 Retirement

Budget Impact: The 2023 4010 budget will be amended to reflect an increase of \$131,738 in revenue and expense lines. The remaining grant amount will be allocated in the 2024-2027 4010 budgets. \$0 cost to the county, revenue and expenses offset.
