FOURTEENTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York

Wednesday, August 26, 2020

The Genesee County Legislature met in Regular Session on Wednesday, August 26, 2020 at 5:30PM in the Legislative Chambers at the Old Courthouse, 7 Main Street, Batavia, New York. Legislator Torrey assisted with the audit. Prayer was offered by Legislator Deleo followed by the Pledge to the Flag.

Legislators Maha and Dibble presented National Suicide Prevention Month and National Recovery Month proclamations to Mental Health Director Lynda Battaglia & Suicide Prevention Coalition Coordinator Sue Gagne and GCASA Services Director Shannon Ford. Ms. Gagne shared details of Overdose Awareness Day scheduled for August 28 at the Recovery Station. Ms. Battaglia expressed appreciation for the recognition by the Legislature and the importance of raising awareness of suicide prevention and the growing number of people experiencing higher levels of stress and anxiety due to the pandemic.

Minutes of the July 22, 2020 Legislature Meeting were approved upon motion of Legislator Maha, seconded by Legislator Torrey, carried unanimously.

The Legislature received notice from the GCEDC pertaining to a Public Hearing scheduled for September 2^{nd} . The Clerk will post the notice on the bulletin board.

County Manager Matt Landers explained that he spoke with Public Health Director Paul Pettit regarding the re-opening of fitness centers and gyms. It seems that Gym and Fitness Center owners & operators aren't clear on the re-opening requirements which include scheduling an appointment with a Health Department sanitarian for an inspection within two weeks of opening. He commented that hopefully the media will pick up on the matter and include relevant information in their respective publications.

The Clerk proceeded with the Resolutions:

RESOLUTION NO. 292 ACCEPTANCE OF GRANT FUNDS - BUDGET AMENDMENT/SHERIFF - POLICE TRAFFIC SERVICES PROGRAM - APPROVAL OF

Legislator Maha offered the following resolution:

WHEREAS, the Sheriff requested authorization to accept grant funding from the NYS Governor's Traffic Safety Committee, in the amount of \$27,000, to participate in the statewide Police Traffic Services Program, for the time period of October 1, 2020 through September 30, 2021, and

WHEREAS, the Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to amend the 2020 budget by increasing Sheriff's account A3110.1020.0700 (Overtime – STEP) in the amount of \$27,000, to be offset by an increase in revenue account A3110.4511 (Federal Aid Traffic Safety) in a like amount.

Budget Impact: Increase in Sheriff's 2020 appropriations in the amount of \$27,000 from a NYS GTSC Police Traffic Services Program Grant Award; offset by an increase in revenue in a like amount.

Legislator Klotzbach seconded the resolution which was adopted by 238 votes, Yunker (45), Stein (43) absent.

RESOLUTION NO. 293

AWARD OF BID – SHERIFF'S OFFICE / MOLASSES HILL TOWER FENCING – APPROVAL OF

Legislator Dibble offered the following resolution:

WHEREAS, Genesee County is constructing a new Public Safety Communications Tower at 268 Molasses Hill Rd, Attica NY pursuant to Resolution 385, dated October 24, 2019, and

WHEREAS, Genesee County issued BID 2020-14 for perimeter fencing at the new Molasses Hill Tower location, and

WHEREAS, Genesee County received a NYS Statewide Interoperable Communications Grant which included funds for perimeter fencing construction at the new tower, and

WHEREAS, After careful review, the Genesee County Sheriff, Purchasing Director, Highway Superintendent, and Director of Emergency Communications recommend Genesee County award the bid to New York State Fence, Inc. with offices at 858 Manitou Rd, Hilton, NY 14468 address at a cost of \$9,980.00, and

WHEREAS, The Committee on Public Service did review this request and does recommend approval at this time. Now, therefore, be it

RESOLVED, the perimeter fencing BID 2020-14 is awarded to New York State Fence, Inc. with offices at 858 Manitou Rd, Hilton, NY 14468 address at a cost of \$9,980.00

Budget Impact: None. Cost of the fencing previously appropriated to the Public Safety Communications Tower Capital Project offset by NYS Statewide Interoperability Communications Grant funds.

2020 BUDGET AMENDMENT – COUNTY PARKS - INTERPRETIVE CENTER/PRIVATE DONATION - APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, The Genesee County Highway Superintendent does request an amendment to the 2020 Genesee County Budget to allow the acceptance of a private donation from Linda Keister in memory of Kathy Owen, and

WHEREAS, The budget increase will allow the Deputy Highway Superintendent to use the funding to administer an Environmental program for Genesee County youth through the Environmental Education programming at the Genesee County Park and Forest Interpretive Nature Center in Bethany, and

WHEREAS, The Committees on Public Service and Ways and Means did review this request and does recommend approval at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to amend the 2020 Genesee County Budget by increasing Appropriation A.7110 INTC 4660.0000 County Park, Contractual in the amount of \$250 to be offset by an increase in Revenue A.7110 INTC 2002 Programs in a like amount.

Budget Impact: Increase to 2020 budget expense in the amount of \$250 - offset by revenue in like amount. Cost to County \$0.

Legislator Young seconded the resolution which was adopted by 238 votes, Yunker (45), Stein (43) absent.

RESOLUTION NO. 296 CHANGE ORDERS – PHASE 2 WATER SUPPLY – CONTRACT 3B – APPROVAL OF

Legislator Young offered the following resolution:

WHEREAS, Genesee County has commenced work on several projects needed to expand water supply capacity under Phase 2 of the Countywide Water Supply Program, and

WHEREAS, Pump stations are being constructed in Churchville and Mumford as part of this program, and

WHEREAS, These projects have encountered changes in requirements, which have increased costs required to complete the projects, and

WHEREAS, The Genesee County Highway Superintendent has reviewed this change request for need and accuracy of pricing, and

WHEREAS, The Genesee County Highway Superintendent recommends approval of the change order at this time, and

WHEREAS, The Committees on Public Service and Ways and Means have reviewed this request and do concur at this time. Now, therefore, be it

RESOLVED, That the Chairperson of the Genesee County Legislature is hereby authorized to and directed to approve a change order to Contract 3B with Suburban Electric in the amount of \$8,682.50 for the installation of TCP/IP communication controls and fuel pressure sensors for the backup generators being installed at each pump station.

Budget Impact: The total amount for the change order is \$8,682.50. The change order was necessary so that MCWA can monitor the operation of the generators remotely during emergency operations. This is the first change order on this contract and brings the total contract cost to \$767,682.50.

Legislator Torrey seconded the resolution which was adopted by 238 votes, Yunker (45), Stein (43) absent.

RESOLUTION NO. 297 CONSULTANT AGREEMENT – CITY OF BATAVIA WELL "C" DEVELOPMENT – APPROVAL OF

Legislator Maha offered the following resolution:

WHEREAS, A period of high demand and hot, dry weather conditions combined to require the County to enact steps of the Emergency Water Supply Plan in July 2020, and

WHEREAS, This plan calls for the development of Well "C" in the City of Batavia well fields on Cedar Street in order to provide redundancy of operations at the City of Batavia Water Treatment Plant during times of high creek water turbidity or during time of low groundwater that impact either Well "A" or Well "B", and

WHEREAS, The development of this well is allowed under the Amended and Restated Water Agreement between the County and the Monroe County Water Authority as long as it does not expand production of water from the City of Batavia Water Treatment Plant, and

WHEREAS, The Genesee County Highway Superintendent has reviewed the consultant proposal and does recommend approving the agreement at this time, and

WHEREAS, The Committees on Public Service and Ways and Means did review this request and does recommend approval at this time. Now, therefore, Be it,

RESOLVED, That the Chairperson of the Genesee County Legislature is hereby authorized and directed to enter into a consultant agreement with the CPL Team, 205 St Paul St, Suite 500, Rochester, NY 14604 in an amount not to exceed \$80,000.

Budget Impact: The consultant agreement will be funded from the Water Fund.

Legislator Deleo seconded the resolution which was adopted by 238 votes, Yunker (45), Stein (43) absent.

RESOLUTION NO. 298

ACCEPTANCE OF PROPERTY DONATION – QUIT CLAIM DEEDS – UPTON RD OVER BOWEN CREEK RIGHT OF WAY –APPROVAL OF

Legislator Dibble offered the following resolution:

WHEREAS, Genesee County has been awarded a Federal Aid pass-thru grant for the replacement of the Upton Rd bridge over the Bowen Creek in the Town of Batavia, and

WHEREAS, Plans for the replacement of this bridge require additional right of way in order to construct and maintain the bridge, and

WHEREAS, Residents adjacent to the bridge have agreed to donate portions of their property, as described in maps prepared for the project, to the County in the interest of saving taxpayer funds required for the acquisition of de minimis property, and

WHEREAS, The County is required to file deeds in order to secure donation of these portions of property, and

WHEREAS, The County Attorney has prepared, and the property owners have executed Quit Claim Deeds for the portions of property involved in the donation, and

WHEREAS, The Genesee County Highway Superintendent recommends accepting the property donations and filing the deeds at this time, and

WHEREAS, The Committee on Public Service did review this request and does concur. Now, therefore, Be it,

RESOLVED, That the Genesee County Legislature does hereby accept the property donations from Alfred and Renee Emmick and Leopold Auriemma to advance the replacement of the Upton Rd bridge over the Bowen Creek in the Town of Batavia, and be it further

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to execute a Quit Claim Deed for said portions of parcels, together with such other necessary recording documents, in order to transfer title of said portions of parcels to the County. **Budget Impact:** There is no cost to acquire portions of adjacent parcels required for the construction of the bridge.

The donation saves the county acquisition process costs, which normally exceed \$5,000 per portion of parcel acquired.

Legislator Young seconded the resolution which was adopted by 238 votes, Yunker (45), Stein (43) absent.

RESOLUTION NO. 299

GRANT ACCEPTANCE – EMERGENCY MANAGEMENT SERVICES & SHERIFF'S OFFICE – FY20 STATE HOMELAND SECURITY PROGRAM (SHSP) GRANT – APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, The Emergency Management Services Coordinator and the Genesee County Sheriff request authorization to accept the FY20 State Homeland Security Program (SHSP) grant funding in the amount of \$109,781 from the US Department of Homeland Security, Federal Emergency Management Agency (FEMA); administered by the NYS Division of Homeland Security and Emergency Services (DHSES), and

WHEREAS, Grant funding priorities focus on the State's homeland security and emergency management efforts through the advancement of regional partnerships, development of citizen preparedness efforts, development of cyber security programs and policies; law enforcement information-sharing capabilities, emergency management planning efforts and sustainment of effective programs and existing capabilities, and

WHEREAS, 25% of the total grant award or \$25,836 must be utilized for law enforcement terrorism prevention activities, and

WHEREAS, The Committee on Public Service did review this request and does concur. Now therefore be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the Agreement with the New York State Division of Homeland Security and Emergency Services, 1220 Washington Avenue, Albany, NY for the acceptance of FY19 State Homeland Security Program (SHSP) funds in the amount of \$109,967 and to execute any and all other documentation related to this funding.

Budget Impact Statement No County cost. Grant funds in the amount of \$25,836 will be appropriated in the 2021 Genesee County Sheriff budget. SHSP funds in the amount of \$82,336 will be appropriated in the 2021 and future EMO operating budgets.

Legislator Maha seconded the resolution which was adopted by 238 votes, Yunker (45), Stein (43) absent.

RESOLUTION NO. 300 APPOINTMENT - GENESEE COUNTY PLANNING BOARD - APPROVAL OF

Legislator Klotzbach offered the following resolution:

WHEREAS, A vacancy does exist on the Genesee County Planning Board due to the resignation of Virginia Adams, and

WHEREAS, the Committees on Public Service and Ways & Means recommend an appointment be made at this time. Now, therefore, Be it

RESOLVED, That Ms. Candace E. Hensel of Swamp Road, Byron, New York is hereby appointed to the Genesee County Planning Board for a 3-year term effective immediately through May 31, 2023.

Budget Impact Statement: None. Planning Board members receive no salary or compensation. Legislator Dibble seconded the resolution which was adopted by 238 votes, Yunker (45), Stein (43) absent.

RESOLUTION NO. 301

AUTHORIZATION FOR THE GENESEE COUNTY LEGISLATURE CHAIR TO SIGN ATTACHMENT A "MULTI-JURISDICTIONAL CHIEF ELECTED OFFICIALS AGREEMENT"

Legislator Torrey offered the following resolution:

WHEREAS, The Workforce Innovation and Opportunity Area of GLOW (Genesee, Livingston, Orleans, and Wyoming) are considered a Multi-Jurisdictional Area .Therefore, each Chief Elected Official is required to sign Attachment A "Multi-Jurisdictional Chief Elected Officials Agreement", as a revision to the current Chief Elected Officials/Workforce Development Board Agreement, as requested by the New York State Department of Labor. Now, Therefore, Be it

WHEREAS, Genesee County, through consultation with and collaboration between the County Health Department, the County Manager's Office and the County Clerk, implemented certain protocols to limit the capacity of the DMV office and to ensure proper distancing is maintained between customers; and

WHEREAS, since reopening to the public under the terms and restrictions imposed by the Governor's Executive Orders and County protocols, the Genesee County Sheriff's Office has allocated a deputy sheriff to provide security at the entrance to the DMV; and

WHEREAS, the allocation of a deputy sheriff to provide security is not cost effective in the long term due to staffing issues and the need to pay overtime; and

WHEREAS, The Chair of the Genesee County Legislature by resolution was authorized to enter into contract with Securemedy, Inc. to provide security services for the Genesee County Department of Social Services and Mental Health Department; and

WHEREAS, it would be cost effective and prudent to amend the contract with Securemedy, Inc. to have that company provide security for the DMV; and

NOW THEREFORE upon recommendation of the Ways and Means Committee of this body, it is hereby

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to amend the contract with Securemedy, Inc. located at 8507 Oxon Hill Road, Suite

#101, Ft. Washington, MD 20744 to provide services at County Building No. 1 at the rate of \$27.01 per hour effective August 31, 2020.
