The Genesee County Legislature met in Regular Session on Wednesday, September 14, 2022 at 5:30 p.m. in the Legislature Chamber of the Old Court House.

**WHEREAS**, The Ways and Means committee did review the request and do recommend approval of the Telephone Maintenance contract. Now, therefore be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute a one year extension with Meridian IT Inc. 509 Erie Blvd. West Syracuse, NY 13204 for a period of 1 year December 1, 2022 through November 30, 2023 in the amount of \$29,258. Budget Impact: The contract cost of \$29,258 for Telephone System Maintenance is within the 2022 Adopted Budget in line item A.1680.4600.0000 PBX / Telephone Systems Maintenance and is included in the 5 year projected budget. The Telephone Systems Maintenance services provided by Meridian IT supplements the IT staff and provides a level of expertise that in-house staff do not have. The telephone system is a critical component to supporting County Departments and this outsource service is necessary to ensure its availability and reliability.

**WHEREAS**, the Public Health Director did present contracts for the provision of services to eligible children in the Preschool Supportive Health Services Program, and

**WHEREAS**, the Committee of Human Services and Ways and Means did review the request and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Chair of the Genesee County Legislature is hereby authorized and directed to execute contracts with Pembroke Central School District for the provision of Special Education Itinerant Teacher (SEIT) Services, Classroom Services (CB), and Evaluator Services in the Preschool Supportive Health Services Program, retroactively, for the period of September 1, 2022 through June 30, 2023 per the 2022 PSSHSP rate schedule.

**Budget Impact:** Revenue and expenses are included in the 2022 A 2960 3-5 Preschool Budget and will be included in the 2022 and 2023 Budgets. These services qualify for NYS reimbursement at the rate of 59.5% less any Medicaid payment on Medicaid eligible children. Legislator Deleo seconded the resolution, which was adopted by 326 votes.

2022 SALARY SCHEDULE AMENDMENT – HEATLH DEPARTMENT – APPROVAL OF

Legislator Clattenburg offered the following resolution:

**WHEREAS**, the Public Health Director has requested the creation of one full time CSEA position of Laboratory Coordinator, and

**WHEREAS**, the Committees on Human Services and Ways and Means did review the request and do recommend approval at this time, now therefore, be it

**RESOLVED,** that the Genesee County Treasurer and Human Resource Director are hereby authorized and directed to amend the 2022 Genesee County Employee Salary Schedule by creating one full time position of Laboratory Coordinator, CSEA Grade 20EH effective 09/15/2022.

Budget Impact: The creation of one full time Position of Laboratory Coordinator will take effect 09/15/2022. The Laboratory Coordinator's salary and fringe are allocated in the 2022 Health Department budget and is fully funded by Article 6 State Aid.

**WHEREAS**, the department of Mental Health in Genesee County provides psychiatric services to community members within Genesee County. The need for additional psychiatric hours is at an all-time high, and

**WHEREAS**, the Director of the Community Mental Health Services did request an amendment to the 2022 Management Salary Schedule to create one (1) Staff Psychiatrist (Community Mental Health) position, F.T., at a base salary range of \$292,500- \$331,500 and

**WHEREAS**, the Committees on Human Services and Ways and Means did review this request and do recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Genesee County Treasurer and Human Resources Director are hereby authorized and directed to amend the 2022 Management Salary Schedule by creating one (1) Staff Psychiatrist (Community Mental Health) F.T., at an annual base salary range of \$292,500-\$331,500 effective September 15, 2022.

Budget Impact: for the final quarter of 2022, we anticipate a base salary expense ranging between \$73,125 and \$82,872. This range estimates the base salary at a range between \$150-\$170/ hour. The estimated fringe expense for final quarter of 2022, between \$19,316 and 20,942. This total potential expense for the final quarter of 2022 ranges between \$92,441 and \$103,814. Fringe benefits were calculated at current retirement rates, and family insurance benefits. There are funds available in the existing 2022 budget to cover this expense due to unstaffed positions within the Mental Health department.

Legislator Deleo seconded the resolution, which was adopted by 326 votes.

2022 SALARY SCHEDULE AMENDMENT - COMMUNITY MENTAL HEALTH SERVICES/MENTAL HEALTH FINANCIAL PROGRAM SPECIALIST - APPROVAL OF

Legislator Clattenburg offered the following resolution:

**WHEREAS**, the department of Mental Health in Genesee County has a long time employee who retired in 2022 and has been working on a part time basis with the Finance Department to reconcile accounts. The need for additional finance coverage with knowledge of medical billing is recognized, and

**WHEREAS**, the Director of the Community Mental Health Services does request an amendment to the 2022 Management Salary Schedule to create one (1) Full-time Mental Health Financial Program Specialist position, at the management salary Grade 108, and

**RESOLVED,** that the Genesee County Treasurer is hereby authorized and directed to amend the 2022 budget by Increasing Revenue A.1000 1110.1 1% Sales Tax in the amount of \$11,500; Increase Appropriation A.9950.9 Transfers to Capital in a like amount; Increase Revenue H.1997.5031 Interfund Transfers in the amount of \$11,500; Increase Revenue H.1997.4089.3 Federal Aid in the amount of \$35,584 and Increase Appropriation H.1997.2080.0000 Capital Expense in the amount of \$47,084.

Budget Impact: Increased county cost is \$11,500 to be covered by 1% sales tax for a Capital Project cost of \$111,500 and the remaining balance of \$133,004 of ARPA funds will be incorporated into the 2023-2024 budgets.

**WHEREAS**, AAWNY is the grant recipient and this MOU establishes the amount of \$125,000 for the period of July 1, 2022-June 30, 2023 to the agreement for which GCOFA would receive funding to provide consultation, respite, and technology services; and

**WHEREAS**, the Committee on Human Services and Ways & Means Committee did review this request and does recommend approval of this MOU. Now, Therefore, Be it

**RESOLVED**, that the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary documents to extend an agreement MOU with Alzheimer's Disease and Related Disorders Association, Inc. dba Alzheimer's Association, 225 N. Michigan Ave., Ste 1700, Chicago, Illinois 60601, not to exceed \$125,000 for the period July 1, 2022 – June 30, 2023. Budget Impact: Expenses are fully funded and are being incorporated into the 2023 County Budget to support OFA Alzheimer's Disease Caregiver Support Initiative services.
