#### SEVENTEENTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, October 14, 2020

The Genesee County Legislature met in Regular Session on Wednesday, October 14, 2020 at 5:30PM in the Legislative Chambers at the Old Courthouse, 7 Main Street, Batavia, New York. Legislator Klotzbach offered to assist with the audit and provided the prayer followed by the Pledge to the Flag.

Minutes of the September 23, 2020 Legislature meeting were approved upon motion of Legislator Clattenburg seconded by Legislator Klotzbach, carried.

Legislator Yunker reported on attendance at the Soil & Water Conservation District Directors meeting where there was a review of the 2021 work plan. They want to increase connections and relationships with municipalities and will be working more closely with highway superintendents and supervisors. Legislature Chair Stein commented on the State's COVID-19 testing unit for schools and the newly announced fining capacity of the State. Local efforts will continue to focus on education, prevention and cooperation. Genesee Community College has engaged in pooling testing among individuals on campus with good results.

County Manager Matt Landers announced the first meeting of the Executive Order 203 Committee (Police Reform and Reinvention Committee) is at 7:00 pm where members will be introduced and there will be a review of the timeline.

This AGREEMENT shall be automatically extended for additional one (1) years terms until the AGREEMENT is expressly terminated in writing, and

**WHEREAS**, The Community Services Board revised the By–Laws of the Genesee County Community Services Board to be in alignment with requirements of New York State Mental Hygiene Law, and

**WHEREAS,** The revised By-Laws were adopted by the Genesee County Community Services Board at the March 5, 2020 meeting, and **WHEREAS**, The Committee on Human Services did review this request and does recommend approval of proposed revisions at this time. Now, therefore, Be it

**RESOLVED**, That the Genesee County Legislature does amend the By-Laws of the Genesee County Community Services Board as proposed and adopted by the Genesee County Community Services Board.

Budget Impact Statement: none.

The rate per night is \$40 (add \$4.40 in taxes per night if being paid by the individual) if stay is 7 days or longer. **WHEREAS**, The current contract for the Purchasing Card Program is expiring and an RFP was issued with three responses being received, and

**WHEREAS**, The County Treasurer and Director of Purchasing wish to award a two year agreement with three optional one year renewals to M&T Bank of Buffalo New York to provide the Purchasing Card Program, and

**WHEREAS**, The Committee on Ways & Means did review this request and does concur. Now, therefore, Be it

**RESOLVED**, That the Chair of the Genesee County Legislature be and hereby is authorized and directed to sign a two year contract with three optional one year renewals with M&T Bank, Buffalo New York effective September 8, 2020 to provide the Purchasing Card Program, and be it further

**RESOLVED**, that the Chair of the Genesee County Legislature is also hereby authorized to sign any other necessary documentation and agreements approved by the County Attorney governing the Visa cards and card management products and services offered by M&T Bank to be obtained by the County of Genesee pursuant to the RFP.

**Budget Impact Statement:** The County will be eligible for rebates as long as the current level of spending for the Purchasing Card Program is maintained. At our current spending level the estimated rebate amount would be \$4,100 per year, which would be a new source of revenue for the County.

**WHEREAS**, The Genesee County Purchasing Department currently utilizes BidNetDirect as a platform for Bid and RFP administration, and

**WHEREAS,** BidNetDirect has the capability to accept electronic bids and offers in compliance with all rules and regulations surrounding that process at no cost to the County, Now therefore, Be it

**RESOLVED,** That the Genesee County Legislature does hereby approve the acceptance of electronic submissions of bids and offers using the BidNetDirect platform and the Purchasing Department is hereby authorized to update the Purchasing Policy & Procedure Manual to reflect this allowance, effective immediately.

WHEREAS, in recognition and consideration of the cooperation of the Towns and Villages acting as partners with the County of Genesee to be able to provide for the health, safety and welfare of all of the communities in the County, to include supporting new commercial, residential and industrial growth, the County intends to distribute annual voluntary payments in monthly amounts to certain Towns and Villages located in Genesee County, as set forth herein. Now, therefore, Be it

**RESOLVED**, that during the calendar year of 2021, the County shall distribute payments to be paid in monthly amounts to all of the Genesee County Towns and Villages, except as specifically differentiated as set fourth hereinafter, and Be it further

**RESOLVED**, that at the County's sole discretion, it may reduce payments to a Town or Village for outstanding obligations or where applicable to ensure water surcharge revenues are collected at a uniform rate, and Be it further

**RESOLVED**, that in the event the County's sales tax distribution amount is reduced by New York State as a result of a cost shift from the State to the County, or State funding for County programs is withheld or reduced after budget adoption, the County may reduce 2021 revenue distribution payments to ensure the County is protected from the cost shift, and Be it further

**RESOLVED**, that there shall be no distribution payments made in the calendar year of 2021 to the Village of Attica, and Be it further

**RESOLVED,** that on or before September 1, 2021, the Genesee County Legislature shall advise and notify all of the Genesee County Towns and Villages, of the amounts of the annual voluntary distribution payments to be made by the County to them in the calendar year of 2023, and Be it further

**RESOLVED**, that the Genesee County Treasurer is hereby authorized and directed to make monthly payments pursuant to the terms and conditions set forth in this Resolution not to exceed the annual amount to each set forth below opposite its respective name:
