### EIGHTEENTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, October 23, 2019

The Genesee Legislature met in Regular Session on Wednesday October 23, 2019 at 5:30 PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Hilchey assisted with the audit. Prayer was offered by Legislator Young followed by the Pledge to the Flag.

Minutes of the October 9, 2019 Legislature meeting were approved upon motion of Legislator Torrey seconded by Legislator Maha, carried unanimously.

Legislator Clattenburg reported that she attended the Holland Land Office Museum board meeting and explained that the two cannons that are slated to be refurbished will be sent out next week. Fundraising is underway for covering the cost of this project. Legislator Deleo stated he attended the Genesee County Farm Bureau Annual meeting and commented that our upstate farm bureaus and farmers are engaged in a battle with downstate representatives who do not have a clear understanding of the business of farming.

The Clerk proceeded with the resolutions:

# RESOLUTION NO. 374 GRANT ACCEPTANCE - EMERGENCY MANAGEMENT SERVICES - FY18 HAZ MAT FUNDS – APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, The Emergency Management Services Coordinator requests authorization to accept the FY18 HazMat grant funds in the amount of \$196,000 from the U.S. Department of Homeland Security Program, Federal Emergency Management Agency (FEMA), administered by The New York State Division of Homeland Security and Emergency Services (DHSES); in conjunction with Monroe, Livingston, Orleans, and Wyoming Counties, and the City of Rochester, and

WHEREAS, Grant funds have been allocated for the sustainment of WMD trailers assigned to the Counties within the grant partnership; personal protection equipment; detection, mitigation and deacon equipment; the maintenance, repair and calibration of hazmat equipment in addition to the training of response personnel from the regional partnership, and

**WHEREAS**, The Committee on Public Service does concur with the Emergency Management Service Coordinator's recommendation. Now therefore be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the Agreement with New York State Division of Homeland Security and Emergency Services, 1220 Washington Avenue, Albany, NY for the acceptance of FY18 HazMat Grant Program (October 1, 2019 through August 31, 2021) in the amount of \$196,000, and to execute any and all other documentation related to this funding. **Budget Impact Statement:** NONE. A portion of the FY18 HazMat grant funds will be appropriated in the 2020 Emergency Management Services (EMS) budget, offset by revenue in like amount.

WHEREAS, The Coordinator of Emergency Management Service, in planning and preparing for and responding to a disaster and/or other emergency situation, does recommend a Memorandum of Understanding between the County of Genesee and RGRTA for the purpose of providing emergency transportation services at the request of the County of Genesee, and

**WHEREAS**, emergency transportation services provided will be compensated at the then prevailing wage rate, and

**WHEREAS**, The Committee on Public Service did review this request and does concur with the Emergency Management Services Coordinator's recommendation. Now, therefore be it

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute a Memorandum of Understanding with the Rochester Genesee Regional Transportation Authority whose address is 1372 East Main Street Rochester, New York 14609.

**Budget Impact:** In the event of a disaster or other emergency situation, emergency transportation services provided will be compensated at the then prevailing wage rate.

**WHEREAS**, The Genesee County Hazard Mitigation Plan has been reviewed by the NYS Emergency Management Office (SEMO) and approved by the Federal Emergency Management Agency (FEMA), and

**WHEREAS**, The Genesee County Office of Emergency Management Coordinator does report that the Genesee County Hazard Mitigation Plan shall be updated no less than every five (5) years and does request adoption of the plan, and

**WHEREAS**, The Committee on Public Service did review this request and does concur with the Coordinator of Emergency Management Services recommendation. Now, therefore, Be it

**RESOLVED**, That the Chair of the Genesee County Legislature does hereby adopt the Genesee County Hazard Mitigation Plan as an official plan of Genesee County and the Legislature affirms that this plan will be updated no less than every five (5) years.

**WHEREAS**, Per our agreement with Justice Benefits, Inc., 12.5% of these funds in the amount of \$235.13 will be paid to Justice Benefits for their professional assistance in acquiring this award, and the remaining \$1,645 will be used to help cover inmate medical expenses at the Genesee County Jail, and

WHEREAS, The Sheriff is requesting a budget amendment in the amount of \$1,881, and WHEREAS, The Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to amend the 2019 budget by increasing Jail appropriations as follows:

\$1,645 to Jail Account A.3150.4650.0000 (Contracted Medical) \$236 to Jail Account A3150.4660.0010 (Contracted Services-SCAAP) to be offset by an increase in Jail Revenue Account A3150.4089.1 (OJP - SCAAP) in the amount of \$1,881.

**Budget Impact Statement:** Increase in Jail appropriations of \$1,881 from SCAAP funding. Funds will be used to help cover Jail inmate medical expenses. 12.5% of the funds will pay for professional services used to acquire the funding. This will be offset by an increase in Jail revenue in a like amount.

WHEREAS, the Genesee County Sheriff did present a contract renewal with the New York State Unified Court System for the provision of Security Services at the Genesee County Courts Facility for a five-year period commending April 1, 2019, through March 31, 2024 (divided into annual periods, approved each year with the first period being April 1, 2019, to March 31, 2020), and

**WHEREAS**, the Public Service Committee did review this contract renewal and does recommend renewal at this time. Now, therefore, be it

**RESOLVED**, that the Chair of the Genesee County Legislature is hereby authorized and directed to execute the contract renewal between the County of Genesee and the New York State Unified Court System for the provisions of security services at the Genesee County Courts facility for the first period of April 1, 2019, through March 31, 2020, at a cost not to exceed \$702,721.

**Budget Impact:** Costs for security services at the Courts Facility are offset by revenue from the New York State Unified Court System.

WHEREAS, Lloyd Lane, Inc. entered into a lease agreement for space on the county's telecommunications tower located at 153 Cedar Street, Batavia NY, 14020, pursuant to Resolution 374, dated October 23, 2008, and

WHEREAS, Lloyd Lane, Inc. wishes to upgrade its equipment on the tower which requires entering into a new lease agreement for a four (4) year contract commencing January 1, 2020, beginning at the cost of \$850.00 per month for the first year, with a 3% increase each year, ending December 31, 2023, appropriated to the Genesee County Sheriff Communications Revenue Account: Sheriff EMS Tower Rental, and

**WHEREAS,** Lloyd Lane, Inc. will have the option to extend the lease for three (3) consecutive four- (4) year terms, subject to the approval of the County.

**WHEREAS,** The agreement imposes a \$75.00 per month generator fee for the term of the contract designated to the Genesee County Highway Department Shared Services Account, and

WHEREAS, The Sheriff, Director of Emergency Communications, and County Attorney recommend entering into a new lease agreement as outlined above for the period of January 1, 2020 to December 31, 2023, and

WHEREAS, The Committees on Public Service and Ways & Means did review this request and do recommend approval at this time. Now therefore be it

**RESOLVED,** That the Chair of the Legislature is hereby authorized and directed to enter into a site lease agreement with Lloyd Lane, Inc., 3258 Merchant Road, Warsaw, NY 14569, for the lease of space on the Genesee County telecommunications tower located at 153 Cedar Street, Batavia, NY for a period beginning January 1, 2020 and ending December 31, 2023.

**RESOLVED,** That the Chair of the Legislature is hereby authorized and directed to accept the Division of Homeland Security and Emergency Services Office of Interoperable and Emergency Communications Public Safety Answering Point (PSAP) Operations Grant in the amount of \$195,740.

WHEREAS, Genesee County has significant coverage gaps in the south central portion of the county that would be remediated by an additional public safety communications tower, and

WHEREAS, Genesee County has identified property to build a new tower / radio site, and

**WHEREAS**, The budgetary cost for the tower, shelter, public safety radio equipment, engineering, consultant fees, and associated civil work is \$1,625,999.00 through 2021, and

**WHEREAS,** There are at least \$83,000.00 unallocated capital project funds remaining in the 800 MHz Capital Project account and

**WHEREAS,** There are at least \$84,327.17 remaining from the NY Statewide Interoperable Communications Grant (SICG) Round 4 currently allocated to the existing project, and

**WHEREAS,** Genesee County was awarded SICG Round 7 funding in the amount of \$664,778.00 in 2018, and

**WHEREAS,** Genesee County has applied for SICG Round 8 funding that is expected to be awarded before the end of the year and will need to apply for SICG Round 9 funding in 2020, and

**WHEREAS,** After discussion between the E911 Operations Board, Sheriff and Director of Emergency Communications, we recommend the County Legislature approve the establishment of a new capital project in the amount of \$1,693,902.00 to be offset by existing capital funds and revenues as follows:

WHEREAS, Revenue sources have been identified to cover the cost of this project, with sources being as follows: funds that remain in the 800 MHz Radio System Upgrade Capital Project totaling \$167,327; and Statewide Interoperable Communications Grant Funding, which includes funds currently available totaling \$798,778, as well as funds expected from future grant awards totaling \$659,894, and

**WHEREAS,** The Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to establish a Capital Project for a Public Safety Communications Tower in the amount of \$966,105 as follows:

Decrease Revenue A.3020.3390.SICG (State Aid SICG) in the amount of \$6,000 and Reduce Appropriation A.3020.4230.0000 (Facility Electric) in a like amount; Increase in H3397.2080.0000 (Capital Project Expense) of \$798,778, offset by an increase in Revenue Account H3397.3097 (State Aid-Communications Grant) in a like amount:

Transfer of \$167,327 from the 800 MHz Radio System Upgrade Capital Project into the Public Safety Communications Tower Capital Project.

**WHEREAS,** The Committees on Public Service and Ways & Means did review the agreements and do recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Chair of the Genesee County Legislature is hereby authorized and directed to sign on behalf of the County of Genesee a proposed "Purchase and Sale Contract for Lots and Vacant Land" by and between Edward and Linda Snyder with the County of Genesee; together with such other and further documents or forms that the Chair needs to sign on behalf of the County of Genesee to complete the transfer and sale of the parcel of land of approximately 180 feet by 200 feet owned by these Sellers, and be it further

DETERMINATION OF NO SIGNIFICANT ENVIRONMENTAL IMPACT – SHERIFF / MOLASSES HILL ROAD EMERGENCY SERVICES COMMUNICATIONS TOWER

Legislator Maha offered the following resolution:

WHEREAS, the County of Genesee, New York (the "County") is considering undertaking a project (the "Project") consisting of the construction of an emergency

services communication tower (the "Tower") on Molasses Hill Rd. in the Town of Attica, Wyoming, New York, and

**WHEREAS**, the Project is considered an action subject to Article 8 of the Environmental Conservation Law of the State of New York and the State Environmental Quality Review Act (SEQRA) and implementing regulations, 6 NYCRR Part 617 (the "Regulations"), and
