#### EIGHTEENTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, October 28, 2020

The Genesee County Legislature met in Regular Session on Wednesday, October, 28, 2020 at 5:30PM in the Legislative Chambers at the Old Courthouse, 7 Main Street, Batavia, New York. Legislator Stein assisted with the audit. The prayer was offered by Legislator Yunker followed by the Pledge to the Flag.

Legislator Deleo presented a commendation to Pembroke School Superintendent Matthew Calderon recognizing his outstanding work on the Genesee County Complete Count Committee. Planning Director Felipe Oltramari explained the Committee received a grant that enabled them to purchase 6 Chrome books which were used to assist residents with completing their U.S. Census materials. All 6 Chrome books were donated to Pembroke Central School in honor of Mr. Caldron's dedication to the Committee.

Legislator Klotzbach presented a Proclamation for Cybersecurity Month to Information Technology Director Steve Zimmer and Deputy Director Melanie Inda.

Minutes of the October 14, 2020 Legislature meeting were approved upon motion of Legislature Deleo seconded by Legislator Maha, carried unanimously.

Legislature Chair Stein thanked the County for illuminating the Old Courthouse in Pink lighting in honor of Breast Cancer Awareness month. She commented on conducting the audit and that the final revenue distribution to towns and villages is included in this audit.

County Manager Matt Landers stated the county had a meeting with E3 Communications to discuss how their services may fit with county needs. The Police Reform and Reinvention Committee has a meeting tonight were they will hear from the Sheriff on the policies of the department. Legislators are invited to attend as well. The County had a meeting with Assemblyman Hawley and Senator Ranzenhofer's attorney to discuss the county request for local legislation pertaining to the voluntary revenue distributions to towns with villages in their borders. These towns are restricted in which fund the voluntary distributions must be assigned to. Mr. Landers stated the 2021 budget has been filed in the Legislature office and any changes will be in the form of an amendment. The Public Hearing on the budget is scheduled for November 4<sup>th</sup>.

JOINT SERVICE AGREEMENT EXTENSION-HIGHWAY/ROCHESTER GENESEE REGIONAL TRANSPORTATION AUTHORITY

Legislator Clattenburg offered the following resolution:

**WHEREAS,** Genesee County has an existing joint service agreement with the Rochester Genesee Regional Transportation Authority (RGRTA) for use of facilities at the Genesee County Highway Department by the Batavia Bus Service Inc., D/B/A RTS Genesee, and

**WHEREAS**, The County Highway Superintendent recommends extending the existing joint service agreement with RGRTA per terms and conditions of the existing agreement, and **WHEREAS**, The Genesee County Legislature did review this recommendation and does concur

at this time. Now, therefore, Be it **RESOLVED,** The Genesee County Legislature does hereby extend the existing joint service agreement with the Rochester Genesee Regional Transportation Authority under the same terms

and conditions of the existing agreement. **RESOLVED,** The extension of the joint service agreement shall be from November 1, 2020 through October 31, 2025.

**Budget Impact**: RGRTA pays Genesee County a \$600 per month lease for use of the highway facilities on Cedar Street.

CONTRACT RENEWAL – CENTRAL SERVICES AND HIGHWAY DEPARTMENT – GARBAGE AND REFUSE REMOVAL -- APPROVAL OF

WHEREAS, The Genesee County Highway Department and the Genesee County Purchasing Department are currently under contract with Waste Management of New York, and this agreement allows for three, one year extensions, the Genesee County Highway Superintendent and the Genesee County Purchasing Director recommend renewing the contract agreement with Waste Management of New York, and

**WHEREAS**, The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a contract with Waste Management of New York, LLC., 100 Ransier Drive, West Seneca, NY 14224 for the removal of garbage and refuse as per bid specifications, effective January 1, 2021 through December 31, 2021 at a price of \$18,910.08 per year.

**Budget Impact Statement**: The Central Services Fund includes \$14,500 for the removal of garbage and refuse from certain County Facilities and both the Road Machinery Fund (DM5130) and Airport (A5610) fund trash removal separately.

WHEREAS, Said contract does provide for three additional one year renewal options, and WHEREAS, The Highway Superintendent does recommend the contract be renewed and the Committees on Public Service and Ways and Means do concur. Now, therefore, Be it RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to enter into the second year of three one-year renewals with Thyssenkrupp Elevator Corp., 2745 Broadway #25, Buffalo, NY 14227 for the maintenance and repair of elevators located at various county facilities for the period of January 1, 2021 through December 31, 2021 at a cost not to exceed \$19,680.

**Budget Impact Statement**: Facilities Management budgets for this contract in its operating budget. Legislator Maha seconded the resolution which was adopted by 326 votes.

INTERMUNICIPAL AGREEMENT – HIGHWAY/TOWN OF BETHANY SNOW AND ICE CONTROL AND MOWING - APPROVAL OF

Legislator Torrey offered the following resolution:

**WHEREAS**, The Genesee County Highway Superintendent and the Genesee County Attorney have prepared an Intermunicipal Agreement for the control of snow and ice and mowing on county highways, and

**WHEREAS**, The Genesee County Highway Superintendent has presented this agreement to the several Town Highway Superintendents within Genesee County, and

**WHEREAS**, The Intermunicipal Agreement has been approved by the Town of Bethany who desires to provide such services to the County under the terms of the Agreement, and

**WHEREAS,** The Genesee County Highway Superintendent recommends approving this agreement as it is in the best interest of the taxpayers of the County, and

**WHEREAS**, The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it,

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the Intermunicipal Agreement for Snow & Ice Control and Mowing with the Town of Bethany as approved by their Town Board.

**Budget Impact Statement:** The cost per mile for the 2021 snow and ice season is \$6,521 and the cost per mile for mowing is \$474. This represents a 1.1% increase in the rate for snow and ice over the 2020 season and a 2% increase in the cost for mowing. The total annual payment to the Town of Bethany for these services is \$141,961.85 for snow and ice control and \$10,328.46 for roadside mowing.

WHEREAS, a Project for the Darien-Alexander Townline Rd over Tunnery Creek Bridge Replacement, Towns of Darien and Alexander, P.I.N. 4GN0.05 (the "Project"), County of Genesee is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ration of 80% Federal Funds and 20% Local Match; and

**WHEREAS**, Genesee County desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of the total project. Now, therefore, be it

**RESOLVED,** that the Genesee County Legislature does hereby approve all future supplemental agreements to the federal aid master agreement for the Project; and it is hereby further

**RESOLVED**, that the Genesee County Legislature hereby authorizes the Chairperson to pay in the first instance 100% of the federal and non-federal share of the cost of the Project or portions thereof; and it is further

**RESOLVED,** that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the Genesee County Legislature shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the New York State Department of Transportation thereof, and it is further

**RESOLVED,** that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project, and it is further

**RESOLVED,** that the Genesee County Legislature does hereby direct and authorize the Genesee County Treasurer to establish a capital project for Darien-Alexander Townline Rd over Tunnery Creek with federal aid in the amount of \$860,970 and a local match from Road and Bridge Reserve of \$215,243, and it is further

**RESOLVED,** that the Genesee County Legislature does hereby direct and authorize the Genesee County Treasurer to make the following budget amendment. Increase A.1000.9999 Balancing utilizing Road and Bridge Reserve in the amount of \$215,243 to be offset by an increase in appropriation A.9950.9 Transfers to Capital in a like amount. Increase H.5197.4592 Federal Aid in the amount of \$860,970. Increase H.5197.5031 Interfund Transfers in the amount of \$215,243 and increase H.5197 2080.0000 Highway Capital Project Expense for the Darien-Alexander Townline Bridge over Tunnery Creek in the amount of \$1,076,213.

**Budget Impact Statement:** Total cost of this project is \$1,076,213, funded with 80% federal aid and a 20% match from Road and Bridge Reserve.

Airport Pavement Rehabilitation

**WHEREAS,** the New York State Department of Transportation, under State Transportation Law, requires that project applications made by privately owned airports be accompanied by a resolution from the governing body of the county in which the airport is located. Now, therefore, be it

**RESOLVED**, that the County of Genesee endorses the project identified above at the LeRoy Airport for the purpose of making the project eligible for State funding; and be it further, **RESOLVED**, that a certified copy of the Resolution be forwarded to the President of LeRoy Aviation Services, Inc. to be filed with the New York State Commissioner of Transportation by attaching it to any necessary documents in connection with this project; and be it further, **RESOLVED**, that this Resolution shall take effect immediately.

**WHEREAS**, The Genesee County has received federal aid for the replacement of the Darien-Alexander Townline Rd over Tunnery Creek in the Towns of Darien and Alexander, and **WHEREAS**, This bridge project has been found by the Genesee County Legislature not to be subject to SEQR, as it is a Type II (4) Action, and

**WHEREAS,** The County requested letters of interest from consultant firms on the Local Design Services Agreement list as approved by NYSDOT and NYSCHSA and received proposals from 12 firms, and

**WHEREAS,** The Genesee County Highway Superintendent and the Assistant County Engineer did review and rate these proposals and did make a recommendation on selecting the best qualified firm for the project, and

**WHEREAS,** The Genesee County Highway Superintendent did review a fee proposal and negotiate a price according to the Procedures for Locally Administered Federal Aid Projects, and **WHEREAS,** The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a consultant agreement with Barton & Loguidice, 11 Centre Park #203, Rochester, NY 14614 in an amount not to exceed \$157,000.

**Budget Impact Statement**: This consultant agreement funds the preliminary engineering and final design work needed to progress the project under the federal aid program. The cost of the consultant agreement is \$157,000 and the design work and right of way acquisition is anticipated to take 12-18 months. Construction is scheduled for the spring of 2022. The capital project has a budget of \$1,076,213.
