TWENTIETH DAY GENESEE COUNTY LEGISLATURE OLD COURT HOUSE – 7 MAIN STREET, BATAVIA, NY MONDAY, NOVEMBER 20, 2023

The Genesee County Legislature met in Regular Session on Monday, November 20, 2023 at 5:30 PM in the Legislative Chambers of the Old Courthouse.

Chair Stein amended the agenda to take Setting of the public hearing resolution #12 from the original agenda and move to #36 on the non-consent.

Legislator Torrey offered to assist with the audit. The prayer will be offered by Legislator Torrey followed by the Pledge to the Flag.

Proclamations & Commendations: None.

<u>Approval of Minutes</u>: Legislator Clattenburg motioned to approve the November 8, 2023 minutes seconded by Legislator Hawley, carried.

<u>Committee & Special Assignment Reports</u>: Chair Stein announced that she was at the Finger Lake Regional Economic Development Council meeting was last week having been given the opportunity for the region to compete in a 10 million dollar pot of money for one specific activity. The FLREDC chose workforce. Application had to be in to the State last Friday. The committee will be looking for the selection of the workforce application for 10 million dollars to be awarded back to the Finger Lakes Region. We have the designation of a Tech Hub because of STAMP - the Tech Hub-Genesee High Tech Manufacturing in New York State, residing between Buffalo, Rochester and Syracuse. The application is being submitted on the premise of this Tech Hub and I-90 transportation availability to the tech hub.

<u>Communications & Petitions</u>: the Clerk announced correspondence was received in the office that Ethics Board member, Teressa Morasco is retiring at the end of December so that there will be a vacancy to the board. Chair Stein wished Teressa well.

<u>Legislator Comments</u>: Legislator Torrey announced Isaiah Jones the Student Trustee for GCC was in attendance. Legislator Torrey mentioned he is a great addition as the Student Trustee. Chair Stein mentioned several joined Senator Borrello to recognize Command Sgt. Major William R. Joyce receiving 2023 Veterans Hall of Fame Honoree for the 57th District. It was a very nice celebration with his family in attendance. Chair Stein thanked Mr. Joyce for his service, his contribution serving our community is noticed. Lastly, Governor Hochul vetoed the Class III Stream. This helps the County with Ditches and Waterways. This is the third veto.

<u>County Manager Report</u>: County Manager Matt Landers mentioned Shining Star Employee Recognition: Wendie Davis and Karen Hall – During the casual lunch gathering, they noticed a concerning situation unfolding as a fellow community member appeared unresponsive while waiting for the bus. Wendie took immediate action by securing assistance and having someone call 911 while she stayed with the individual. Simultaneously, Karen managed the situation by ensuring those on the nearby bus remained calm and supported. It's important to emphasize that their quick response, combined with the efforts of the bus driver, led to a positive outcome, and the unresponsive individual has now fully recovered. Also, CSEA is close to an agreement on contract. Lastly, spending is up a little bit on the budget. There is a slight increase in the levy showing 5.3% up over the last four years. With inflation over the past four years keeping the levy at 5.3 % is significant.
