TWENTIETH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, November 25, 2019

The Genesee Legislature met in Regular Session on Monday, November 25, 2019 at 5:30 PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Stein assisted with the audit. Prayer was offered by Legislator Torrey followed by the Pledge to the Flag.

In addition to our regular meeting Chairman Bausch opened a public hearing on the mandated public sector shared services plan. All interested parties were invited to be heard.

Minutes of the November 13, 2019 Legislature meeting were approved upon motion of Legislator Hilchey seconded by Legislator Stein, carried unanimously.

Legislator Stein commented on the last Inter County Association meeting of the year held at the Elmira Corning Regional Airport where NYSAC staff stated the Governor indicates he is willing to delay criminal justice reform but the legislature is leaning toward moving ahead and providing funding. Chairman Bausch reported he attended GAM where the discussion revolved around fire protection and issues communities are facing due to limited volunteers.

County Manager Jay Gsell commented on the statewide press event held on November 21, 2019 relating to Criminal Justice reform. Part of the message was that public safety is not in the forefront and victims won't be seeing offenders held. Participants and supporters included the Sheriffs Association and Police Chiefs Association.

The Clerk proceeded with the resolutions:

RESOLUTION NO. 465 BUDGET AMENDMENT - SHERIFF/K-9 PROGRAM-APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, A transfer of funds is needed to the Sheriff's K9 Program budget to help cover the cost of a bulletproof vest for K9 Frankie, as well as his food and incidentals through year end, and

WHEREAS, Funds are available in the K-9 Donations Reserve Account from the gifts and donations that have been made to the K9 Program to help cover these costs, and WHEREAS, The Committees on Public Service and Ways and Means did review this

request and do recommend approval at this time. Now therefore be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to amend the 2019 budget as follows:

\$400 to A3110.4800.3317 (Program Exp-Canine Program)

To be offset by increasing the following revenue account:

\$400 to A3110.2705 (Gifts and Donations), with funds to come from A915.6 (K-9 Assigned Unappropriated Funds)

Budget Impact Statement: Increase in Sheriff's 2019 appropriations in the amount of \$400; offset by an increase in revenue in a like amount. Funds will come from the K9 Donations Reserve Account.

Legislator Young seconded the resolution which passed by 326 votes.

RESOLUTION NO. 466 2019 BUDGET AMENDMENT – SHERIFF/ STOP-DWI PATROLS - APPROVAL OF

Legislator Maha offered the following resolution

WHEREAS, The Genesee County STOP DWI Coordinator did reallocate funds within the 2019 STOP DWI budget to allow for the Sheriff's Office to run additional STOP DWI patrols, and

WHEREAS, The Public Service Committee did review this request and does recommend approval at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to amend the 2019 budget by increasing A.3110.1020.0150 – Overtime DWI in the amount of \$1,450 to be offset by an increase in revenue A.3110.2804 – Shared Services in a like amount.

Budget Impact: None. Unused funds within the existing STOP DWI budget will be used to accommodate the Sheriff's Office request to run additional STOP DWI patrols

Legislator Stein seconded the resolution which passed by 326 votes.

RESOLUTION NO. 467 BUDGET AMENDMENT - SHERIFF-OVERTIME/OFFICE OF COURT ADMINISTRATION-APPROVAL OF

Legislator Hilchey offered the following resolution:

WHEREAS, The courthouse security overtime costs have exceeded the amount budgeted for 2019 due to staff changes and an officer out on extended sick leave, and WHEREAS, An additional \$27,000 is needed to cover court security overtime through the end of 2019, and

WHEREAS, The Office of Court Administration will reimburse all court security overtime costs, and

WHEREAS, The Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to amend the 2019 budget by increasing Sheriff's appropriations as follows:

\$27,000 to Sheriff's Account A.3110.1020.0500 (OT-Office of Court Admin) to be offset by an increase in Sheriff's Revenue Account

Budget Impact Statement: Increase in Sheriff's appropriations of \$27,000 to cover courthouse security overtime costs; offset by an increase in revenue in a like amount from Office of Court Administration reimbursement.

RESOLUTION NO. 468 CONTRACT AMENDMENT – SHERIFF / UNINTERRUPTED POWER SUPPLY MAINTENANCE AGREEMENT – EATON CORPORATION-APPROVAL OF

Legislator Stein offered the following resolution:

WHEREAS, Genesee County did contract with Eaton Corporation, represented by Lynn Associates, Inc., 6622 Main Street, Suite 4, Buffalo, New York 14221 for the purchase, installation and maintenance of the Uninterrupted Power Supply (UPS) supporting the Genesee County Emergency Dispatch Center at 165 Park Rd, Batavia, NY 14020, pursuant to Resolution #292 on August 13, 2014, and

WHEREAS, The current, three-year maintenance agreement will expire on July 26, 2020, and

WHEREAS, Genesee County received a NYS Statewide Interoperable Communications Grant (SICG) which included funds for radio system maintenance, including

uninterrupted power supply systems, and

WHEREAS, Eaton Corporation and the County negotiated a four-year maintenance agreement renewal with an annual cost of \$6,000.00 each year, and

WHEREAS, Both parties agreed to adjust the commencement date to January 1, 2020, in order to align with SICG funding, and

WHEREAS, After careful review, the Genesee County Sheriff, County Attorney, and Director of Emergency Communications recommend the County amend the maintenance agreement with Eaton Corporation for the period of January 1, 2020, through December 31, 2023, at a cost not to exceed \$24,000.00, to be paid in four annual payments of \$6,000.00, and

WHEREAS, The Committee on Public Service did review this request and does recommend approval at this time. Now, therefore, be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to approve the amendment to the UPS maintenance agreement with Eaton Corporation, represented by Lynn Associates, Inc., for the period of January 1, 2020, through December 31, 2023, at a cost not to exceed \$24,000.00, to be paid in four annual payments of \$6,000.00.

Budget Impact: The 2020 cost of \$6,000.00 for UPS maintenance and offsetting SICG revenues were incorporated into the 2020 Communications Budget.

WHEREAS, The Committee on Public Service did review this request and does concur with the Emergency Management Services Coordinator's recommendation at this time. Now, therefore, Be it

RESOLUTION NO. 473 2019 SALARY SCHEDULE AMENDMENT – DISTRICT ATTORNEY – APPROVAL OF

Legislator Stein offered the following resolution:

WHEREAS, The District Attorney has requested the creation of one full time position of a Paralegal which is included in the 2020 Genesee County Budget, due to the Discovery obligations recently imposed on prosecutors by the State of New York, and

WHEREAS, There is a need for the position of a Paralegal beginning in December 2019, and

WHEREAS, The Committees on Public Service and Ways and Means did review the request and do recommend approval at this time, now therefore, be it

RESOLVED, That the Genesee County Treasurer and Personnel Officer are hereby authorized and directed to amend the 2019 Genesee County Management Salary Schedule by creating one full time position of a Paralegal Grade 13 effective 12/2/2019.

Budget Impact: Due to vacancies, there is enough money in our Personal Services Account and Medical Account to start the Paralegal position in December 2019.

RESOLUTION NO. 474 2019 BUDGET TRANSFER – HIGHWAY/ CAPITAL PROJECTS – APPROVAL OF

Legislator Hilchey offered the following resolution:

WHEREAS, The Genesee County Highway Superintendent did review his construction budgets for the 2019 construction season and recommends completing additional work, and

WHEREAS, A capital project transfer would be required to fund this work, and WHEREAS, The Genesee County Highway Superintendent recommends transferring local funds from a road project to the Large Span Culvert project to allow for this work, and

WHEREAS, The Committees on Public Service and Ways and Means did review this recommendation and does concur. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature does hereby authorize the Genesee County Treasurer to make the following Capital Project Transfers:

Transfer \$195,000 from Capital Project – Colby Rd (CR#51) to Capital Project – Large Span Culverts

Budget Impact Statement: The resolution moves \$195,000 in funding from the Colby Rd capital project to the Large Span Culvert capital project. This additional funding will allow another culvert to be installed along Bloomingdale Rd in the Town of Alabama.

CHANGE ORDER – HIGHWAY/ LARGE SPAN CULVERTS-KEELER CONSTRUCTION -- APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, The Genesee County Highway Superintendent recommends authorizing additional bridge and culvert work with Keeler Construction as part of the Large Span Culvert project, and

WHEREAS, The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it

RESOLVED, That the Chair of the Genesee County Legislature does hereby authorize change orders in the amount of \$235,277.70 for Keeler Construction related to discovered conditions on bridge replacements in the original contract as well as adding an additional bridge replacement to the contract.

Budget Impact Statement: The capital project for Large Span Culverts will be amended to allow for the additional work. The original contract with Keeler Construction was for \$635,614.14 and the change orders will bring the total contract amount to \$870,892.11. The original scope called for the replacement of Bridges 405, 917 and 1010. The change order will add the replacement of Bridge 112 to the contract. Legislator Deleo seconded the resolution which passed by 326 votes.

RESOLUTION NO. 476 APPOINTMENT - GLOW WORKFORCE DEVELOPMENT BOARD MEMBERSHIP

WHEREAS, The Chief Elected officials are charged with the responsibility of soliciting and appointing members to this Workforce Development Board. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature does hereby approve the following appointment to the GLOW Workforce Development Board:

Molly Haungs, Marketing Manager of LandPro Equipment has been nominated as a GLOW Workforce Representative for Private Sector Business to serve a term from 11/19/2019 - 11/19/2021.

RESOLVED, That the GLOW Workforce Development Board will be in effect until such time that the Workforce Innovation and Opportunity Act of 2014 is repealed. Legislator Maha seconded the resolution which passed by 326 votes.

RESOLUTION NO. 477 CONTRACT – CENTRAL SERVICES/CONSTELLATION NEW ENERGY AGREEMENT– APPROVAL OF

Legislator Young offered the following resolution:

WHEREAS, The Purchasing Office did sponsor a bid through MEGA in 2018, and **WHEREAS,** As a result of this bid Constellation was awarded the contract for supplying electricity to Genesee County buildings, and

WHEREAS, Constellation NewEnergy, Inc. has offered us a fixed price contract for the supply of electricity in concordance with the MEGA contract, and

WHEREAS, The EnergyNext Consultant for MEGA determined that this contract should generate a savings for Genesee County of approximately \$6000 per over a 36-month period, and

WHEREAS, The Genesee County Attorney and the EnergyNext Consultant have both reviewed and approved the contract, and

WHEREAS, The Committee on Ways and Means did review the fixed price contract with Constellation and do recommend approval at this time. Now, therefore, Be it **RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a three-year fixed price contract with Constellation NewEnergy, Inc., 1001 Louisiana St. Constellation Suite 2300, Houston, TX 77002, Attn: Contract Administration, to provide Genesee County with a fixed price contract for electricity service to take us through the remainder of the MEGA contract, from the period of January 14, 2020 through October 2023.

Budget Impact: The previous contract was based on the market price of electricity, whereas this contract is fixed price and will not vary based on the market. Our Energy consultant estimated that this contract will save Genesee County approximately \$6,000 on our electrical costs over a 36-month contract term. Legislator Hilchey seconded the resolution which passed by 326 votes.

RESOLUTION NO. 478 AWARD OF CONTRACT-INFORMATION TECHNOLOGY/ RFP2019-111 TELEPHONE SYSTEM MAINTENACE - APPROVAL OF

WHEREAS, The Genesee County Information Technology Director is recommending Genesee County award RFP2019-111 Telephone System Maintenance to MeridianIT to provide 24x7 monitoring, remote and on-site service of all equipment including handsets and incremental software upgrades for the IP Office servers installed at every County location, and

WHEREAS, The Ways and Means Committee did review this request and recommend the approval of the Telephone System Maintenance contract, Now, therefore, Be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the Telephone System Maintenance contract with MeridianIT, 2110 S. Clinton Ave Rochester NY 14168 with an amount not to exceed \$24,943

BUDGET IMPACT STATEMENT: The contract cost of \$24,943 for Telephone Systems Maintenance is within the 2019 Adopted Budget in line item A.1680.4290.0100 PBX / Telephone Systems Maintenance and is included in the 5-year projected budget. The Telephone Systems Maintenance services provided by MeridianIT supplement the I.T. staff and provide a level of expertise that in-house staff do not have. The telephone system is a critical component to supporting County Departments and this outsourced service is necessary to ensure its availability and reliability.

RESOLUTION NO. 492 IMPLORING THE STATE OF NEW YORK TO IMMEDIATELY AMEND OR DELAY IMPLEMENTAITON OF BAIL AND DISCOVERY REFORM LAWS THAT WILL ENDANGER THE PEOPLE OF NEW YORK AND REVERSE DECADES OF BIPARTISAN PROGRESS IN REDUCING CRIME

Legislator Stein offered the following resolution:

WHEREAS, the Genesee County Legislature recognizes the need for statewide bail and discovery reform, and

WHEREAS, protecting the people from harm by enforcing the rule of law is the foundational role of government, and

WHEREAS, County governments are vested by the State of New York with the responsibility to protect the most vulnerable among us, including the socioeconomically disadvantaged, the disabled, the elderly, and children, and

WHEREAS, no group is more vulnerable than the victims of crime, and a just society demands that crime victims should be recognized as key participants within the criminal justice system and be treated with dignity, fairness, and respect, and,

WHEREAS, for the past twenty-five years the State of New York has committed itself to reducing crime, and has succeeded as evidenced by official U.S. Department of Justice Uniform Crime Reporting Statistics showing that New York transformed from the second most dangerous state in America in the early 1990s to the safest large state in America by the early 2000s, and WHEREAS, in the final stages of adopting its FY 2020 budget, the State of New York enacted sweeping criminal justice reforms including the elimination of cash bail for many specific enumerated crimes and the imposition of stringent discovery mandates on police and prosecutors, and

WHEREAS, under bail reform, beginning January 1, 2020, judges will be stripped of their discretion to set bail for many specific enumerated crimes, which means those suspected of committing these crimes can no longer be held in jail after their arrest, regardless of the strength of the case against these defendants, or the length of the potential sentence faced by these defendants, or the extent of the harm allegedly caused by these defendants, and instead these defendants will be released back into the general public, and

WHEREAS, these crimes include those that result in the deaths of innocent people, including several subcategories of homicide and manslaughter, resulting in those responsible for these deaths being released back into the community of grieving families, and

WHEREAS, these crimes include Making a Terroristic Threat and Money Laundering in Support of Terrorism in the Third and Fourth degree, resulting in those alleged to have supported terrorism in this manner, or who have threatened to commit acts of terrorism, being released immediately from police custody, and

WHEREAS, these crimes include Promoting an Obscene Sexual Performance by a Child; Possessing an Obscene Sexual Performance by a Child; Failure to Register as a Sex Offender; and Patronizing a Person for Prostitution in a School Zone, resulting in suspected child predators being released and returning into our community, and

WHEREAS, these crimes include Aggravated Assault Upon a Person Less than Eleven Years Old; Reckless Assault of a Child by a Daycare Provider; Criminal Sale of a Controlled Substance to a Child; Abandonment of a Child; and Criminal Possession of a Weapon on School Grounds, resulting in those suspected to have physically harmed or endangered children in this manner being free from custody, and

WHEREAS, these crimes include Female Genital Mutilation; Stalking in the Second Degree; and Aggravated Harassment, resulting in those suspected of violating victims in this manner being returned to the community of their victims, and

WHEREAS, these crimes include Endangering the Welfare of a Vulnerable Elderly Person or an Incompetent of Physically Disabled Person, resulting in the potential for further endangerment of seniors and these defenseless individuals, and

WHEREAS, these crimes include Aggravated Cruelty to Animals; Torturing Animals and Injuring Animals, resulting in the immediate release of those suspected of deliberately injuring, torturing and killing animals, and

WHEREAS, these crimes include Assault in the Third Degree, Aggravated Vehicular Assault, and other crimes of physical violence against people, and

WHEREAS, these crimes include Burglary of a Residence, resulting in the immediate release of these individuals back into the neighborhoods they are suspected of targeting, and

WHEREAS, these crimes include Bail Jumping and Unlawfully Fleeing a Police Officer in a Motor Vehicle, resulting in release on recognizance of the very individuals who have demonstrated a propensity to evade the law, and

WHEREAS, all of the offenders mentioned heretofore are at risk of not showing up for court, thereby placing a burden on state, county and local public employees who, under this law, are required to send multiple court appearance reminders to these offenders, as well as law enforcement and District Attorneys who must commit resources to tracking and pursuing those who evade prosecution, and

WHEREAS, all offenders who are currently being held in custody for non-qualifying crimes including those mentioned heretofore will be eligible for release from custody on January 1, 2020, and

WHEREAS, the discovery mandates imposed by the State of New York will require law enforcement and District Attorneys, beginning January 1, 2020, to turn over voluminous trial-related materials to defense attorneys within 15 days, creating a mandate that will inevitably not be achieved in some cases and may result in the inability of the People to properly prosecute cases against criminal defendants, and

WHEREAS, the office of New York State's chief law enforcement officer, Attorney General Letitia James, testified at a state legislative hearing on October 28, 2019, that there will be implementation difficulties because prosecutors across the state presently lack the resources required to fully comply with discovery mandates, and

WHEREAS, the Attorney General's office further testified that their own office, which carries a limited criminal caseload, lacks resources required to fully comply with discovery mandates and therefore consequently needs an additional \$10 million in state funding, and

WHEREAS, discovery reform will also result in an opportunity for defendants to gain access to crime scenes that may include a victim's residence, thereby giving defendants accused of burglaries, assaults, rapes and other crimes committed in victims' homes the right to return to those same homes, and

WHEREAS, the issues mentioned heretofore will undeniably impact past, present and future victims of crime in a negative manner, and in so doing, the bail and discovery reforms adopted by the State of New York will themselves further victimize these innocent individuals, and

WHEREAS, these bail and discovery laws, in their current form, represent a clear and present danger to society, will tilt the scales of justice in favor of suspected criminals and away from innocent crime victims, and risk reversing decades of bipartisan progress made by the State of New York in reducing crime, and

WHEREAS, the fundamental responsibility of governments to protect the vulnerable in society demands that the shortcomings of these laws be remedied prior to their effective date of January 1, 2020, now, therefore, be it

RESOLVED, that the Genesee County Legislature hereby implores the State of New York to immediately amend or otherwise delay implementation of these laws by convening an emergency session of the State Legislature, or by emergency executive authority, or by any other means deemed legal/ possible by the State, and to do so before December 31, 2019, and be it further **RESOLVED**, that the following improvements to these laws be implemented as soon as possible:

- 1. Give judges the discretion to impose bail when appropriate for all of the crimes enumerated in this resolution;
- 2. Increase the discovery timeline from 15 days to a minimum of 45 days;
- 3. Phase in discovery reform by applying these new mandates only to misdemeanors effective January 1, 2020, and then to felonies effective January 1, 2021, and repeal the provision that makes the new discovery mandates applicable to violations of the Vehicle and Traffic Law;
- 4. Require that court appearance reminders are sent not only to defendants but also to the victims of their crimes; and
- 5. Extend appropriate dignity, fairness and respect to crime victims by soliciting input from victim advocate organizations and considering their suggestions for improving these laws, and be it further

RESOLVED, that the Genesee County Legislature asks all counties in New York State to urge their state representatives to take immediate action on the foregoing issues, and be it further **RESOLVED**, that copies of this resolution be provided to every member of the New York State Legislature including Senator Michael Ranzenhofer and Assemblyman Stephen Hawley, Attorney General Letitia James, Lieutenant Governor Kathy Hochul, Governor Andrew Cuomo, Senator Kirsten Gillibrand, Senator Charles Schumer, the New York State Association of Counties, the New York State Sheriffs' Association, the New York State Association of Chiefs of Police, the District Attorneys Association of New York, the New York State Defenders Association, the New York State Probation Officers Association, the New York Council of Probation Administrators, the Association of Justices of the Supreme Court of the State of New York, the New York State Association of City Court Judges, the County Judges Association of the State of New York, and the County Attorneys' Association of the State of New York. Legislator Torrey seconded the resolution which passed by 326 votes.

RESOLUTION NO. 493 SETTING A PUBLIC HEARING ON INTRODUCTORY LOCAL LAW NO. 3 YEAR 2019 –

SALARIES OF COUNTY FIXED TERM OFFICERS-**APPROVAL OF**

WHEREAS, There is hereby introduced to the Genesee County Legislature a proposed Local Law entitled: "A LOCAL LAW IN RELATION TO THE SALARIES OF COUNTY OFFICERS OF THE COUNTY OF GENESEE ELECTED OR APPOINTED FOR A FIXED TERM," and

WHEREAS, Subdivision 5 of Section 20 of the Municipal Home Rule Law requires a Public Hearing to be held on such Local Law. Now, therefore, Be it

RESOLVED, That a Public Hearing shall be held on the Proposed Local Law Introductory No. 3, Year 2019 on Wednesday, December 11, 2019 at 5:30 p.m. at the Genesee County Courthouse, 7 Main Street, Batavia, New York.

Legislator Young seconded the resolution which passed by 326 votes.

RESCIND RESOLUTION NO. 463-2019 Legislator Clattenburg offered the following resolution:

WHEREAS, the County of Genesee has hired the Napoli Shkolnik, PLLC law firm to represent the County of Genesee in litigation involving damages sustained by the County as a result of the opioid epidemic, and

WHEREAS, Federal Judge Polster of the United States District Court, Northern District of Ohio, has preliminarily approved a request to certify a negotiating class setting forth the framework to assist this Court to negotiate and potentially obtain a resolution of all of the opioid litigation throughout the United States, and

WHEREAS, the Napoli Shkolnik law firm originally recommended that the County of Genesee opt out of this negotiation class to continue litigation in Suffolk County, and WHEREAS, based upon a change in circumstances and further clarifications made regarding Judge Polster's Order, early last week, the Napoli Shkolnik law firm revised its recommendation in order to allow the County of Genesee to remain in the Federal negotiating class, and

WHEREAS, the County Attorney concurs with this revised recommendation, and WHEREAS, the County of Genesee Legislature adopted Resolution No. 463 on

November 14, 2019, authorizing the Chair of the Legislature to sign a document entitled "Exclusion Request Form" to be filed on or before the deadline of November 22, 2019, in order to confirm the decision to opt out, and

WHEREAS, on November 20, 2019, the County of Genesee Legislators gave direction to the County Attorney to contact the Napoli Shkolnik law firm and request that the "Exclusion Request Form" not be filed with the Federal Court, which was done by the County Attorney in an email on November 21, 2019. Now, therefore, Be it

RESOLVED, that Resolution No. 463 is hereby rescinded, and thereby, the County of Genesee will continue to participate in the negotiating class in the United States District Court. Northern District of Ohio.

Prior to the vote the County Attorney stated the firm originally recommended New York Counties opt out but then reversed their recommendation after getting further clarification on the judge's orders. Ways & Means Committee Chair Clattenburg stated the County Attorney was given direction to withdraw our opt-out action and this resolution formalizes that directive.

Now, therefore, Be it

RESOLVED, That the Genesee County Legislature has audited and does approve the claims as listed above, and Be it further

RESOLVED, That the Genesee County Treasurer be and hereby is authorized and directed to make payments as listed above.

Prior to the vote Legislator Stein commented that when legislators conduct the audit they have the opportunity to ask questions and check for errors

Legislator Dibble seconded the resolution which passed by 326 votes.

At 6:05 pm Chairman Bausch closed the Public Hearing on Shared Services Plan. There were no speakers or comments.

The meeting adjourned at 6:05 PM upon motion of Legislator Stein seconded by Legislator Young, carried unanimously.
