TWENTY-FIRST DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, December 11, 2019

The Genesee Legislature met in Regular Session on Wednesday, December 11, 2019 at 5:30 PM at the Old Courthouse 7 Main Street, Batavia, New York. Chairman Bausch assisted with the audit. Prayer was offered by Legislator Deleo followed by the Pledge to the Flag.

In addition to our regular meeting Chairman Bausch opened a public hearing on Local Law Introductory No. 3, Year 2019; A Local Law in Relation to the Salaries of County Officers of the County of Genesee, Elected or Appointed for a Fixed Term. All interested parties were invited to be heard.

Legislature Chair Robert Bausch was presented with a retirement commendation and pen certificate for the Sales Tax Allocation 40 Year bill signed into law by the Governor from Assemblyman Hawley. Mr. Don Read, former County Clerk and Vice Chair of the Genesee County Republican Committee presented Mr. Bausch with a framed print of the Old Courthouse. Chairman Bausch commented that he has served on the Genesee County Legislature for ten years, the past two as Chair. Senator Ranzenhofer was unable to be present due to road conditions.

Minutes of the November 25, 2019 meeting were approved upon motion of Legislator Stein seconded by Legislator Maha, carried unanimously.

Legislator Maha reported that he attended CJAC meeting where it was stated the jail population is down. There was a robust discussion on criminal justice reform. Chairman Bausch reported that an appointment to the NYS Board of Electric Generation Siting and the Environment in relation to the application of Excelsior Energy Center; Norman Pawlak of Bergen. Chair Bausch also commented that he has had contact with the NYS Comptroller's Office regarding the status of our Sales Tax Allocation Agreement. He stated that he was told they expect to approve the agreement before 12/31/19.

County Manger Jay Gsell reported the State is projected to have a \$6 billion deficit in 2020 and he anticipates the Counties will be hit with more funding cuts. Mr. Gsell thanked Chairman Bausch for his leadership, communication and service as a legislator and chairman.

WHEREAS, Allied Universal bought out U.S Security Associates in early 2019 and that U.S. Security Associates transferred all personnel and services to Allied Universal and that Allied Universal continues to provide all the security services for the DSS/MH building at 5130 East Main Street, Batavia, and

WHEREAS, Pursuant to Genesee County Request for Bids #2014-15, it is the mutual desire of the Genesee County Commissioner of Social Services, the Director of Community Services and Allied Universal to extend said contract for a one-month period January 1, 2020 through January 31, 2020 under the current rate of \$24.30 per man hour with the same terms and conditions, and

WHEREAS, the Committee on Human Services has reviewed this request and does concur. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature does hereby authorize and direct the Chairperson to enter into an agreement with Allied Universal, 180 South Clinton Avenue, Suite 110, Rochester, NY 14602 for the provision of Security Services at offices occupied by DSS and Mental Health at 5130 East Main Street, Batavia for the period January 1, 2020 through January 31, 2020 at the rate of \$24.30 per man hour.

Budget Impact Statement: The annual DSS cost of the program is \$113,600 with a local share of approximately \$28,445. The annual MH cost of the program is \$94,000 with a local share of approximately \$90,000. The funds for the remainder of 2019 are already included in each Department's current budget, and the additional funds for 2020 will be included in the approved 2020 Departmental budgets. The 2020 budget projections are based on the outcome of the Request for Bid proposal for security services that are currently under review. Prior to the vote Legislator Deleo stated he will be abstaining due to a conflict since he works part-time for Allied Universal.
