## **RESOLUTION NO. 515**

TO ADOPT LOCAL LAW D, YEAR 2022 - IN RELATION TO THE SALARIES OF COUNTY OFFICERS OF THE COUNTY OF GENESEE, ELECTED OR APPOINTED FOR A FIXED TERMADOPTION OF

Legislator Clattenburg offered the following resolution:

WHEREAS, the following proposed Local Law D, Year 2022 which was duly introduced to the Genesee County Legislature on November 9, 2022 in accordance with the Law: LOCAL LAW D, YEAR 2022 FOR COUNTY OF GENESEE, NEW YORK A LOCAL LAW IN RELATION TO THE SALARIES OF COUNTY OFFICERS OF THE COUNTY OF GENESEE, ELECTED OR APPOINTED FOR A FIXED TERM BE IT ENACTED by the Genesee County Legislature as follows: Section 1. The salary of County Officers set forth below shall be as follows:

a.	Commissioner of Elections (2)	\$53,966
b.	Director of Human Resources	\$102,565
c.	Commissioner of Social Services	\$95,325
d.	County Clerk	\$105,819
e.	Treasurer	\$111,639
f.	Sheriff	\$117,121
g.	Highway Superintendent	\$128,922
h.	County Attorney	\$137,519
i.	Public Defender	\$111,239

- Section 2. The above salary shall take effect January 1, 2023.
- Section 3. This Local Law is subject to referendum on petition pursuant to the provisions of Section 24 of the Municipal Home Rule Law.
- Section 4. This Local Law shall take effect upon proper filing with the Office of the Secretary of State, and

WHEREAS, the Clerk of the Genesee County Legislature will post a certified notice of the Public Hearing on said proposed Local Law on the bulletin boards in the Old Courthouse, and

WHEREAS, the Clerk of the Genesee County Legislature will publish in the Batavia Daily News, the official newspaper of the County of Genesee, the notice of Public Hearing on Local Law Introductory D, Year 2022, and

WHEREAS, a Public Hearing will be held at 5:30 p.m. on the 21<sup>st</sup> day of November 2022 in Batavia, New York, at which time all interested persons who wished to speak were heard. Now, therefore, be it

RESOLVED, that "A LOCAL LAW IN RELATION TO THE SALARIES OF COUNTY OFFICERS OF THE COUNTY OF GENESEE, ELECTED OR APPOINTED FOR A FIXED TERM" to be known as Local Law Number 1, Year 2023, for the County of Genesee as introduced on November 9<sup>th</sup> and adopted on November 21, 2022.
