**ADMINISTRATIVE WATER REVIEW BOARD – Eff: 5/23/24**  
 Established Resolution No. 222-2024

The Genesee County Legislature created the Genesee County Administrative Water Review Board. The Genesee County Administrative Water Review Board shall have the following power and duties:

1. Establishment of criteria for required review of new water supply requests or expanded water supply requests.
2. Establishment of a water supply request form.
3. Setting a framework or matrix for approval or denial of requests.
4. Compile required data on water resources, supply, usage and existing plans.
5. Establish meeting times and frequency.
6. Establish a system for notifying applicants of Review Board decision.
7. Appoint a clerk or secretary as may be needed.
8. Maintain an open line of communication with stakeholders including but not limited to municipalities, Genesee County Economic Development Agency, the Legislature, Water Resources Agency and Monroe County Water Authority.

The Genesee County Administrative Water Review Board shall consist of the following members; Public Health Director or designee, County Highway Superintendent or designee, Planning Director, County Attorney, County Manager or Deputy County Manager, Legislator (who shall be appointed by the Legislature Chairperson) and, at their sole discretion, the Genesee County Legislature may appoint one (1) Community Member. The Administrative Water Review Board shall prepare an annual report consisting minimally, of a list of all requests, meeting dates and disposition of each request.

**AGING COUNCIL**  
 Established Resolution NO. 136-1972, Revised By-Laws Reso No. 214 year 2016, Reso No. 146 year 2018, Reso No. 130 year 2019

This Council was formed as the direct result of the Legislature’s concern for the Senior Citizens of Genesee County. It was established in response to the many letters concerning the problems such as housing, health related problems and services available for the local elderly. The most pressing charge is to respond to the various concerns of the elderly through advising the Office for the Aging as to its directions and/or function.

**Membership:** Composition includes consumer and provider members with representatives from each Legislature Dist. Social Security, GCC, Salvation Army and Social Services.

**Article II Organization**

- (4) **Membership Terms**-Terms of office for both Community members and Service Provider/Caregiver/Public members shall be **as follows**:
- a. Members in good standing, and may serve **a maximum of three (3) consecutive terms with each term being three (3) years in length, for a total of nine (9) consecutive years.**
    - i. **In the event a position is not filled within a year of vacancy, any former member can be reappointed to a new term.**
  - b. A Legislative representative serves an appointed two (2) year term **and is exempt from term limits.**
  - c. A permanent position shall be allocated to the DSS Adult Services Supervisor. The DSS Adult Services Supervisor is exempt from **terms and term limits. Unless the individual in that position changes, an application and legislative approval are not required.**
  - d. **Members shall have one (1) vote within the Advisory Council.**
- (5) **Council** members with nine (9) years of service or more may elect to become an emeritus member of the Committee whose membership is defined by the following responsibilities and limitations. Emeritus members may participate through attending scheduled meetings; and attending social events (no minimum requirement). **Meetings:** First Wednesday of every month at 2:30 p.m. except July & August at Office for the Aging. ## AGRICULTURAL AND FARMLAND PROTECTION BOARD

Established Resolution No. 19 – 1993

This Board shall advise the County Legislature and work with the County Planning Board in relation to the proposed establishment, modification and termination of any agricultural district. The Board shall render expert advice relating to the desirability of such action, including advice as to the nature of farming and farm resources within any proposed or established area and the relation of farming in such area to the County as a whole. The Board revises and makes recommendations on revisions to the classification of specific land areas based on local soil, land and climatic conditions to the Department of Agriculture and Markets. The Board also reviews Notice of Intent Filings to undertake an action within an agricultural district involving the advancement of Public Funds for certain construction projects.

**Membership:** This Board shall consist of four active farmers residing within the County. One representative of agribusiness, one representative of an organization dedicated to farmland preservation, a County Cooperative Extension Agent, County Director of Planning, County Director of Real Property Tax Services, Chair of the County Soil and Water Conservation District’s Board of Directors, and a member of the County Legislature. Four-year terms.

**Meetings:** Meets quarterly on the second Monday at 7:00 p.m. at County Building II.

## GENESEE COMMUNITY COLLEGE BOARD OF TRUSTEES

The Genesee Community College Board of Trustees is the policy making body of the College. In order to discharge their legal responsibilities, members of the Board serve on the three-standing committees, (Buildings & Grounds, Personnel, and Policy), and on ad hoc and special committees of the whole from time to time. The Board is responsible for a wide range of College business from the approval of new curricula and the decision to modify facilities to the appointment of the President. The Board reviews and approves the college budget each year and recommends its adoption to the Genesee County Legislature. The Board also approves collective bargaining contracts when they are negotiated, and recommends their approval to the Legislature. They participate in the celebration and ceremonies of the College especially by taking part in conferring of degrees at graduation.

**Membership:** Nine members are appointed for **seven** year terms. Four are appointed by the New York State Governor and five are appointed by the County Legislature. In addition, the students elect a tenth Board member for a one-year term on an annual basis.

**Meetings:** Official business is transacted at regularly scheduled monthly meetings on the second Monday at 6:30 p.m. on each month (Except February) in the College Board Room at GCC.

## GENESEE COUNTY ECONOMIC DEVELOPMENT CORPORATION

GCEDC is a public benefit corporation established in 1970 under New York State’s General Municipal Law. Board membership was increased from 5 to 7 in 1979. The Agency is commissioned by the Genesee County Legislature to promote, attract and encourage economic development in Genesee County that results in the creation of employment opportunities, enhancement of the quality of life and general prosperity for county residents. In meeting this charge, GCEDC is involved in both public and private sector projects which address the needs of the local business community. It is a policy making Board. Resolution 381-2012 states it is the intention and pleasure of the Genesee County Legislature that any non-legislature appointment to the GCIDA/GCEDC continue to be at the “pleasure” of the Genesee County Legislature but not to exceed a term of six years after which term an application for reappointment or new appointment must be approved by the Legislature.

**Membership:** The Agency is governed by a Board of Directors consisting of seven volunteer members who are appointed by the Genesee County Legislature. Resolution No. 381-12 established terms for the Corporation members. Six-year terms.

## HEALTH BOARD

Established Resolution No, 50-1953

Amended Resolution No. 353-06, No. 244-2015

The Board of Health is a Regulatory Agency, charged with enforcing in the County of Genesee, the New York State Public Health Law, New York State Sanitary Code, some New York State Department of Environmental Conservation Codes and the Genesee County Sanitary Code. The Board is responsible for recommending and setting policies and procedures for the Genesee County Health Department.

**Membership:** The Board of Health, by Law, must be comprised of three physicians, one representative from the County Legislature, three members at large. According to Law, one additional member from the City of Batavia is entitled to appointment. Terms are for six years, and terms are staggered.

**Meetings:** The Board meets quarterly on the first Tuesday (Feb, Apr, Jun, Aug, Oct) at 4:00 PM in alternating Health Department Offices. Members are paid a stipend of \$20.00 per meeting.

**7/1/15 Amendments to above:** The current Genesee County Board of Health be abolished, effective June 30, 2015 and a combined Board of Health consisting of common members from both the counties of Genesee and Orleans be established, effective July 1, 2015, with members appointed by the County Legislatures of both counties. The combined Board of Health shall consist of seven members, with one Legislative member from each county and at least three of whom shall be physicians licensed to practice in the State of New York. The term of office of each appointed member of the Board of Health shall be six years but established on a rotational basis, and the term of one of the members shall expire annually on a sequential rotating basis, except for the Legislative representatives whose term coincides with that of his/her membership on the County Legislature.

A \$20 stipend is available for each Board Member per meeting attended.

Four-year terms. **Meetings:** Monthly meetings are held at least 10 times per year on the fourth Thursday at 3:30 PM at the Mental Health Clinic. A \$40.00 stipend is paid per meeting.

## TRAFFIC SAFETY BOARD

Established by Local Law No. 3 1975, Resolution No. 191

This Board’s function and purpose is to promote and encourage street and highway traffic safety; to formulate county-wide highway safety programs and coordinate efforts of interested parties and agencies engaged in traffic safety education; to cooperate with local officials within the county in the formulation and execution of traffic safety programs and activities; to study traffic conditions on streets and highways within the county, study and analyze reports of accidents and causes thereof; and to coordinate and direct all local activities related to the implementation of the state highway safety program as approved by the Governor or his designee.

**Membership:** The Board shall consist of not less than ten members interested in traffic safety and traffic problems and shall be appointed by the Genesee County Legislature.

Each member shall be a resident of Genesee County and shall be a qualified elector thereof. This is a volunteer Board with a term of office of three years.

**Meetings:** Shall be held within the County at least twice a year but limited to no more than 4 per year when the Board shall deem it advisable. Interested parties and agencies, public and private, interested in traffic regulation, control, safety, and education are invited to participate. Meets quarterly on the third Tuesday (Mar, Jun, Sept, Dec) at 3:00 PM and usually held at the County Sheriff’s Office in the Conference Room.

## WATER RESOURCES AGENCY

Created to assist the Legislature in the planning and implementation of future water improvements for the County of Genesee. To consist of nine members, each appointed for three year terms and each to be a resident of Genesee County. No more than three County Legislators may be members of the Agency at any time. The Genesee County Legislature did increase the number of members of the Water Resources Agency from 9 to 10 to include a representative from the Genesee Association of Municipalities appointed by the Genesee County Legislature

This agency shall have the following powers & duties:

1. To assemble data relating to the water resources available to the County, both within and without its boundaries.
2. To assist in the planning and design of coordinated water resource and transmission projects within the County of Genesee and make recommendations in connection with such projects.
3. To recommend and assist in the development of intermunicipal agreements and grant applications for water supply and transmission pursuant to Article 5-G of the General Municipal Law.
4. To contract for engineering and related technical services within the annual budgetary appropriations provided to the Agency by the County and if requested, to provide said services to municipalities within the County pursuant to contract with said municipalities.
5. To contract for other necessary services to carry out its functions within the annual budgetary appropriation provided to the Agency by the County subject to the provisions of Article 5-A of the General Municipal Law and audit requirements of the County Legislature.
6. To serve as administrative head or body of any county water district that may hereinafter be created.
7. To coordinate the implementation of any county water resource or transmission project or district with comprehensive planning and land use regulation and consistent with any intermunicipal agreements entered into by other municipalities in Genesee County pursuant to Article 5-J of the General Municipal Law.
8. To have such other powers and duties as may from time to time be lawfully conferred upon the Agency by the County Legislature. It is expressly provided, however, that nothing contained herein shall be construed as modifying, transferring or abolishing any power, duty or authority of the County Legislature, any county department or elected or appointed official.

The Agency shall prepare an annual report of its activities in the form required by the County Legislature not later than October 1<sup>st</sup> of each year. (three-year terms)

The Genesee County Planning Board shall hear appeals from applicants who choose to contest the decision of the Administrative Review Committee.

## YOUTH BOARD Amended 2009, Amended 2017 – Resolution 126-2017, Amended 2023 - Resolution 43-2023

Develops effective recommendations and programs for the prevention and control of delinquency, crimes by youths, and to further youth development. Acts as liaison between executive, administrative and other legislative bodies in respect to the solutions of youth problems and for the enactment of youth programs. Encourages closer cooperation between employers, labor, churches, recreation commissioners, state and local employment programs, service clubs and other public and private agencies so as to stimulate employment for youth and encourage sound youth programs on the basis of community planning. Review and analyze grants, accept or reject the creation of expansion of recreation and youth services projects, and review and analyze statistical records and data that reflect the incidence and trends of delinquency and youthful crimes and offenses.

**Membership:** The Youth Bureau shall have a membership of 20, one from each of the following municipalities: Elba; Darien/Corfu/Pembroke; Oakfield/Alabama; Byron/Bergen; Pavilion/Bethany; LeRoy; Stafford; Alexander and the Town of Batavia and two from the City of Batavia; the remainder representing the following: Genesee County Sheriff’s Office; County Probation Department, Department of Social Services; Job Development Bureau, Health Department and four youth representatives. All representatives will be appointed for a term of three years, unless they represent a County Department, then it is their tenure of office.
