The meeting was called to order by the Clerk of the Legislature, Pamela LaGrou, pursuant to Section 151 of County Law.

Prayer was offered by Legislator Hilchey followed by the Pledge to the Flag.

The Clerk asked for nominations for a Temporary Chairperson. A motion was made by Legislator Stein to nominate Gregg Torrey as Temporary Chairman, seconded by Legislator Clattenburg, carried unanimously.

Temporary Chair Torrey took the chair and asked for nominations for a Permanent Chair. Legislator Clattenburg made a motion to nominate Rochelle Stein, seconded by Legislator Maha, carried unanimously. Temporary Chair Torrey declared Rochelle Stein the Permanent Chair for the Term 2020/2021.

Temporary Chair Torrey asked for nominations for a 2nd Vice Chair. Legislator Hilchey made a motion to nominate Andrew Young, seconded by Legislator Dibble, carried unanimously. Temporary Chair Torrey declared Andrew Young the 2nd Vice Chair for the Term 2020/2021.

Temporary Chair Torrey asked for nominations to fill the position of Clerk to the Legislature. Legislator Stein made a motion to nominate Pamela LaGrou seconded by Legislator Young, carried unanimously.

A brief recess convened for the administration of Oaths of Office by County Clerk Michael Cianfrini.

Temporary Chair Torrey turned the gavel over to Permanent Chair Stein.

Chair Stein conveyed her gratitude to County Clerk Cianfrini for administering Oaths of Office and to Legislator Torrey for serving as Temporary Chair. Legislators were thanked for their support and dedication to Genesee County business. She commented that there is much progress yet ahead for our County and Legislators voices need to be heard to best represent our rural community.
