County Attorney Kevin Earl presented a resolution to set a Public Hearing on Local Law Introductory No. 1 Year 2019 pertaining to imposing a hotel/motel room occupancy tax with an expiration date of September 30, 2021. The Public Hearing date will be February 13, 2019. This was approved for placement on the next Legislature Agenda upon motion of Legislator Stein seconded by Legislator Young, carried unanimously.

Mr. Earl presented a resolution that amends the expiration date of the Hotel/Motel Room Occupancy Tax Local Law. County Manager Jay Gsell explained that 95% of the bed tax collected goes to the County tourism agency for marketing and promotion of tourism. The County retains a percentage for administrative fees. Mr. Gsell stated that some counties are considering adding AIR BNB rooms to the list of what is asses a bed tax. Chair Clattenburg requested the Legislature be provided Local Law No. Two of 1995 to ensure legislators are familiar with the law and any members of the public who attend the public hearing should have the information available. Legislator Young inquired about the timing of the public hearing and vote on the local law. It was clarified that the public hearing on the local law shall be set for February 13, 2019. Upon hearing from the public, the resolution amending the Local Law will follow on Legislature agenda on February 13, 2019. This was approved for placement on the February 13, 2019 Legislature Agenda upon motion of Legislator Bausch seconded by Legislator Young, carried unanimously.
