Public Defender location is running out of space for employees. Genesee County seeks to renovate the first and second floor interior of the existing Engine House facility with the goal of expanding the Public Defender's Office space and address accessibility issues. Genesee County staff has reviewed and evaluated architectural proposals submitted for this work under a qualification based selection. The Public Defender has identified 2023 Hurrell Harring grant funds in the cap amount of \$892,610 that will be utilized to fund a portion of the project. Genesee County will fund the remainder of the project up to \$975,990. Upon award of said Hurrell Harring grant, \$892,610 will be added to the capital project for a total project cost of \$1,868,600.
