#### **GENESEE COUNTY LEGISLATURE**

Batavia, New York

Wednesday, January 22, 2020

The Genesee Legislature met in Regular Session on Wednesday, January 22, 2020 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Hilchey assisted with the audit. Prayer was offered by Legislator Yunker followed by the Pledge to the Flag.

Minutes of the December 11, 2019 and January 8, 2020 Legislature meetings were approved upon motion of Legislator Dibble seconded by Legislator Young, carried unanimously.

The following Out-of-State Travel Requests:

Tim Hens, Highway Superintendent to travel to Washington DC for a White House NEPA signing event 1/8/20-1/9/20, \$0 cost. Motion for approval by Legislator Maha seconded by Legislator Hilchey, carried.

Tim Hens, Highway Superintendent to travel to Brainerd, MN for NACE President visit January 1/21-1/24/20, \$0 cost. Motion for approval by Legislator Yunker seconded by Legislator Deleo, carried.

Tim Hens, Highway Superintendent to travel to Columbus, OH for NACE President visit & presentation 1/30-1/31/20, \$0 cost. Motion for approval by Legislator Deleo seconded by Legislator Hilchey, carried.

Kristine Voos, Public Health to Alexandria, VA for Public Health Accreditation Board Applicant Learning event 2/10-2/13/2020 County cost \$700. Motion for approval by Legislator Young seconded by Legislator Dibble, carried.

Vice Chair Clattenburg commented that many e-mails and correspondence have been received pertaining to bail reform and new discovery requirements. She has heard from many constituents concerned with the changes recently implemented.

County Manager Jay Gsell shared a few details pertaining to the release of the Governor's budget. Video Lottery Terminal (VLT) payments to Genesee County are on the chopping block with this budget proposal. Annual County VLT payments have been around \$160,000. NYSAC staff are analyzing aspects of the proposed budget and will provide details and priorities in the near future.

### SALARY SCHEDULE AMENDMENT/BUDGET AMENDMENT-DISTRICT ATTORNEY/PT-TIME LEGAL CLERK TYPIST

Legislator Dibble offered the following resolution:

**WHEREAS**, in 2019, the District Attorney's Office sought a part-time Legal Clerk Typist to provide required clerical services associated with newly required Discovery statute for the sole purpose of dealing with Discovery relating to City of Batavia traffic tickets, and

**WHEREAS**, after the 2020 Genesee County Budget was adopted, the City of Batavia and County of Genesee negotiated a new County/City Contract for the position for the purpose of providing required services associated with said Discovery requirements for the City of Batavia, and

WHEREAS, the Committees on Public Service and Ways & Means did review this request concur, now Therefore Be it

**RESOLVED,** that the Genesee County Treasurer and Human Resources Director are authorized and directed to amend the 2020 Employee Salary Schedule by creating a Part-time Legal Clerk-Typist CSEA Grade 7 effective January 23, 2020, and Be It further

**RESOLVED,** that the Genesee County Treasurer is authorized and directed to make the following amendment to the budget:

Increase A1165 1030-0000 Part-time Salaries \$9,930.00, A1165 8010-0000 Social Security \$744.00, A1165 8011-0000 Medicare \$174.00 and A1165 8020-0000 Retirement \$1,152.00 to be offset by an increase to A1165 2807.2 Shared Service, City Prosecutorial in the amount of \$12,000.

**Budget Impact Statement**: \$12,000.00 increase in expenses offset by increase in revenue from City of Batavia who will contract with the County for \$12,000 for the provision of part-time Legal Clerk-Typist services.

Legislator Torrey seconded the resolution which passed by 283 votes, Stein (43) absent.

# RESOLUTION NO. 8 SALARY SCHEDULE AMENDMENT-DISTRICT ATTORNEY/PT-TIME ADA & FULL-TIME PARALEGAL

Legislator Yunker offered the following resolution:

**WHEREAS**, the District Attorney's office has been analyzing and strategizing for the most efficient and cost-effective manner to ensure implementation of the newly enacted Criminal Procedure Law Article 245 Discovery statutes, and

**WHEREAS**, the 2020 budget and salary schedule included an additional part-time Assistant District Attorney to assist with managing the provisions of newly required Discovery statutes, and

**WHEREAS**, a full-time Paralegal was hired in early December of 2019 providing the Department with needed assistance with implementing Discovery statutes, and

**WHEREAS**, the District Attorney and First Assistant District Attorney have assessed the value of the Paralegal position and how it better fits with the needs of new Discovery requirements and now request the elimination of the part-time Assistant District Attorney and creation of a full-time Paralegal, and

WHEREAS, the Committees on Public Service and Ways & Means did review this request concur, now Therefore Be it

**RESOLVED,** that the Genesee County Treasurer and Human Resources Director are authorized and directed to amend the 2020 Employee Salary Schedule by eliminating one part-time Assistant District Attorney and creating a full-time Paralegal Grade 13 effective January 23, 2020.

**Budget Impact Statement**: The cost for another Paralegal starting February 3, 2020 will be \$56,337 for salary and fringe for the remainder of the year. We budgeted \$35,175 for a part-time ADA for the year. Therefore, we would be short \$21,162. In Addition, we budgeted \$129,750 for the new full-time Assistant District Attorney for salary and fringe. The salary and fringe for the Assistant District Attorney we hired for the year is \$104,289. That is a savings of \$25,461. Furthermore, we budgeted \$21,449 for medical for the Paralegal that is now working. She is not taking advantage of that coverage but instead is taking for \$2500 buyback. There is a savings of another \$18,949. That means that we have \$23,248 that was budgeted for our office that we will not be spending.

Legislator Deleo seconded the resolution which passed by 283 votes, Stein (43) absent.

# RESOLUTION NO. 9 GRANT ACCEPTANCE / BUDGET AMENDMENT – SHERIFF / STATEWIDE INTEROPERABLE COMMUNICATIONS GRANT – APPROVAL OF

Legislator Yunker offered the following resolution:

**WHEREAS**, The New York State Division of Homeland Security and Emergency Services Office of Interoperable and Emergency Communications (NYS DHSES/OIEC) has awarded Genesee County sustainment funds in the amount of \$698,572 from the Statewide Interoperable Communications Grant (SICG) program, and

**WHEREAS**, The grant funds can be used for a variety of reimbursements including, but not limited to, new tower / public safety radio site construction, currently budgeted operational costs (radio system maintenance, towers leases, radio system utilities), new equipment purchases (radio infrastructure improvements, programming, and interoperable user equipment), and a portion of budgeted salary expenditures, and

WHEREAS, The grant period is from January 1, 2020 – December 31, 2021, and

**WHEREAS**, The total award of \$698,572 will be allocated as follows: \$306,979 to the 2020 Communications Budget and \$391,593 to the Public Safety Communications Tower Capital Project, and

**WHEREAS**, After careful review, the Genesee County Sheriff, County Treasurer, and Director of Emergency Communications recommend the County Legislature accept the NYS DHSES / OIEC SICG award in the amount of \$698,572, and

**WHEREAS**, The Committees on Public Service and Ways & Means did review this request and recommend approval at this time. Now, therefore, be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to accept the NYS DHSES / OIEC SICG award in the amount of \$698,572. Be it further **RESOLVED**, That the Genesee County Treasurer is hereby authorized and directed to amend the budget of the Public Safety Communications Tower Capital Project as follows:

Increase in H3397.2080.0000 (Capital Project Expense) \$391,593, offset by an increase in Revenue Account H3397.3097 (State Aid-Communications Grant) in like amount.

Increase in A3020.4660.SICG (Contracted Other-SICG) \$2,160, offset by an increase in Revenue Account A3020.3390.SICG (State Aid-SICG) in like amount.

**Budget Impact:** The total award of \$698,572 will be allocated as follows: \$306,979 to the 2020 Communications Budget (previously \$304,819) \$391,593 to the Public Safety Communications Tower Capital Project

## RESOLUTION NO. 10 BUDGET AMENDMENT - SHERIFF/ REMAINING GRANT FUNDS- APPROVAL OF

Legislator Hilchey offered the following resolution:

**WHEREAS**, The Sheriff's Office has several active grants with funds remaining available to be used in 2020, and an Agreement with the Village of Bergen with funds available to use through May 31, 2020 and

**WHEREAS,** These grants include the GTSC Police Traffic Services Grant, with available funds in the amount of \$23,389; a DCJS Legislative Initiative Grant, with available funds in the amount of \$7,712; and two DHSES grants with available funds totaling \$42,898; as well as an

Agreement with the Village of Bergen to provide additional police services with available funds in the amount of \$6,462, and

**WHEREAS**, The Sheriff is requesting a 2020 budget amendment to allow for the use of the available funds, and

**WHEREAS,** The Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to amend the 2020 budget by increasing Sheriff's appropriations as follows:

\$6,462 to A3110.1020.0900 (Overtime Bergen)

\$7,712 to A3110.2030.0030 (Sheriff's Equipment)

**Budget Impact**: Increase in Sheriff's 2020 appropriations in the amount of \$80,461, with money coming from funds remaining in a GTSC grant, a DCJS grant, two DHSES grants, and an Agreement with the Village of Bergen; offset by revenue in a like amount.

# RESOLUTION NO. 11 APPOINTMENT – SHERIFF / TRAFFIC SAFETY BOARD – APPROVAL OF

Legislator Hilchey offered the following resolution:

**WHEREAS**, there is a vacancy that exists on the Genesee County Traffic Safety Board for a representative for the category of Insurance, and

**WHEREAS**, Joseph A. Teresi, Jr., Vice President of Tompkins Insurance Agencies, Inc., has expressed interest in being appointed to fill this vacancy and has submitted an application that Traffic Safety Board members have reviewed, and

**WHEREAS**, as Chairman of the Traffic Safety Board, I am recommending this appointment. Now, therefore, be it

**RESOLVED**, that the above three-year appointment (02/1/20-1/31/23) of Joseph A. Teresi, Jr. to the Genesee County Traffic Safety Board be approved at this time.

**WHEREAS,** The Genesee County Highway Superintendent was presented a Memorandum of Agreement by the Federal Aviation Administration for the continued operation and maintenance of the Navigational Aids (NAVAIDS) at the Genesee County Airport, and

**WHEREAS**, The approval of this agreement would benefit Genesee County and the users of the Genesee County Airport, and

**WHEREAS,** The agreement consolidates and replaces four existing land leases for NAVAIDS at the Genesee County Airport, and

**WHEREAS**, The Genesee County Attorney has reviewed and concurred with the proposed agreement, and

**WHEREAS,** The Genesee County Highway Superintendent does recommend approval of the Memorandum of Agreement at this time, and

**WHEREAS**, The Public Service Committee reviewed and concurs with this recommendation. Now, therefore, Be it,

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized to execute the Memorandum of Agreement with the Federal Aviation Administration on behalf of Genesee County to continue the operation of the NAVAIDS at the Genesee County Airport.

**Budget Impact**: There is no cost to the MOA. Entering into the Agreement with the FAA saves the County money from operation, maintenance and inspection of these facilities.

## CONSULTANT AGREEMENT – HIGHWAY-HUNDREDMARK RD BRIDGE ENGINEERING -APPROVAL OF

**WHEREAS**, Genesee County has been awarded a federal aid pass-thru grant to replace the Hundredmark Rd over Muck Drainage, and

**WHEREAS**, engineering and design services will be required to complete the project and conform with the rules and regulations of the Federal Highway Administration, and

**WHEREAS**, The Genesee County Highway Superintendent has reviewed a consultant agreement covering this work and does recommend approval at this time, and

**WHEREAS**, The Committee on Public Service has reviewed this request and does concur at this time, Now, therefore, be it

**RESOLVED,** That the Chairperson of the Genesee County Legislature is hereby authorized to approve a consultant agreement with Erdman & Anthony, 145 Culver Rd #200, Rochester, NY 14620 for design and engineering services related to the replacement of the Hundredmark Rd Bridge over the Muck Drainage in a cost not to exceed \$175,000.

**Budget Impact:** The agreement is for \$175,000. The capital project established for this bridge replacement has funds available for this agreement and is funded at 80% federal aid, 15% state aid and a 5% local match. **WHEREAS,** The Committee on Public Service has reviewed this recommendation and does concur, Now therefore, Be it

**RESOLVED**, That the Genesee County Legislature does hereby extend the contract for the supply of aviation service products with Ascent Aviation Group, One Mill Street, Parish, NY for the period of March 1, 2020 through February 28, 2021.

**Budget Impact**: The equipment will be purchase from the Road Machinery Equipment capital project. The capital project was increased by \$220,000 for this purchase. The total cost of the equipment, based on local bids, is \$178,682.

#### RESOLUTION NO. 17 REJECTION OF BIDS –HIGHWAY/EXCAVATOR

**WHEREAS**, The Genesee County Highway Superintendent advertised and received local bids on for a hydraulic tracked excavator and attachments for use at the County Highway Department and all bid received exceeded budgeted funds, and

**WHEREAS**, The Genesee County Highway Superintendent recommends rejecting all bids received at this time, and

**WHEREAS,** The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it

**RESOLVED,** The Genesee County Legislature does hereby reject all bids received for the purchase of a new and unused hydraulic tracked excavator under Genesee County Bid #2019-17. **Budget Impact**: The equipment will be purchase using Equipment Funds from the 2020 DM5130 Road Machinery Fund. Budgeted amount for this purchase is \$78,738 per year for 5 years. All bids received exceeded this amount. The bid specifications will be revised and rebid by the County at a later date.

**WHEREAS**, Genesee County advertised plans and specifications for the construction of a new water transmission main along portions of Chestnut Ridge Rd, Paul Rd (NYS Route 252A), and Chili Ave (NYS Route 33A) in the Town of Chili, Monroe County in order to advance Phase 2 of the Countywide Water Project; and

**WHEREAS,** Genesee County previously awarded a construction contract for this work to Villager Construction, Inc., 425 Old Macedon Center Rd, Fairport, NY 14502 in a total amount not to exceed \$3,796,700, and

**WHEREAS,** After a thorough review of the proposals and interviews with the eligible applicants DSS and MH have opted to select Securemedy, Incorporated, 8507 Oxen Hill Road, #101, Fort Washington, MD 20744 to provide security services at 5130 East Main Street, Batavia, NY 14020 for the time period of 2/1/2020 to 12/31/2020, and

**WHEREAS,** The security services will be provided for each department at \$26.10 per man hour with the annual approximated cost of \$248,002, and

**WHEREAS**, The Ways and Means Committee having reviewed the RFP recommendation and do concur at this time. Now, therefore, be it

**RESOLVED,** That the Genesee County Legislature does hereby authorize and direct the Chairperson to enter into an agreement with Securemedy, Incorporated, 8507 Oxen Hill Road, #101, Fort Washington, MD 20744 to provide security services for offices occupied by DSS and MH at 5130 East Main Street, Suite #3, Batavia, NY 14020.

**Budget Impact Statement:** The DSS portion of the cost for security services for 2020 is \$105,784 for the 11-month contract-period of 2/1/2020 to 12/31/2020. Approximately \$26,446 is local share, with the remaining \$79,338 is reimbursed by federal/state aid. The current

projected billing rate for 2020 is \$26.10 per man hour. The previous one-month extension with Allied Universal will have no impact to the DSS departmental 2020 budget. The 2020 DSS departmental budget accounts for this expenditure. The projected shortfall from the adopted budget and the projected total of the new security contract is \$384.

The MH department's portion of the cost or security services is \$97,500 for 11-month contract period. All \$97,500 is local share. The 2020 MH departmental budget will be drafted to account for this expenditure for the contract period.

In addition to the RFP for security services each final applicant was asked for a Best and Final Offer based on a request by DSS and MH to provide cost estimates to provide a proposal for an On-Site Security Threat Assessment. The proposal for Securemedy, Inc. is attached. The projected time required for the completion of the proposed On-Site Security Assessment cannot be accurately determined until an initial consultation has been completed to determine the scope of the project. This additional cost for this project is currently not budgeted, is not included in this Memorandum of Support and will be brought back to the legislature for review and approval in the future.
