WEDNESDAY, JANUARY 24, 2024

The Genesee County Legislature met in Regular Session on Wednesday, January 24, 2024 at 5:30 PM in the Legislative Chambers of the Old Courthouse. Vice Chair Clattenburg chaired the meeting in absence of Chair, Rochelle M. Stein.

Legislator Maha offered to assist with the audit. The prayer was be offered by Legislator Yunker followed by the Pledge to the Flag.

Proclamations & Commendations: None.

<u>Approval of Minutes</u>: Legislator Dibble motioned to approve the December 13, 2023 minutes seconded by Legislator Hawley. Legislator Torrey motioned to approve the Organizational Meeting January 3, 2024 minutes seconded by Legislator Deleo.

<u>Committee & Special Assignment Reports</u>: Legislator Torrey mentioned the search for a new Genesee Community College President is going well. There are nine finalists which interviews will be conducted over zoom to narrow this selection down to 3 to 4 people for in-person interviews. Legislator Torrey will update as progress happens.

County Manager Report: NYSAC updated counties on anticipation of the governor's budget for 2024/25. First issue is with the proposed cuts of 400 million in Medicaid costs. Second concern is sun setting on the Shared Services. 18 out of 57 counties have submitted plans giving the governor an indication that this is something that can be done away with since more counties are not participating. If the Governor eliminates the shared services, County Manager stated this would take away allocated funds such as the 250K for Broadband. County Manager Landers sent correspondences to Senator Borrello, Assemblyman Hawley, and Governor's Office explaining the importance of the shared services and how to obtain funds back that have been allocated if the governor moves forward with this action. This impacts all current shared services.

RESOLUTION NO. 8

REAL PROPERTY TAX CORRECTIONS AND REFUNDS 2024–TREASURER–APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, the New York State Real Property Tax Law §554 and §556, provide an administrative correction of errors process to assist the property owner in obtaining real property tax corrections and refunds caused by certain clerical errors, unlawful entries, and errors in essential fact, and

WHEREAS, the tax levying body can delegate, by resolution on an annual basis, the authority to perform the duties of the tax levying body in regard to Real Property Tax Law §554 and Real Property Tax Law §556, and

WHEREAS, the Committee on Ways and Means does recommend that the Treasurer be delegated to perform said duties. Now, therefore, be it

RESOLVED, that the Genesee County Treasurer be and hereby is authorized and directed to carry out the requirements of §554 and §556 of the Real Property Tax Law, effective immediately, where the Real Property Tax Director's recommended correction or refund is two thousand five hundred dollars or less, and be it further

RESOLVED, that on the fifteenth day of each month, the Genesee County Treasurer shall submit a report to the Genesee County Legislature of the corrections and refunds processed during the preceding month containing the name of each recipient, the location of the property, the reason for the correction or refund, and the amount of the correction or refund.

Budget Impact: No immediate impact, correction and refund amounts will vary from year to year. Refunds are charged to allowance for uncollectable which currently has a balance of approximately \$89,204.

RESOLVED, that the Genesee County Treasurer and Human Resources Director are hereby authorized and directed to amend the 2024 Employees Salary Schedule by establishing 1 45 hour biweekly temporary position of Senior Financial Clerk-Typist, CSEA Grade 11 in the Treasurer's Office effective February 1 – April 30, 2024.

Budget Impact: There should be sufficient funds in the .1 from the vacant full time position

WHEREAS, as part of the approved 2024 Asset Acquisitions, two projects are noted to have outside revenue sources; Emergency Management Mobile Command Unit and Department of Social Services Visitation Rooms, and

WHEREAS, budget Amendments are needed in order to account for the revenue in the respective department budgets, and

WHEREAS, the Committee on Ways and Means did review this request and do recommend approval at this time. Now, therefore, be it

RESOLVED, the County Treasurer is hereby authorized and directed to amend the 2024 Genesee County Budget by increasing A.3640.4800.0503 – Program Exp, Homeland Security in the amount of \$30,000, offset by an increase A.3640.4305.2 – Fed Aid, Homeland Security in a like amount; increasing A.6010.4660.0000 – Contracted Other in the amount of \$23,611, offset by an increase in A.6010.4610 – Fed Aid – Soc Services Administration.

Budget Impact: Increase in expense of \$30,000 for EMS and \$23,611 for DSS is covered in total by grant revenue.

RESOLUTION NO. 12 CONTRACT-CHAMBER OF COMMERCE /TOURISM-APPROVAL OF

WHEREAS, the County of Genesee has implemented a hotel and motel tax to fund tourism promotion within Genesee County, and

Reimbursement at 59.5% from NYS Department of Health. The Genesee County Public Health Department is responsible for 40.5% of which we receive some Medicaid reimbursement.

RESOLVED, that Genesee County Legislature does hereby authorize the Chairperson of the Genesee County Legislature to approve the Intermunicipal Agreement between Genesee County and the Town of Alexander related to the inclusion of upsized water transmission mains, a SCADA system, electrical upgrades, and related site improvements, which are being constructed by the Town. Budget Impact: Per the agreement, the County Water Fund will reimburse the Town of Alexander up to \$466,000 for installing upsized water transmission mains, a SCADA system, electrical upgrades, and related site improvements. Reimbursements will be made within 30 days after the Town of Alexander invoices the County for work completed on a monthly basis and it is certified complete by their Engineer. The funding for these improvements is provided from the Water Fund.

RESOLVED, the Genesee County Highway Superintendent is hereby authorized and directed to purchase a dump body and snow plow equipment from TENCO Industries, 5700 South Lima Rd, Lakeville, NY 14480 in an amount not to exceed \$169,069 per Onondaga County Contract #8996-2022 bid specifications.

Budget Impact: The equipment will be purchase using Asset Acquisition funds. Budgeted amount for this purchase is \$357,000 and the actual cost of the truck, body and snow plow equipment is \$328,636.

WHEREAS, a project for the Dry Bridge Rd over Drainage Ditch in the Town of Alexander (PIN 4BNY.76), (the "Project") is eligible for reimbursement of qualified costs from Bridge NY funding that calls for the post-reimbursement apportionment of the qualified costs be borne at the ratio of 100% Bridge NY funds and 0% non-Bridge NY funds; and

WHEREAS, the New York State Department of Transportation will administer the right-of way phase of the project.

WHEREAS, the County Highway Superintendent does recommend executing the master agreement for the replacement of the culvert, and

WHEREAS, the Committees on Public Service and Ways and Means did review this recommendation and do concur. Now, therefore, be it

RESOLVED, that the Genesee County Legislature hereby approves the above subject Project; and be it further

RESOLVED, that the Genesee County Legislature hereby grants NYSDOT permission to directly apply Bridge NY funds to reimburse ROW costs incurred by NYSDOT on the Project; and it is further **RESOLVED**, that the Genesee County Legislature hereby agrees that the County of Genesee shall be responsible for all costs of the Project which exceed the amount of the BRIDGE-NY Funding awarded to the County of Genesee; and be it further

RESOLVED, that in the event the full state and non-state share costs of the Project exceeds the Bridge NY funding appropriated, the Genesee County Legislature shall convene as soon as possible to appropriate said excess amount immediately upon notification by the Superintendent of County Highways thereof, and be it further

RESOLVED, that the Genesee County Legislature hereby agrees that construction of the Project shall begin no later than twenty-four (24) months after award and that the project shall be completed within thirty (30) months of commencing construction; and be it further

RESOLVED, that the Chairperson of the Genesee County Legislature be and is hereby authorized to execute all necessary Agreements, Supplemental Agreements, certifications or reimbursement requests for State Aid and/or Bridge NY funding on behalf of the County of Genesee with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of Project costs; and be it further

RESOLVED, that the Genesee County Highway Department will be responsible for all maintenance of the Project; and it is further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project, and be it further

RESOLVED, that this resolution shall take effect immediately.

Budget Impact: There is no budget impact for this resolution; the capital project has already been established.

SPECIAL EVENT – AIRPORT/WINGS OVER BATAVIA AIR SHOW – APPROVAL OF

WHEREAS, a Special Events application was received from Wings over Batavia Foundation LLC to use the Genesee County Airport to host the Wings over Batavia Air Show from August 30 to September 2, 2024 and

WHEREAS, the Highway Superintendent and County Attorney did review and recommend approval of this special event, and

WHEREAS, the Committees on Public Service and Ways and Means do concur with this request. Now, therefore, be it

RESOLVED, that the Genesee County Legislature does herby grant permission to the Wings over Batavia Foundation LLC to use the Genesee County Airport to host the Wings over Batavia Air Show from August 30 to September 2, 2024 in accordance with the Rules and Regulations adopted for the Genesee County Airport.

Budget Impact: County support costs total are estimated at \$19,500, which are covered by the Air Show through Memorandum of Understanding with the Sheriff and local EMS operations. There is no added cost for current airport liability policy. There will be increased revenues for the airport during the event for additional fuel sales, tie downs and rentals. The county will also see increased sales tax because of the air show. The 2023 show generated over \$6,000 in profit off fuel sales. Estimated increase in sales tax and bed tax related to the event of approximately \$40,000.

WHEREAS, the Committee of Public Service did review this request and does recommend approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Legislature is hereby authorized and directed to enter into a site lease extension agreement with Lloyd Lane, Inc., 3258 Merchant Road, Warsaw, NY 14569, for the lease of space on the Genesee County telecommunications tower located at 153 Cedar Street, Batavia, NY for a period beginning January 1, 2024, and ending December 31, 2027, at a cost of \$956.68 per month for the first year with a 3% increase each year, ending December 31, 2027.
