THIRD DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, February 14, 2018

The Genesee County Legislature met in Regular Session on Wednesday, February 14, 2018 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Dibble assisted with the audit. Prayer was offered by Legislator Deleo followed by the Pledge to the Flag.

In addition to our regular meeting Chairman Bausch opened a Public Hearing on Fair Housing practices in Genesee County. As a recipient of Office of Community Renewal-Community Development Block Grant funds the County is required to hold an annual public meeting. All interested parties were invited to be heard.

The minutes of the January 24, 2018 meeting were approved upon motion of Legislator Maha seconded by Legislator Dibble, carried unanimously.

Chair Bausch reported he attended CJAC where the jail bed count was stated to be down a bit for males (73) and down dramatically for females (13). Chair Bausch also commented that there are many job openings in Genesee County. Job Development Director Scott Gage was present and commented there are 1000 open jobs this week including many at HP Hood, the company that purchased the yogurt plant in Batavia. Legislator Stein, the new Inter County Association President, commented that the February meeting is hosted by Genesee County at the Call Arena at GCC. NYSAC is sending staff to provide first-hand updates and information. Legislator Young, the liaison to the Health Board reminded those present of the importance of getting a flu shot. Legislator Maha stated he is on the NYSAC Public Safety Committee that met at the legislative conference last month. Among topics discussed were the Raise the Age requirements that will go into effect October 1, 2018 for 16 year olds and October 1, 2019 for 17 year olds. He further commented on his concern with the availability of required facilities for this age group of offenders. He also commented on his concern with the expectation that the arresting officer maintain custody.

County Manager Jay Gsell commented that the requirements for special facilities for 16 and 17 year olds essentially make them a prison. There has been some discussion among GLOW counties with regard to what options may exist for collaborating on a facility for the region.

WHEREAS, Genesee County is desirous of obtaining the services of the Monroe County Department of Public Health's Tuberculosis Control Program, and;

WHEREAS, The Director of Public Health did present a contract renewal for said services and the Committee on Human Services does concur. WHEREAS, AAWNY is the grant recipient and this MOU establishes the terms for which the GCOFA would receive funding to provide consultation, respite, and technology services; and

WHEREAS, A budget amendment is necessary for an additional \$3,573 revenue to be incorporated in the 2018 County Budget; and

WHEREAS, The Committee on Human Services did review this request and does recommend approval of this MOU and adjusting Office for the Aging Appropriations and Revenues for incorporation of these funds. Now, Therefore, Be it

Budget Impact: An increase in expenditures of \$92,173.95 in the General Fund and increase in revenue to the General Fund Nursing Home Revenue of \$184,347.91
