# SIXTEENTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York

Wednesday, September 26, 2018

The Genesee County Legislature met in Regular Session on Wednesday, September 26, 2018 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Bausch assisted with the audit. Prayer was offered by Legislator Young followed by the Pledge to the Flag.

In addition to our regular Legislature Meeting Chairman Bausch opened a Public Hearing on the mandated public sector shared services plan. All interested parties were invited to be heard. No one spoke on the shared services plan.

Legislature Vice Chair Marianne Clattenburg presented a commendation to retiring Job Development Director Scott Gage who retires on September 28, 2018. Mr. Gage was thanked for his many years of service to Job Development Bureau and the residents of Genesee County. Mr. Gage commented that communication and collaboration among departments provides for a beneficial work environment and the Legislature is credited with setting the tone with their positive leadership style.

The minutes of the September 12, 2018 Legislature meeting were approved upon motion of Legislator Stein seconded by Legislator Dibble, carried unanimously.

Legislator Stein commented that the Farm Bureau Annual meeting will be held on October 23<sup>rd</sup> at Terry Hills. She attended the NYSAC Fall Conference where Orleans County Manager Chuck Nesbitt was elected and will serve as President. A summary of resolutions and initiatives NYSAC is working on is available in the Clerk's office for anyone to review. At NYSAC conference she attended a Raise the Age panel discussion where it was stated that the expectation is for more activity with the county attorney's office and not as much as originally expected with the district attorney. The State has the RTA plan from 24 counties, including Genesee however no county plan has been approved. Raise the Age is to be implemented October 1, 2018. Soil & Water is experiencing staff changes with Jared Elliott leaving his position. She expressed kudos toward GAM for extending an invitation to all legislators to discuss sales tax sharing.

Chairman Bausch reported on a discussion on internet sales tax collection at NYSAC Fall Conference. New York State is not among twenty-four states that formed a coalition to press the issue of sales tax collection for internet sales. He and County Manager Gsell attended a round-table discussion with GCEDC leaders and Comptroller DiNapoli last week and he thanked legislators for attending the GAM meeting to discuss sales tax sharing.

County Manager Jay Gsell stated Genesee County was the second county to submit its Raise the Age Plan and there have been four versions of edits. They understand the importance of separating and tracking costs for Raise the Age. The question arose about implementation date, plan approval date and reimbursement for legitimate RTA expenses. Mr. Gsell indicated that the question was posed to State representatives and were assured there would be no funding withheld.

The Clerk proceeded with the resolutions:

RESOLUTION NO. 307 AID TO PROSECUTION GRANT ACCEPTANCE/ DISTRICT ATTORNEY - APPROVAL OF

Legislator Maha offered the following resolution:

**WHEREAS**, The District Attorney has been notified of the award of grant funding from the New York State Division of Criminal Justice Services for prosecution services aid in the amount of \$30,200.00, and

**WHEREAS**, The Committee on Public Services does recommend acceptance of these funds at this time. Now, therefore, Be it

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the agreement with the New York State Division of Criminal Justice Services for the acceptance of grant funds in the amount of \$30,200.00 for Aid to Prosecution in Genesee County, and Be it further

**RESOLVED**, That funds for said grant have been appropriated in the 2018/2019 Genesee County Budget.

**Budget Impact:** None - funds have been appropriated.

Legislator Clattenburg seconded the Resolution which passed by 326 votes.

**RESOLUTION NO. 308** 

GRANT ACCEPTANCE- EMERGENCY MANAGEMENT SERVICES & SHERIFF'S OFFICE - FY18 STATE HOMELAND SECURITY PROGRAM (SHSP) GRANT - APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, The Emergency Management Services Coordinator and the Genesee County Sheriff request authorization to accept the FY18 State Homeland Security Program (SHSP) grant funding in the amount of \$114,967 from the US Department of Homeland Security, Federal Emergency Management Agency (FEMA); administered by the NYS Division of Homeland Security and Emergency Services (DHSES), and

**WHEREAS**, Grant funding priorities have been identified as the advancement of regional partnerships to build on capabilities, development of citizen preparedness efforts, development of cyber security programs and policies; law enforcement information-sharing capabilities, emergency management planning efforts and sustainment of effective programs and existing capabilities, and

**WHEREAS**, 25% of the total grant award or \$28,742 must be utilized for law enforcement terrorism prevention activities, and

**WHEREAS,** The Committee on Public Service did review this request and does concur. Now therefore be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the Agreement with the New York State Division of Homeland Security and Emergency Services, 1220 Washington Avenue, Albany, NY for the acceptance of FY18 State Homeland Security Program (SHSP) funds in the amount of \$114,967 and to execute any and all other documentation related to this funding, and

**Budget Impact Statement** No County cost. Grant funds in the amount of \$28,742 will be appropriated in the 2019 Genesee County Sheriff budget. SHSP funds in the amount of \$86,225 will be appropriated in 2019 & 2020 EMO operating budget.

Legislator Hilchey seconded the resolution which passed by 326 votes.

RESOLUTION NO. 309 GRANT ACCEPTANCE - EMERGENCY MANAGEMENT SERVICES - FY17 HAZ MAT GRANT-FUNDS – APPROVAL OF

Legislator Hilchey offered the following resolution:

WHEREAS, The Emergency Management Services Coordinator did request authorization to accept the FY17 HazMat grant funds in the amount of \$196,000 from the U.S. Department of Homeland Security Program, Federal Emergency Management Agency (FEMA), administered by The New York State Division of Homeland Security and Emergency Services (DHSES); in conjunction with Monroe, Livingston, Orleans, and Wyoming Counties, and the City of Rochester, and

**WHEREAS**, Grant funds have been allocated for the sustainment of WMD trailers assigned to the Counties within the grant partnership; personal protection equipment; detection, mitigation and deacon equipment; the maintenance, repair and calibration of hazmat equipment in addition to the training of response personnel from the regional partnership, and

**WHEREAS,** The Committee on Public Service does concur with the Emergency Management Service Coordinator's recommendation. Now therefore be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the Agreement with New York State Division of Homeland Security and Emergency Services, 1220 Washington Avenue, Albany, NY for the acceptance of FY17 HazMat Grant Program (August 1, 2018 through August 31, 2020) in the amount of \$196,000, and to execute any and all other documentation related to this funding.

**Budget Impact Statement:** NONE. A portion of the FY17 HazMat grant funds will be appropriated in the 2019 Emergency Management Services (EMS) budget, offset by revenue in like amount.

Legislator Deleo seconded the Resolution which passed by 326 votes.

### RESOLUTION NO. 310 CONTRACT FOR GRANTS NO. C000718 AMENDMENT-PUBLIC DEFENDER-APPROVAL OF

Legislator Clattenburg offered the following resolution:

**WHEREAS,** The Public Defender does recommend the acceptance of a contract for grants amendment between the Genesee County Public Defender's Office and the New York State Office of Indigent Legal Services, Contract No.: C000718, Distribution No. 5, to extend the original contract term for one (1) year period of January 1, 2018 to December 31, 2018.

**WHEREAS**, the Public Service Committee did review the contract for grants amendment and does recommend acceptance at this time. Now, therefore, Be it

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the contract for grants amendment Contract No. C000718, Distribution No. 5, to extend the original contract term for one (1) year period of January 1, 2018 to December 31, 2018, and it be further

**Budget Impact:** The contract for grants extension will have no effect on the budget. Legislator Maha seconded the Resolution which passed by 326 votes.

## RESOLUTION NO. 311 GRANT ACCEPTANCE/BUDGET AMENDMENT/SHERIFF - POLICE TRAFFIC SERVICES PROGRAM - APPROVAL OF

Legislator Maha offered the following resolution:

**WHEREAS**, the Sheriff requested authorization to accept grant funding from the NYS Governor's Traffic Safety Committee, in the amount of \$27,030 to participate in the statewide Police Traffic Services Program, for the time period of October 1, 2018 through September 30, 2019, and

**WHEREAS**, the Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it

**RESOLVED**, That the Genesee County Treasurer is hereby authorized and directed to amend the 2018 budget by increasing Sheriff's account A3110.1020.0700 (Overtime – STEP) in the amount of \$27,030, to be offset by an increase in revenue account A3110.4511 (Federal Aid Traffic Safety) in a like amount.

**Budget Impact:** Increase in Sheriff's 2018 appropriations in the amount of \$27,030 from a NYS GTSC Police Traffic Services Program Grant Award; offset by an increase in revenue in a like amount.

Legislator Deleo seconded the Resolution which passed by 326 votes.

**WHEREAS**, The Sheriff's Office will be purchasing body armor for Sheriff's Deputies and Correction Officers at a total cost of \$25,833, and

**WHEREAS,** Funding in the amount of \$11,003 will be provided through the Office of Justice Bulletproof Vest Program, and \$10,730 will be transferred from funds available in the T83 Trust Account (Uniform Vests), with the balance of \$4,100 for this purchase to be paid from individual uniform allowances, and

**WHEREAS**, The Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it,

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to amend the 2018 budget as follows:

Increase Sheriff's Account A3110.4580.0000 (Personal Uniforms) in the amount of \$10,055; To be offset by an increase of \$4,311 to Sheriff's Revenue Account A3110.4515 (Federal Aid Bulletproof Vests), and an increase of \$5,744 to Sheriff's Revenue Account A3110.2831 (Contributions From Other Funds) to be transferred from the T83 Trust Account-Uniform Vests. Increase Jail Account A3150.4580.0000 (Personal Uniforms) in the amount of \$11,678; To be offset by an increase of \$6,692 to Jail Revenue Account A3150.4515 (Federal Aid Bulletproof Vests), and an increase of \$4,986 to Jail Revenue Account A3150.2831 (Contributions From Other Funds) to be transferred from the T83 Trust Account-Uniform Vests. **Budget Impact:** Increase in Sheriff's 2018 appropriation in the amount of \$10,055, for the purchase of body armor, offset by an increase in revenue in a like amount, with funds provided by the OJP Bulletproof Vest Program, and a transfer from the T83 Trust Account-Uniform Vests. ## RESOLUTION NO. 313 BUDGET TRANSFER/SHERIFF – VEHICLE FUEL, VEHICLE MAINTENANCE AND REPAIR – APPROVAL OF

Legislator Dibble offered the following resolution:

Legislator Dibble seconded the Resolution which passed by 326 votes.

**WHEREAS**, There are two line items in the Sheriff's Contractual Services budget that are in need of funds – Vehicle Fuel, and Vehicle Maintenance and Repair, and

**WHEREAS,** There are funds available in the Sheriff's Personnel Services budget to transfer to cover these shortages, and

**WHEREAS**, the Committees on Public Service and Ways and Means did review this request and do recommend approval at this time. Now therefore be it

**RESOLVED**, That the Genesee County Treasurer is hereby authorized and directed to make the following budget transfers:

\$30,500 from A3110.1010.0000 (Personal Services); \$20,500 from A3110.1060.0100 (Special Pay-Holiday)

\$22,000 to A3110.4310.0000 (Vehicle Fuel); \$29,000 to A3110.4340.0000 (Vehicle Maintenance and Repair)

**Budget Impact:** There is no budget impact as funds are being transferred within the Sheriff's 2018 budget.

## RESOLUTION NO. 314 ACCEPTANCE OF GRANT FUNDS / SHERIFF - COMMUNICATIONS – PUBLIC SAFETY ANSWERING POINT (PSAP) OPERATIONS GRANT - APPROVAL OF

Legislator Stein offered the following resolution:

**WHEREAS,** The New York State Division of Homeland Security and Emergency Services Office of Interoperable and Emergency Communications (NYS DHSES/OIEC) has awarded Genesee County grant funding in the amount of \$204,071 from the Public Safety Answering Point (PSAP) Operations Grant, and

**WHEREAS,** These funds will be used to offset a portion of the 2019 Communications budget in a like amount, and

**WHEREAS**, The Genesee County Sheriff and the Director of Emergency Communications recommend the acceptance of such grant funds, and

**WHEREAS,** The Committee on Public Service did review this request and does recommend approval at this time. Now therefore be it

**RESOLVED,** That the Chair of the Legislature is hereby authorized and directed to accept the Division of Homeland Security and Emergency Services Office of Interoperable and Emergency Communications Public Safety Answering Point (PSAP) Operations Grant in the amount of \$204,071.

**Budget Impact:** None. The grant funds will be incorporated into the 2019 Communications budget submission.

Legislator Maha seconded the Resolution which passed by 326 votes.

## RESOLUTION NO. 315 INTERMUNICIPAL AGREEMENT – SHERIFF / MONROE COUNTY DEPARTMENT OF PUBLIC SAFETY CRIME LABORATORY – APPROVAL OF

Legislator Torrey offered the following resolution:

**WHEREAS**, the Sheriff did present an agreement for forensic laboratory services with Monroe County, and

**WHEREAS**, the forensic laboratory, as of May 1, 2018, no longer provides *Driving Under the Influence* drug testing of blood samples and alcohol testing, which resulted in a decrease of the initial budgeted amount of \$122,224 to \$120,366.11, and

**WHEREAS**, after careful review by the Sheriff and County Attorney, it is recommended the County Legislature approve this contract for the period of January 1, 2018, through December 31, 2018, and

**WHEREAS**, the Committee on Public Service did review this agreement and does recommend approval at this time. Now, therefore, be it

**RESOLVED**, that the Chair of the Genesee County Legislature is authorized and directed to execute the agreement between the County of Genesee and the County of Monroe for forensic

laboratory services for the period of January 1, 2018, through December 31, 2018, at a cost of \$120,366.11.

**Budget Impact:** Appropriation of \$122,224 was included in the 2018 Sheriff's budget for this contracted service.

Legislator Stein seconded the Resolution which passed by 326 votes.

**WHEREAS,** reimbursement from Pembroke, Alexander and Pavilion Central School Districts will include the hourly rate for a Grade 12/Step 1 Deputy Sheriff plus all fringe benefits as follows:

Pembroke and Alexander 10-month period 9/1/18 - 6/30/19 \$80,533.09 \* Pavilion 12-month period 7/1/18 - 6/30/19 \$96,716.09 \*

**WHEREAS**, the Sheriff has requested to create three (3) new Deputy Sheriff positions to fill the void on Road Patrol as a result of the creation of three (3) SRO positions for the Pembroke, Alexander and Pavilion Central School Districts, and

**WHEREAS**, the Sheriff has requested a 2018 budget amendment for these new Deputy Sheriff positions for the time period of August 1, 2018, through December 31, 2018, increasing Sheriff's appropriations in the amount of \$102,154, to be offset by an increase in Sheriff's revenue by a like amount, and

**WHEREAS**, the Committee of Ways & Means did review these requests and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Chair of the Genesee County Legislature and the Genesee County Sheriff are hereby authorized and directed to execute the Pembroke, Alexander and Pavilion School Resource Officer MOUs for periods and estimated costs listed above, and be it

**RESOLVED,** that the Genesee County Legislature is authorized and directed to amend the 2018 Employee Salary Schedule by creating three (3) new Deputy Sheriff positions in order to fill the void on Road Patrol resulting from the three (3) new School Resource Officer positions for a period **effective August 1, 2018,** and be it

**RESOLVED,** that the Genesee County Treasurer is hereby authorized and directed to amend the 2018 budget as follows:

Increase is for the 2018 portion of the salaries for three (3) new Deputy Sheriff positions created to fill a void in Road Patrol due to the addition of three (3) new SRO positions.

### RESOLUTION NO. 317 APPOINTMENT – SHERIFF / TRAFFIC SAFETY BOARD – APPROVAL OF

Legislator Dibble offered the following resolution:

**WHEREAS**, there is a vacancy that exists on the Genesee County Traffic Safety Board for a representative of Public Transportation, and

**WHEREAS**, Town of Batavia Highway Superintendent Thomas Lichtenthal has expressed interest in being appointed to fill this vacancy and has submitted an application that Traffic Safety Board members have reviewed, and

**WHEREAS**, as Chairman of the Traffic Safety Board, Sheriff Sheron is recommending this appointment. Now, therefore, be it

**RESOLVED**, that the above three-year appointment (10/1/18-9/30/21) of Town of Batavia Highway Superintendent Thomas Lichtenthal to the Genesee County Traffic Safety Board be approved at this time.

**Budget Impact: None.**

### RESOLUTION NO. 318 CONTRACT RENEWAL – SHERIFF /NEW YORK STATE UNIFIED COURT SYSTEM - APPROVAL OF

Legislator Maha offered the following resolution:

WHEREAS, The renewal contract between the County of Genesee and the New York State Unified Court System for security services at the Genesee County Courts Facility was adopted on November 24, 2014, pursuant to Resolution No. 431 (copy attached) and was for a five-year period commencing April 1, 2014 through March 31, 2019 (divided into annual periods, approved each year), and

WHEREAS, the Genesee County Sheriff did present a contract renewal with the New York State Unified Court System for the fifth renewal period (fiscal year 2018-2019) of the agreement which is April 1, 2018, through March 31, 2019, with the maximum monetary reimbursement amount not to exceed \$723.061, and

**WHEREAS**, the Committee on Public Service did review this contract renewal and does recommend renewal at this time. Now, therefore, be it

**RESOLVED,** that the Chair of the Genesee County Legislature is hereby authorized and directed to execute the contract renewal between the County of Genesee and the New York State Unified Court System for the provisions of security services at the Genesee County Courts facility for the fifth renewal period of April 1, 2018, through March 31, 2019, at a cost not to exceed \$723,061.

**Budget Impact**: Costs for security services at the Courts Facility are offset by revenue from the New York State Unified Court System.

Legislator Dibble seconded the Resolution which passed by 326 votes.

## RESOLUTION NO. 319 CONTRACT – SHERIFF/ORLEANS COUNTY PRISONER HOUSING-APPROVAL OF

Legislator Torrey offered the following resolution:

**WHEREAS**, the Sheriff did present a prisoner housing contract with Orleans County Jail, and **WHEREAS**, the County Attorney has reviewed and approved the terms of this Contract, and

**WHEREAS**, the Committee on Public Service did review this contract renewal and does recommend approval at this time. Now, therefore, be it

**RESOLVED**, that the Chair of the Genesee County Legislature and the Genesee County Sheriff are authorized and directed to execute the contract between the County of Genesee and the County of Orleans for the provision of Jail space in the Orleans County Jail at a rate of \$80.00 per day for each prisoner housed between the date of the contract's execution through December 31, 2020.

**Budget Impact:** Funds have been appropriated to the 2018 budget.

Legislator Clattenburg seconded the Resolution which passed by 326 votes.

## RESOLUTION NO. 320 RENTAL AGREEMENT RENEWAL- JUSTICE FOR CHILDREN ADVOCACY CENTER/ALBION - APPROVAL OF

Legislator Clattenburg offered the following resolution:

**WHEREAS,** The Genesee County Legislature did approve the acceptance of funding from the New York State Office of Children and Family Services in the amount of \$100,000.00 for the grant year running from 10/1/18 to 9/30/19; and

**WHEREAS,** Included in the acceptance of the 2018-19 NYS Office of Children and Family Services is funding for a lease agreement for a satellite office in Albion; and

**WHEREAS**, The office space in Albion is located in the Arnold Gregory Complex at 243 South Main Street, Albion, New York, 14411 and is managed by the DeGeorge Property Group; and

**WHEREAS**, The agreed upon rate per month is \$1016.00, including heat, water, and electric utilities; and

**WHEREAS**, The landlord has offered a discount of \$366.00 if payment for the year is provided at the time of lease renewal; and

**WHEREAS,** The lease with the DeGeorge Acquisition Group, LLC will be for a period of one year, to commence on October 15, 2018; and

**WHEREAS**, The Committee on Public Service did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** That the Chair of the Genesee County Legislature and the Genesee County Sheriff are authorized and directed to enter into a lease agreement renewal, to be paid in full at the beginning of the lease, with DeGeorge Acquisition Group, LLC, 1067 Gateway Drive, Farmington, New York 14425 for the rental of the office located at 243 South Main Street, Suite 156, Albion, New York 14411 effective October 15, 2018 through October 15, 2019.

**Budget Impact:** Appropriations to the Justice for Children Advocacy Center budget are offset by revenue from the NYS Office of Children and Family Services. Funds for this lease agreement are fully covered by grants from the NYS Office of Children and Family Services and are included in the 2018 and 2019 Justice for Children Advocacy Center budget. Legislator Deleo seconded the Resolution which passed by 326 votes.

## RESOLUTION NO. 321 DOYLE SECURITY SERVICE AGREEMENT – JUSTICE FOR CHILDREN ADVOCACY CENTER – APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, The Genesee County Legislature did approve the acceptance of funding from the New York State Office of Children and Family Services in the amount of \$100,000.00 for the grant year running from 10/1/18 to 9/30/19, and

**WHEREAS**, Included in the acceptance of the 2018-19 NYS Office of Children and Family Services grant are funding to establish two satellite offices, one in Albion and one in Warsaw, and

**WHEREAS**, The Justice for Children Program Coordinator has requested permission to enter into a contract with Doyle Security to provide security monitoring to offices at 243 South Main Street in Albion and 31 Duncan Street in Warsaw, and

**WHEREAS,** The agreed upon rate for installation in Albion is \$733.00 with a monthly monitoring fee of \$32.00. The cost for installation in Warsaw is \$813.00 with a monthly monitoring fee of \$32.00. The total expenditure will be \$1,546 for installation and \$64.00 per month for monitoring for both offices, and

**WHEREAS**, The Committees on Public Service and Ways and Means did review this request and does recommend approval at this time. Now, therefore, be it
