NINETEENTH DAY GENESEE COUNTY LEGISLATURE Batavia, NY Wednesday, October 25, 2017

The Genesee County Legislature met in Regular Session on Wednesday, October 25, 2017 at 5:30PM at the Old Courthouse, 7 Main Street, Batavia, New York. Legislator Torrey assisted with the audit. Prayer was offered by Legislator Clattenburg followed by the Pledge to the Flag.

Minutes of the October 11, 2017 Legislature meeting were approved upon motion of Legislator Clattenburg seconded by Legislator DeJaneiro, carried unanimously.

Legislator DeJaneiro reported that he attended the GAM meeting where there was a presentation by MEGA. He also reported on the volume of CRT TV's and florescent light bulbs taken in at the last GLOW Solid waste recycling event.

County Manager Jay Gsell shared an update on county meetings with municipalities regarding the new re-drafted water agreement. They just met with the Town & Village of Bergen yesterday and have a few more scheduled meetings where questions and comments are able to be addressed and answered. He stated that the Comptroller approved the amendment to the existing agreement. The amendment extended the end date of the Sales Tax Agreement from February 2018 to December 2018. Mr. Gsell also related that Leadership Genesee class of 2017 had their Government Focus day where Senator Ranzenhofer, Assemblyman Hawley and he had an opportunity to present and interact with class members. They also toured the County EMS Fire Training Center and met with EMS Director Tim Yaeger.

The Clerk proceeded with the resolutions:

RESOLUTION NO. 376 AWARD OF BID/SHERIFF'S OFFICE – PATROL RIFLE OPTICS AND FLASHLIGHTS

Legislator Davis offered the following resolution:

WHEREAS, Three bids were received for the purchase of patrol rifle optics and flashlights, and **WHEREAS**, The lowest bid for the patrol rifle optic, and the streamlight flashlight, meeting specifications, was submitted by Clyde Armory, 4800 Atlanta Highway, Atlanta, GA 30606, for a total amount of \$13,420.80, and

WHEREAS, \$13,555 has been appropriated to the 2017 asset acquisitions for the purchase of patrol rifle optics and flashlights, and

WHEREAS, The Sheriff is recommending that the award of bid for the patrol rifle optics and flashlights be made to Clyde Armory, and

WHEREAS, The Committee on Public Service did review this request and does recommend approval at this time. Now therefore be it

WHEREAS, The agreement imposes a \$75.00 per month generator fee for the term of the contract designated to the Genesee County Highway Department Shared Services Account, and

WHEREAS, The Sheriff, Director of Emergency Communications, and County Attorney recommend a lease amendment be approved for a cost the period of November 1, 2017, to October 31, 2020, and

WHEREAS, The Committee on Public Service did review this request and do recommend approval at this time. Now therefore be it

RESOLVED, That the Chair of the Legislature is hereby authorized and directed to enter into a site lease agreement with Lloyd Lane, Inc., 3258 Merchant Road, Warsaw, NY 14569, for the lease of space on the Genesee County telecommunications tower located at 153 Cedar Street, Batavia, NY for a period beginning November 1, 2017, ending October 31, 2020. **Budget Impact:** None.

WHEREAS, Genesee and Orleans County are creating a multi-county public safety radio system pursuant to the New York Statewide Interoperable Communications Grant program, and **WHEREAS,** Tim Warth, dba Radio Technologies, has been the primary programmer for the Genesee County P25 System since its inception in 2013, and

WHEREAS, Orleans County has hired Tim Warth, dba Radio Technologies, for its portion of the subscriber radio programming, and

WHEREAS, The Genesee County Sheriff, Emergency Management Coordinator, and Director of Emergency Communication recommend approval of the professional services quote by Tim Warth, dba Radio Technologies, at a cost not to exceed \$61,045, and

WHEREAS, The Committees on Public Service and Ways & Means did review this request and do recommend approval at this time. Now therefore be it

RESOLVED, That the Chair of the Legislature is hereby authorized and directed to approve of the professional services quote by Tim Warth, dba Radio Technologies, 15 Pamda Drive, Rochester, NY 14617, at a cost not to exceed \$61,045, to be offset by revenue from the NY Statewide Interoperable Communications Round 4 Grant. Be it further

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to amend the 2017 budget by increasing Sheriff's Communications appropriations as follows:

\$61,045 to A3020.4660.SICG (Contracted Other–SICG), offset by an increase in revenue account A3020.3390.SICG (State Aid-SICG) in a like amount.

Budget Impact: Increase in Sheriff's Communications appropriations in the amount of \$61,045, to be offset by an increase in revenue in a like amount, with funds to come from NYS Statewide Interoperable Communications Grant funding.

WHEREAS, the current agreement is due to expire on December 31, 2017, and

WHEREAS, the Sheriff does recommend renewing this contract for an additional one-year period to commence January 1, 2018, and continue through December 31, 2018, and **WHEREAS**, the Committee on Public Service did review this request and does recommend

approval at this time. Now, therefore, be it

RESOLVED, that the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a renewal agreement with United Uniform Distribution, LLC, 495 North French Road; Buffalo, New York 14228, for the provision of uniforms and accessories for the Sheriff's Office, including Correction Officers.

BUDGET IMPACT: Uniforms are purchased with funds from the personnel uniform account, pursuant to the Collective Bargaining Agreement. Amount budgeted for 2018 is \$87,730, which includes Law Enforcement, Jail, Communications, Animal Control and Juvenile divisions.

WHEREAS, The Enterprise Fleet Management contract includes vehicle telematics and GPS tracking for vehicles, and

WHEREAS, Vehicle telematics and GPS tracking services are provided by Sprint which has separate legal terms, and

WHEREAS, The County Attorney reviewed these contracts and does recommend approval at this time, and

WHEREAS, The Public Service Committee did review this request and does concur at this time. Now, therefore, Be it,

RESOLVED, That the Genesee County Legislature does hereby authorize and direct the Chairperson of the Legislature to execute agreements with Enterprise Fleet Management and Sprint Solutions, Inc for the purpose of providing vehicle telematics and GPS tracking of the privatized motor pool fleet.

Budget Impact: One-time installation cost per vehicle of \$49 and recurring monthly charges of \$24. Total county cost for fleet telematics and tracking is \$11,121 per year which is over \$3,000 less than the current provider. Legislator Bausch offered the following resolution:

WHEREAS, The State of New York and the Federal Government Medicaid Program have agreed to re-institute the Inter-Governmental Transfer (IGT) Program to assist public nursing homes through their financial crisis, and

WHEREAS, New York State and the federal Medicaid Program is allowing county owned nursing homes to recapture IGT for 2016 in the amount of \$5,125,013 on October 27, 2017 with the requirement of Genesee County having a 50% match (\$2,562,506.50), and

WHEREAS, The Genesee County Treasurer recommends the use of the IGT-Reserve to maximize the IGT payment and

WHEREAS, The Committee on Ways and Means concurs, Now, therefore Be it **RESOLVED**, That the Genesee County Treasurer is hereby authorized and directed to amend the 2017 budget by Increasing Appropriation A.6100.4800.0000 MMIS in the amount of \$2,562,507 and Increasing Revenue A.1000.9999 Balancing in a like amount utilizing the IGT-Reserve.

Budget Impact: An increase in expenditures of \$2,562,506.50 in the General Fund and increase in revenue to the General Fund Nursing Home Revenue of \$5,125,013.

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a contract between the Genesee County Self-Insurance Plan and Key Insurance & Benefits Services for third party administration services for the periods 1/1/18 - 12/31/18 for \$47,400, 1/1/19 - 12/31/19 for \$48,720 and 1/1/20 - 12/31/20 for \$49,800 with the option to renew for two additional one year terms upon mutual written consent.

Budget Impact: Funds for this service have been provided in the Self-Insurance budget and apportioned to the participants.
