#### TWENTY-FIRST DAY GENESEE COUNTY LEGISLATURE Batavia, NY Monday, November 20, 2017

The Genesee County Legislature met in Regular Session on Monday, November 20, 2017 at 5:30PM at the Old Courthouse, 7 Main Street, Batavia, New York. Legislator Young assisted with the audit. Prayer was offered by Legislator Bausch followed by the Pledge to the Flag.

The minutes of the November 8, 2017 Legislature Meeting were approved upon motion of Legislator Clattenburg seconded by Legislator Stein, carried unanimously.

Legislator Stein reported the County received notice from NYS Ag & Markets that they approved the County's Ag & Farmland Protection plan. We can now be reimbursed for the grant dollars we asked for. Inter County Association met on November 17 where Richard Tobe from the Governor's office provided a Shared Services update. They identified the top dollar initiatives where money can be saved; Health Insurance consortium and justice courts. Also discussed was the number of counties suing the Opioid pharmaceutical manufactures-37. Legislator DeJaneiro reported that he attended the GAM meeting in Oakfield and the new president of GAM will be Tom Dix, a councilman from Pembroke and Joe Higley from Alexander will be the vice president.

Legislator Bausch commented that he was present for the counting of absentee ballots by the elections department. He stated that staff conducted themselves in a very professional and thorough manner. Legislator Stein provided a summary of her attendance at the Tax Reform discussion at the White House. She was invited and attended with several other NYS County legislators and supervisors. NACo provided a pre-meeting briefing then participants went to the White House where several high level officials stopped in, including VP Pence. She emphasized the 2-way conversation and how contact information was freely distributed. The tax reform vote occurred that afternoon while the meeting was being conducted.

County Manger Jay Gsell stated that Genesee County is a member of NACO and they have their annual conference in March where delegates can weigh in and participate in votes. He also explained that Congressman Collins was in the county to visit with Job Development leaders to get an overview of programs and needs.

The Clerk proceeded with the resolutions:

### RESOLUTION NO. 413 2017 BUDGET AMENDMENT - DISTRICT ATTORNEY/OFFICE FURNITURE-APPROVAL OF

Legislator Torrey offered the following resolution:

**WHEREAS**, the District Attorney has requested an amendment to the 2017 County Budget to allow for the utilization of a portion these unexpended funds in the amount of \$1,488.00 and the Committees on Public Service and Ways & Means concur. Now, therefore, Be it **RESOLVED**, That the Genesee County Treasurer is hereby authorized and directed to amend the 2017 Genesee County Budget by increasing District Attorney Appropriation A.1165.2010.0021 Tables/Tubs/Totes in the amount of \$560.00, A.1165.2010.0020 Desk in the amount of \$475.00 and A.1165.2010.0022 Chairs in the amount of \$453.00 to be offset by an increase in District Attorney Revenue A1165.2626 Forfeiture of Crimes in the amount of \$1,488.00.

**Budget Impact Statement:** Increased expense for the District Attorney's 2017 budget of \$1,488 which is totally offset by using funds allocated for the District Attorney's Office in a Forfeiture of Crimes proceeds.

Legislator Clattenburg seconded the resolution which was adopted by 326 votes.

#### **RESOLUTION NO. 414**

#### 2017 DONATION ACCEPTANCE/BUDGET AMENDMENT-GENESEE JUSTICE-FOUNDATION DONATION FOR TRAINING AND COMPUTER EQUIPMENT-APPROVAL OF

Legislator Deleo offered the following resolution:

**WHEREAS**, The Genesee Justice Program Coordinator has made a request to amend the 2017 Genesee Justice budget in order to accommodate revenue associated with a recent Genesee Justice Foundation donation, and

**WHEREAS**, The Committees on Public Service and Ways & Means did review this request and do recommend acceptance of the donation and budget amendment at this time. Now, therefore, Be it

**RESOLVED** that the Genesee County Treasurer is hereby authorized and directed to make the following budget item amendments to the 2017 Genesee Justice Budget as follows:

- Increase revenue:
  - \$1,000.00 in line A.3151.2705 Gifts and Donations
- Increase expense line items:
  - o \$419 in line A.3151 2026.0035 Computer Accessories
  - \$581 in line A.3151 4550.0000 Personnel Training

**Budget Impact**: Appropriations to the 2017 Genesee Justice budget are offset by revenue from the Genesee Justice Foundation. No county funding is affected by this amendment.

Legislator DeJaneiro seconded the resolution which was adopted by 326 votes.

### RESOLUTION NO. 415 BUDGET AMENDMENT-SHERIFF/SALE OF POLICE PATROL VEHICLE

Legislator Davis offered the following resolution:

**WHEREAS**, Per resolution #231, dated June 29, 2017, the award of bid for the purchase of five law enforcement vehicles, as well as the authorization to trade-in four vehicles, was made to Beyer Ford, and

**WHEREAS**, The LeRoy Police Department has requested to purchase one of the vehicles earmarked as a trade-in vehicle, and will pay a purchase price of \$4,250, which is equal to the amount that was to be given as a trade-in value from Beyer Ford, and

**WHEREAS**, Beyer Ford has agreed to forgo the vehicle for trade-in and increase the purchase price of the five new vehicles by \$4,250, and

WHEREAS, The Sheriff is requesting permission to sell car #88, VIN

#1FM5K8AR2DGC73204, a 2013 Ford Interceptor Utility, to the LeRoy Police Department for \$4,250, and

**WHEREAS,** The Committees on Public Service and Ways & Means did review this request and do recommend approval at this time. Now therefore be it

**RESOLVED**, That the LeRoy Police Department be allowed to purchase Sheriff's Office patrol vehicle #88 for a purchase price of \$4,250; and the Genesee County Treasurer is hereby authorized and directed to amend the 2017 budget by increasing A1989.2060.0000 (Asset Acquisition-Vehicles) by \$4,250, offset by an increase in revenue A1000.2665 (Sale of Equipment) in a like amount.

**Budget Impact:** Increase in 2017 Asset Acquisition-Vehicles in the amount of \$4,250 from the sale of a police patrol vehicle; to be offset by increase in revenue in a like amount.

Legislator Stein seconded the resolution which was adopted by 326 votes.

### RESOLUTION NO. 416 CONTRACT APPROVAL – SHERIFF / CATTARAUGUS COUNTY PRISONER HOUSING – APPROVAL OF

Legislator Torrey offered the following resolution:

**WHEREAS**, the Sheriff did present a prisoner housing contract with Cattaraugus County, and **WHEREAS**, the County Attorney has reviewed and approved the terms of this Contract, and **WHEREAS**, the Committee on Public Service did review this contract and does recommend approval at this time. Now, therefore, be it

**RESOLVED**, that the Chair of the Genesee County Legislature and the Genesee County Sheriff are authorized and directed to execute the contract between the County of Genesee and the County of Cattaraugus for the provision of Jail space in the Cattaraugus County Jail at a rate of \$85.00 per day for each prisoner housed beginning on the date of execution through December 31, 2022, automatically renewable on a year-to-year basis under the same rates, terms and conditions, if neither party requests renegotiation.

Budget Impact: Funds have been appropriated in the annual budget.

Legislator Deleo seconded the resolution which was adopted by 326 votes.

### RESOLUTION NO. 417 AWARD OF BID – SHERIFF'S OFFICE / JAIL PHARMACY SERVICES – APPROVAL OF

Legislator Bausch offered the following resolution:

**WHEREAS,** the current agreement with Omnicare of New York, LLC (dba Omnicare of Rochester), 175 Humboldt Street, Suite 225, Rochester, NY 14610, for the pharmacy services provided to the Genesee County Jail expires December 31, 2017, and

**WHEREAS** Genesee County issued BID 2017-115 for pharmacy services at the Jail, and three proposals were received, and

**WHEREAS,** after careful review by the Genesee County Sheriff, County Treasurer, County Manager and Jail Superintendent, it was determined that Omnicare of Rochester provided the best combination of competitive pricing and services, and

**WHEREAS,** the Committee on Public Service did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary documents to award the bid for Jail pharmacy services to Omnicare of Rochester, 175 Humboldt Street, Suite 225, Rochester, NY 14610, for a cost not to exceed \$120,000, and for the period of January 1, 2018, through December 31, 2020, with the option to renew for three (3) additional one-year periods upon written agreement between both parties under the same terms and conditions as the original Agreement.

BUDGET IMPACT: Pharmacy costs have been budgeted for in the 2018 budget.

Legislator Davis seconded the resolution which was adopted by 326 votes.

# RESOLUTION NO. 418 BUDGET AMENDMENT/AWARD OF CONTRACT-HIGHWAY/DUDE SOLUTIONS-FACILITY MAINTENANCE AND HIGHWAY WORK ORDER SYSTEM-APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, The Genesee County Highway Superintendent has been investigating automated and on-line work order systems for several years, and

**WHEREAS**, The addition of an online work order system would greatly increase the productivity and management of work performed by the Highway Department, Central Services and Facility Maintenance Departments, and

WHEREAS, An online work order system is available on NJPA contract and was researched

and demonstrated by the Highway Department and Central Services staff and found to be beneficial and easy to use, and

**WHEREAS,** The Genesee County Highway Superintendent recommends awarding a contract to establish an online work order system for the County, and

WHEREAS, The Committees on Public Service and Ways & Means have reviewed this recommendation and odes concur at this time. Now, therefore, Be it

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to make the following budget amendment:

Increase A.4530.1689 Other Income – Nursing Home in the amount of \$30,414.50; increase A.9950.9 Transfers to Capital in the amount of \$30,414.50; increase H.5197.5031 Interfund Transfers in the amount of \$30,414.50 and Increase H.5197.2080 Capital Expense in the amount of \$30,414.50

**RESOLVED,** That the Genesee County Treasurer is hereby authorized and directed to establish a Capital Project Highway Work Order System in the amount of \$30,414.50.

**Budget Impact:** The cost of the Maintenance Edge and Capital Forecast software license and one-time startup costs is \$11,971.20 and will be funded from A1680.4410.0095. The cost of the Mobile 311 software license and one-time startup cost is \$30,414.50 and will be funded from a capital project established using the universal settlement funds from the Genesee County Nursing Home. The annual renewal on the Maintenance Edge and Capital Forecast software license (1/1/2019-12/31/2019) is \$7,440.40. The annual renewal on the Mobile 311 software license (1/1/2019-12/31/2019) is \$13,252.10.

**WHEREAS**, Michael Ciociola submitted a completed application for reappointment to serve a full two-year term, and

**WHEREAS,** The Committees on Public Service and Ways and Means do recommend that a reappointment of the Sportsman seat on the board be made at this time. Now, therefore, Be it **RESOLVED,** That the Genesee County Legislature does hereby reappoint the following to serve a full two-year term on the Fish & Wildlife Management Board;

Legislator Stein seconded the resolution which was adopted by 326 votes.

## RESOLUTION NO. 420 AMENDED AND RESTATED AGREEMENT – MONROE COUNTY WATER AUTHORITY—COUNTYWIDE WATER PROJECT —APPROVAL OF

Legislator Stein offered the following resolution:

**WHEREAS**, Genesee County has requested modifications to the existing water operating agreement with the Monroe County Water Authority, and

**WHEREAS,** The several agreements that Genesee County has with the Monroe County Water Authority relative to the operation of the Countywide Water System have been consolidated into one restated and amended agreement, and

**WHEREAS**, The Genesee County Highway Superintendent and the County Attorney have reviewed this agreement and do recommend approval of the agreement at this time, and **WHEREAS**, The Committees on Public Service and Ways and Means have reviewed this request and do concur at this time, Now, therefore, be it

**RESOLVED,** The Genesee County Legislature hereby authorizes and directs the Chairperson of the Legislature to execute the Amended and Restated Water Operating Agreement between Genesee County and the Monroe County Water Authority at this time.

**Budget Impact:** There is no direct budget impact to the County by executing this agreement. The amended and restated agreement does give the County the flexibility it needs to move forward with planned water supply modifications.

Prior to the vote Legislator Young stated his concern that the County is committing millions of dollars and a quantity of water yet we don't have commitments from the people who will actually be using the water and that he plans to vote no on the resolution. Legislator Bausch thanked the County Manager and Highway Superintendent who worked with the County Attorney to ensure the agreement with MCWA was amended and worked out in a timely manner. Legislator Torrey seconded the resolution which was adopted by 279 votes, Young (47) no.

### RESOLUTION NO. 421 CONTRACT RENEWAL -GRANTS WRITING CONSULTANT SERVICES – APPROVAL OF

Legislator DeJaneiro offered the following resolution:

WHEREAS, RFQ 2015-301 was awarded to Labella Associates, DPC for Grant Writer Services for Genesee County for the period January 1, 2016 through December 31, 2017, with an option to renew the contract for three (3) additional one year periods, and

**WHEREAS**, The County Manager does recommend the renewal of this contract for the first one year term, which would continue the contract for the period January 1, 2018 through December 31, 2018, under the same terms and conditions as the original Agreement, and

**WHEREAS,** The Committee on Ways and Means has reviewed this recommendation and does concur. Now, therefore, Be it

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute an agreement with the firm of LaBella Associates, DPC, 300 State Street, Suite 201, Rochester, NY for grants writer consultant services for Genesee County at the rate of \$90 per hour of service for a total expenditure not to exceed of \$5,000 for grant preparation, facilitation and application services for the period January 1, 2018 through December 31, 2018. **Budget Impact Statement:** Annual appropriation allocation of \$5,000 has remained the same since fiscal year 2002. Legislator Bausch seconded the resolution which was adopted by 326 votes.

Prior to the vote, Legislator Young stated he thought all legislators were not afforded the opportunity to provide input to the budget before it was presented at the November 15, 2017 Ways & Means meeting. He further stated he did not approve of the politics of it and that he would not be party to it. Legislator Davis stated that he agreed with Legislator Young, further stating he thought there was a lack of communication and he took issue with how they got there, the process. He stated he would therefore be voting no on the resolution. Legislator Clattenburg stated that parliamentary procedure applies and there is an opportunity to offer amendments. Legislator Bausch stated there was discussion at the Ways & Means meeting where all who were present could offer comments. He apologized if that opportunity was not made clear to all legislators, not just Ways & Means Committee members. Legislator Young made reference to last year's budget meeting schedule and how he thought this year there was an effort to have fewer meetings this year. Chairman Cianfrini commented that there were multiple budget conference sessions and all proposed changes and updates were put out to all legislators. He further stated the \$10.07 figure was put out to legislators and there seemed to be agreement. There was no collusion nor was that figure pushed through. There were two meetings where the \$10.07 figure was discussed; November 1 and November 8. Chairman Cianfrini went on to commend Jay, the budget officer, Matt and Vicky as well as the department heads for their time and effort with this budget.

Legislator Clattenburg seconded the resolution which was adopted by 236 votes, Davis (43) and Young (47) no.

#### RESOLUTION NO. 423 2018 GENESEE COUNTY BUDGET - ADOPTION OF

Legislator Bausch offered the following resolution:

**WHEREAS**, A public hearing was held on the Tentative Budget for the year 2018 on Wednesday, November 8, 2017, at which time all interested persons were heard, and

**WHEREAS,** Amendments to the 2018 Tentative Budget have been presented and duly adopted by Resolution No. 422 on November 20, 2017, and

**WHEREAS**, The Committee on Ways and Means does recommend adoption at this time. Now, therefore be it

**RESOLVED,** That the 2018 Tentative Budget presented by the Budget Officer, as amended, be and hereby is adopted as the Budget for the County of Genesee for 2018 with a total amount to be raised by property tax of \$29,295,272 and a tax rate equivalent to \$10.07.
