TWENTY-SECOND DAY GENESEE COUNTY LEGISLATURE Batavia, NY Wednesday, December 13, 2017

The Genesee County Legislature met in Regular Session on Wednesday, December 13, 2017 at 5:30PM at the Old Courthouse, 7 Main Street, Batavia, New York. Legislator Stein assisted with the audit. Prayer was offered by Legislator Davis followed by the Pledge to the Flag.

In addition to our regular meeting Chairman Cianfrini opened a Public Hearing on Local Law Introductory No. 5, Year 2017, A Local Law in relation to the Salaries of County Officers of the County of Genesee, Elected or Appointed for a Fixed Term. All interested parties were invited to be heard.

Commendations were presented to retiring Legislators Cianfrini, Davis and DeJaneiro by Senator Mike Ranzenhofer, Assemblyman Steve Hawley and Congressman Collins representative George McNerney. Following the presentation of commendations, Mr. Richard Siebert and Mr. Michael Plitt presented a framed sketch of the Old Courthouse to each retiring legislator.

The minutes of the November 20, 2017 Legislature Meeting were approved upon motion of Legislator Clattenburg seconded by Legislator Stein, carried unanimously.

Legislator Bausch reported that he attended the CJAC meeting this morning where the Jail Needs Assessment Study was reviewed.

Chair Cianfrini thanked those present for coming to the reception held prior to this meeting. He has served as District #1 Legislator for a total of ten years, four as Chairman. Legislator DeJaneiro commented that he has served on the Legislature for 16 years after serving on City Council for ten. Legislator Davis stated he has learned a lot during his three years and appreciated the hard work and dedication of his colleagues. Legislators Clattenburg, Bausch and Young thanked them for their dedication and service.

WHEREAS, Genesee County is desirous of obtaining the services of the Monroe County Department of Public Health's Tuberculosis Control Program, and;

WHEREAS, The Director of Public Health did present a contract renewal for said services and the Committee on Human Services does concur. Now, therefore, Be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute a contract with Monroe County for Tuberculosis Consultative and Educational Services for the Genesee County Health Department for the term January 1, 2017 to December 31, 2017 at the following rates and not to exceed \$20,000 for the term of the contract: Flat fee of \$4,714.76 for Electronic Health Record Access, VPN Services, IT consultations and continuing education, Telemedicine access and for ongoing clinical support including policies and procedures, QA/QI and clinical education and staff development.
