SEVENTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, April 12, 2017

The Genesee County Legislature met in Regular Session on Wednesday, April 12, 2017 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Deleo assisted with the audit. Prayer was offered by Legislator Bausch followed by the Pledge to the Flag.

Chairman Cianfrini presented a proclamation for *National Public Safety Telecommunications Week* to Sheriff Sheron, Undersheriff Walker and several dispatchers and thanked them for the crucial work they do serving our community. Chairman Cianfrini presented a proclamation to County Manager Jay Gsell and Youth Bureau Director Jocelyn Sikorski for County Government Month, April 2017. Ms. Sikorski announced the Annual Family Night don in conjunction with County Government Month is scheduled for April 20th at County Building #2. Human Services Chair Shelley Stein presented a Proclamation to Reality Check youth Krysta Hansen and Ben Streeter for Kick Butts Day. Youth were thanked for their commitment to preventing other youth from starting smoking.

The minutes of the March 22, 2017 meeting were approved upon motion of Legislator Torrey seconded by Legislator Stein, carried unanimously.

Legislator Deleo reported he is aware of e-mail notices sent by NYS DMV directing residents in need of services to seek assistance from the State instead of local DMV offices. He also spoke of a recent news report of the 75th Anniversary of the Dolittle raid and how a local resident reportedly participated in that raid. He stated he would like to see a plaque or other memorial put up at the County Airport.

Legislator DeJaneiro reported on his attendance at the Health Board meeting where it was mentioned that Yellow Fever has been seen again. The Environmental staff is still pursuing information on mold in the Batavia Mall building. The GLOW Solid Waste Committee will host a collection in September and discussed the lack of City Vendors following proper protocol relative to recycling.

The Clerk reported an Out-of-State Travel Request: Bill Schutt, Emergency Management Services to Emmetsburg, MD for FEMA Emergency Management Institute Advance Training June 12-16, cost to County \$375, AND September 10-15 cost to County \$375. Motion to approve made by Legislator DeJaneiro seconded by Legislator Bausch carried unanimously.

County Manager Jay Gsell passed out a copy of his notes on the NYS enacted 2017/2018 Budget and the preliminary impact to Genesee County:

- Clean Water infrastructure funding \$2.5 billion some potential drinking water and septic tank replacement funding could be applied for here in Genesee County
- Community Colleges FTE aid + \$50 per FTE increase
- Human Services Foster Care cuts \$19.3 cut for counties reimbursement
- Judiciary no new last 2 salary increases for full time District Attorney funds from NYS.

- Indigent Defense December 2017 Hurrell- Harring settlement enhancements for 52 non-litigation counties was in new budget. 100% reimbursement for new standards cost increases statewide deadline to implement = 2023. Arraignment, representation and caseload caps would be funded.
- Expanded income eligibility guidelines from 150% of federal poverty level -> 250% not funded.
- Public Health Governor's proposals which would have reduced State funding to County Health Departments like ours <u>not</u> included.

WHEREAS, The 1989 "Genesee 2000" strategic planning process resulted in the formation of the Business Education Alliance as an adjunct of the Genesee County Chamber of Commerce, and

WHEREAS, The Business Education Alliance provides services and programs that promote the formation of partnerships among businesses and schools for the continuous improvement of education and employment readiness within Genesee County, and

WHEREAS, The County is desirous of supporting such a program, and

WHEREAS, The Committee on Human Services did review the agreement and does recommend approval at this time. Now, therefore, Be it

RESOLVED, That the Chair of the Genesee County Legislature be and hereby is authorized and

directed to execute an agreement by and between the County of Genesee and the Genesee County Chamber of Commerce, 8276 Park Road, Batavia, NY for the Business Education Alliance program during the contract term of January 1, 2017 through December 31, 2017 in the amount of \$3,107.00.

Legislator DeJaneiro offered the following resolution:

WHEREAS, The Genesee County Public Health Director has received notification from the New York State Department of Health that Genesee County's Early Intervention Administration contract has been awarded in the amount of \$25,681, and

WHEREAS, The Public Health Director has requested that the County accept this funding which stipulates that this revenue will be used to support the administration of the Early Intervention Program, and

WHEREAS, The Committee on Human Service did review this request and does recommend approval at this time. Now, therefore, Be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the Agreement with the New York State Department of Health for the acceptance of the Early Intervention Administration contract for the period October 1, 2016 through September 30, 2017 in the amount of \$25,681, and to execute any and all other documentation related to this funding.

Budget Impact: Revenue and expenses, in the amount of \$8,491, are appropriated in the 2016 Dept. 4059 – Early Intervention Budget; the remaining balance in the 2017 Dept. 4059 – Early Intervention Budget.

RESOLUTION NO. 125 CONTRACT RENEWAL – HEALTH DEPARTMENT/ TUBERCULOSIS CONSULTATIVE AND EDUCATIONAL SERVICES – APPROVAL OF

WHEREAS, New York State Public Health Law does specify the responsibility of Genesee County to ensure direct clinical services for Tuberculosis, and;

WHEREAS, Monroe County operates a Tuberculosis Control Program with consulting pulmonary and critical care physicians and Certified Infection Control Practitioners for providing comprehensive medical and nursing / case management consultative service under the statutory jurisdiction of the Department of Public Health, and;

WHEREAS, Genesee County is desirous of obtaining the services of the Monroe County Department of Public Health's Tuberculosis Control Program, and;

WHEREAS, The Director of Public Health did present a contract renewal for said services and the Committee on Human Services does concur. Now, therefore, Be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute a contract with Monroe County for Tuberculosis Consultative and Educational Services for the Genesee County Health Department for the term January 1, 2017 to December 31, 2017 at the following rates and not to exceed \$20,000 for the term of the contract:

Budget Impact Statement: Expenses related to this contract are eligible for full reimbursement under Article 6–State Aid Funding for General Public Health Works.

WHEREAS, the Committee on Human Services did review this request and does recommend approval at this time. Now, therefore, Be it

RESOLUTION NO. 130 APPROVAL OF 2017 CONTRACT MEMORANDUM OF UNDERSTANDING – OFA/CATHOLIC CHARITIES – WNY ALZHEIMER'S CAREGIVER PARTNERSHIP–APPROVAL OF

Legislator Davis offered the following resolution:

WHEREAS, The Director of the Office for the Aging did present a contract Memorandum of Understanding in the amount of \$114,999 for the period of January 1, 2017 – December 31,2017; and

WHEREAS, a Memorandum of Understanding (MOU) with the Catholic Charities of Buffalo (CCB) for the period of January 1, 2017 – December 31, 2017 outlines the relationship of Genesee County Office for the Aging (GCOFA) as the Community Based Organization in Genesee County to work with CCB, the Alzheimer's Association-Western New York Chapter, and Erie, Niagara, Wyoming, Cattaraugus, Chautauqua, and Allegany County Offices for the Aging to implement the Western New York Alzheimer's Caregiver Partnership (WNYACP); a seven county, multi-agency, five year (1/1/2016-12/31/2020 renewable annually), initiative funded by NY State Dept. of Health (NYSDOH) through an Alzheimer's Disease Caregiver Support Initiative grant awarded to the Catholic Charities of Buffalo; and

WHEREAS, The purpose of WNYACP is to decrease the burden of Alzheimer's Disease and other dementias on individuals, caregivers, and families by providing comprehensive and collaborative services to caregivers of persons with dementia in the form of in-home respite and added social adult day care respite, transportation access, a volunteer component, education programs for caregivers and professionals, caregiver wellness, joint enrichment activities, family and individual dementia consultation services, and technology; and

WHEREAS, CCB is the grant recipient and this MOU establishes the terms for which the GCOFA would receive funding to provide services; and

WHEREAS, the Committee on Human Services did review this request and do recommend approval of this MOU and budget amendment. Now, Therefore, Be it

RESOLVED, That the Chairman of the Genesee County Legislature is hereby authorized and directed to execute the necessary documents to enter into a MOU with Catholic Charities of Buffalo, 741 Delaware Avenue, Buffalo, NY 14209 not to exceed \$114,999 for the period January 1, 2017 – December 31, 2017.

Budget Impact: Neutral. Funds in the amount of \$114,999 are already included in the 2017 county budget. Legislator Torrey seconded the resolution which was adopted by 298 votes, Clattenburg (28) absent.

RESOLUTION NO. 131 AWARD OF CONTRACT – OFFICE FOR THE AGING REGISTERED DIETITIAN SERVICES – APPROVAL OF

WHEREAS, The Director of the Office for the Aging did present an award of contract established through RFP 2017-104 to Ellen E. Foster, Consultant Dietitian, 33 Willmont Street, Rochester, N.Y. 14609-3617 for the provision of Registered Dietitian Services for the Older Americans Act, NYS Office for the Aging, and other contractual Nutrition Programs operated by Genesee County Office for the Aging; and

WHEREAS, This is the 1st year of a five year contract with potential for 4 additional 1 year renewals for provision of Registered Dietitian Services including kitchen monitoring, meal site

monitoring, home delivered meal program monitoring, nutrition education, nutrition counseling, menu planning/analysis and administrative duties, as required and the Committee on Human Services does recommend approval at this time. Now, therefore, Be it

RESOLVED, That the Chairman of the Genesee County Legislature is hereby authorized and directed to execute the necessary document to award the contract with Ellen E. Foster, Consultant Dietitian for the provision of Title III C-1, Title III C-2, SNAP and other nutrition funded services provided through the Genesee County Office for the Aging for 8 hours of dietitian services per week at a rate of \$36 per hour, not to exceed \$14,976 annually, April 16, 2017 – March 31, 2018.

Budget Impact: Neutral. \$36 per hour for 8 hours of dietitian service per week, not to exceed \$14,976 annually, is already budgeted in the county 2017 Office for the Aging budget.

WHEREAS, The Genesee County Legislature has sold the Genesee County Nursing Home as of 12:01 AM on January 1, 2017; and

WHEREAS, The Genesee County Manager and County Treasurer have sought the advice of our current independent auditors of Freed Maxick & Battaglia for outstanding revenues and consultation work to close out the E Fund (Nursing Home Fund); and

WHEREAS, The Genesee County Treasurer has negotiated a consulting agreement in an amount not to exceed \$20,000.00 for those services; and

WHEREAS, The Committee on Ways and Means concurs; Now, therefore be it **RESOLVED**, The Genesee County Legislature hereby authorizes the Genesee County Treasurer to sign the Consulting Agreement with the firm of Freed, Maxick & Battaglia in an amount not to exceed \$20,000.00 to assist the county with outstanding nursing home revenues and to assist in closing the E Fund.

Budget Impact: Up to \$20,000.00 will be paid from the proceeds of the sale of the nursing home.

Legislator Stein commented on the importance of getting the funds closed out properly and doing it the right way even if it takes more time than what was initially expected.

Legislator Stein seconded the resolution which was adopted by 298 votes, Clattenburg (28) absent.

RESOLUTION NO. 135 AUTHORIZATION TO SIGN LICENSE AGREEMENT NEW YORK STATE DEPARTMENT OF LABOR – APPROVAL OF

RESOLUTION NO. 137 GRANT AWARD-GENESEE JUSTICE/NYS OFFICE OF VICTIM SERVICES

Legislator Davis offered the following resolution:

WHEREAS, The Genesee Justice Program Coordinator has been notified of a two year extension to an existing grant award from the New York State Office of Victim Services, and **WHEREAS,** The Genesee Justice Program Coordinator has requested the County accept this award in the amount of \$186,749.25 from the New York State Office of Victim Services, and **WHEREAS,** This award will be distributed in increments of \$91,543.75 during the grant year running from 10/1/17 to 9/30/18, and \$95,205.50 during the grant year running from 10/1/18 to 9/30/19, and

WHEREAS, This award represents a substantial increase over the 16-17 award, which was \$73,235.00, and

WHEREAS, Funds from this grant will enable Genesee Justice to meet the growing demand for the services in our county for victims, and

WHEREAS, The Committee on Ways and Means did review this request and does recommend acceptance of the grant funding at this time. Now, therefore, Be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary documents for acceptance of this grant funding for the period of October 1, 2017 through September 30, 2019 in the amount of \$186,749.25.

Budget Impact: The New York State Office of Victim Services funds direct victim services at Genesee Justice, including victim advocacy, home visits, court accompaniment, and referrals to additional resources as needed.
