# TWELVETH DAY GENESEE COUNTY LEGISLATURE

Batavia, New York

Wednesday, June 27, 2018

The Genesee County Legislature met in Regular Session on Wednesday, June 27, 2018 at 5:30PM at the Old Courthouse 7 Main Street, Batavia, New York. Legislator Clattenburg assisted with the audit. Prayer was offered by Legislator Clattenburg followed by the Pledge to the Flag.

In addition to our regular meeting Chairman Bausch opened a Public Hearing on the proposed budget for Genesee Community College for the fiscal year beginning September 1, 2018. All interested parties will be heard.

The minutes of the June 13, 2018 Legislature meeting were approved upon motion of Legislator Stein seconded by Legislator Maha, carried unanimously.

Legislator Stein reported that she attended GAM where discussion included the challenges of using the new electronic program for civil service. Towns and Villages have to report data and information to the County on a regular basis. There was also discussion of shared services and how municipalities and the County are discussing what will be most beneficial. Chairman Bausch commented that last Inter County Association meeting held at Darien Lake Theme Park was well attended. The Theme Park is the largest seasonal employer in the County with 3,200 seasonal staff. Occupancy at the Park hotel and sales at the Theme Park contribute to the increase in bed tax and sales tax for the County. Chairman Bausch also reported he is the new Chair for the Genesee Finger Lakes Regional Planning Council. Legislator Maha stated that he and Legislator Clattenburg attended the City Council presentation on a military grade armored vehicle which City and County law enforcement are interested in. Legislator Clattenburg thanked County Manager Jay Gsell for writing a letter to Senator Ranzenhofer requesting grant funds to allow the County and City to pursue installation of new water meters for City water customers. Legislator Clattenburg also commented on the need for a strong letter of support or resolution regarding collection of internet sales tax.

County Manager Jay Gsell reported that the County was the third highest contributor to the United Way Campaign this year. County Campaign Chairpersons Jocelyn Sikorski and Steve Zimmer attended the United Way wrap up meeting where the County was recognized and presented with a banner.

The Clerk proceeded with the resolutions:

#### RESOLUTION NO. 221 REAPPOINTMENT - GENESEE COUNTY PLANNING BOARD - APPROVAL OF

Legislator Young offered the following resolution:

WHEREAS, The term of office of Berney Staats on the Genesee County Planning Board has expired and he has indicated an interest and desire for reappointment, and

**WHEREAS**, This candidate is in compliance with the training requirements required by New York State for reappointment under Chapter 662 of the Laws of 2006, and

**WHEREAS**, the Committees on Public Service and Ways & Means do recommend he be reappointed at this time. Now, therefore, Be it

**RESOLVED**, That the Genesee County Legislature does hereby reappoint Mr. Berney Staats of Stafford, NY to serve another term on the Genesee County Planning Board for the period ending on May 31, 2021.

Budget Impact Statement: None.

Legislator Maha seconded the resolution which was adopted by 288 votes, Torrey (38) absent.

# RESOLUTION NO. 222 BUDGET AMENDMENT - GENESEE JUSTICE/2018 CRIMINAL JUSTICE DAY TRAINING REVENUE & EXPENSES – APPROVAL OF

Legislator Stein offered the following resolution:

**WHEREAS**, The Genesee Justice Program Coordinator has made a request to amend the 2018 Genesee Justice budget in order to accommodate revenue and expenses associated with a recent Crime Victims' Rights Week Criminal Justice Day training, and

**WHEREAS**, The Committees on Public Service and Ways and Means did review this request and do recommend acceptance of the budget amendment and line item additional revenue and expense at this time. Now, therefore, Be it

**RESOLVED** that the Genesee County Treasurer is hereby authorized and directed to make the following budget item amendments to the 2018 Genesee Justice Budget as follows:

- Increase revenue:
  - \$2,200 in line A.3151.2705 Gifts and Donations
- Increase expense line item:
  - \$2,200 in line A.3151 4800.0000 Program Expenses

**Budget Impact**: Program Expenses are offset by increased revenue so there is no impact on the 2018 Genesee County Budget and no county funding is affected by this amendment.

Legislator Deleo seconded the resolution which was adopted by 288 votes, Torrey (38) absent.

### RESOLUTION NO. 223 AWARD OF BID – EMERGENCY MANAGEMENT SERVICES/COLDEN ENTERPRISES - APPROVAL OF

Legislator Maha offered the following resolution:

**WHEREAS**, The Genesee County Office of Emergency Management Services is in need of upgrades for the scene surveillance camera on-board the mobile command center/emergency support unit (ESU 2), and

**WHEREAS**, The Genesee County Office of Emergency Management Services Coordinator did issue a Request for Proposal for material and labor relative to these upgrades as specified in Bid #2018-11, and

WHEREAS, The Genesee County Office of Emergency Management Service Coordinator and the Purchasing Director recommend awarding the sole bidder, having met specifications, and WHEREAS, the Committees on Public Service and Ways & Means reviewed this recommendation and do concur. Now therefore, Be it

**RESOLVED**, That the Chair of the County Legislature is hereby authorized and directed to enter into an agreement with Colden Enterprises of 750 Ontario Street, Kenmore, NY 14217 to provide materials and labor for the upgrade to the on-board ESU 2 surveillance camera, at a cost not to exceed \$23,599.35.

**Budget Impact**: FY17 State Homeland Security Program funds of \$23,599.35 have been allocated for the cost of camera upgrades and have been included in the 2018 EMS department budget (A3640.2080.0710), offset by revenue in like amount (A.3640.4305.2).

Legislator Stein seconded the resolution which was adopted by 288 votes, Torrey (38) absent.

#### **RESOLUTION NO. 224**

CONTRACT 2018 APPELLATE SERVICES-PUBLIC DEFENDER/LEGAL AID BUREAU OF BUFFALO, INC. -APPROVAL OF

Legislator Hilchey offered the following resolution:

**WHEREAS**, The Public Defender does recommend the contract between Genesee County and The Legal Aid Bureau of Buffalo, Inc. for the provision of appellate defense services for the

period of January 1, 2018 – December 31, 2020 in the amount of a maximum of \$300,000.00 over the term of the agreement, and

**WHEREAS**, the Committees on Public Service and Ways and Means did review the contract and do recommend approval at this time. Now, therefore, Be it

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the new contract with The Legal Aid Bureau of Buffalo, Inc. for the period of January 1, 2018 through December 31, 2020.

**Budget Impact Statement:** This contract is fully funded by an Indigent Legal Services grant entitled Second Upstate Quality Improvement and Caseload Relief RFP in the amount of \$100,000 per year for a total of \$300,000. The revenue line associated with this contract will be A1170 3025 and the expense line associated with this contract will be line A1170 4660. Legislator Dibble seconded the resolution which was adopted by 288 votes, Torrey (38) absent.

RESOLUTION NO. 225 LEASE AGREEMENT – JUSTICE FOR CHILDREN ADVOCACY CENTER / FIRST PRESBYTERIAN CHURCH - APPROVAL OF

Legislator Clattenburg offered the following resolution:

WHEREAS, The Justice for Children Advocacy Center has been operating in a building owned by the First Presbyterian Church of Batavia at a cost of \$1.00 per month since July 1, 2013; and WHEREAS, the architectural study of the building that was funded by the Justice for Children G.L.O.W Foundation has been completed and the Foundation is prepared to seek bids for a renovation project that will improve accessibility and provide the space necessary for an ever expanding number of children and families in need of services; and

**WHEREAS,** The funds that will be used on this project were raised and donated by the Kiwanis Club of Batavia; and

WHEREAS, In anticipation of these renovations that will necessitate a long term commitment to the present site, the First Presbyterian Church of Batavia has agreed to a fifteen year lease of the building located at 304 East Main Street in the City of Batavia; and

WHEREAS, The agreed upon rate per month is \$1.00; and

**WHEREAS**, Because the existing lease expired in June of 2016, the lease will commence retroactively on July 1, 2016 and conclude on June 30, 2031; and

**WHEREAS**, The Committee on Public Service and the Genesee County Attorney did review this request and do recommend approval at this time; Now, therefore, be it

**RESOLVED,** That the Chair of the Genesee County Legislature and the Genesee County Sheriff are authorized and directed to enter into a lease agreement with the First Presbyterian Church of Batavia New York, 300 East Main St. Batavia, NY 14020 effective July 1, 2016 through June 30, 2031.

**Budget Impact:** Funds for rent are fully covered by the New York State Office of Children and Family Services. Funds for the renovations will be fully covered by the Justice for Children Advocacy Center G.L.O.W Foundation and donations from the Kiwanis Club of Batavia. Prior to the vote Legislator Clattenburg thanked the Church and its parishioners.

Legislator Hilchey seconded the resolution which was adopted by 288 votes, Torrey (38) absent.

**RESOLUTION NO. 226** 

BUDGET AMENDMENT-JUSTICE FOR CHILDREN ADVOCACY CENTER/NORTHEAST REGIONAL CHILD ADVOCACY CENTER- TRAVEL EXPENSE REIMBURSEMENT- APPROVAL OF

Legislator Maha offered the following resolution:

**WHEREAS**, The Justice for Children Program Coordinator attended the Leadership Exchange and Coaching training from January 23-25 and the Team Facilitator Training from March 12-15, both held in Philadelphia, PA, and

**WHEREAS**, Both trainings were provided by the Northeast Regional Child Advocacy Center, and all expenses related to travel and lodging have been reimbursed by that agency, and

**WHEREAS**, The Justice for Children Program Coordinator requests permission for the County to accept reimbursement in the amount of \$949.00 from the Northeast Regional Child Advocacy Center, and

**WHEREAS**, The Committees on Public Service and Ways & Means did review this request and do recommend acceptance of the grant funding at this time. Now, therefore, Be it

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary documents for acceptance of this reimbursement funding in the amount of \$949.00, and that the Genesee County Treasurer is hereby authorized and directed to make the following budget amendment:

**Budget Impact:** These funds will fully reimburse all expenses related to the Program Coordinator's attendance at both the Leadership Exchange and Coaching training and the Team Facilitator training.

**RESOLUTION NO. 227** 

GRANT ACCEPTANCE/CONSULTANT AGREEMENT/AWARD OF BID – RECONSTRUCT TAXIWAY 'C' – AIRPORT -- APPROVAL OF

Legislator Hilchey offered the following resolution:

**WHEREAS**, Genesee County will be awarded a federal aid grant to Reconstruct Taxiway 'C' at the Genesee County Airport (the "Project"), and

**WHEREAS,** Genesee County received a proposal from C&S Engineers for the construction inspection and administration of the Project as required under Federal Aviation Administration guidelines, and

**WHEREAS**, Genesee County did advertise and receive several bids for the construction of the Project, and

WHEREAS, The Genesee County Highway Superintendent has reviewed the consultant proposal and reviewed construction bids for accuracy and does recommend their approval at this time, and

**WHEREAS,** The Committees on Public Service and Ways & Means reviewed this request and do concur at this time, Now, therefore, be it

**RESOLVED,** That the Chairperson of the Genesee County Legislature is hereby authorized to approve a consultant agreement with C&S Companies, 499 Eileen Collins Blvd., Syracuse, NY 13212 for the construction inspection and administration of the Reconstruct Taxiway 'C' project in an amount not to exceed \$227,000; and be it further

**RESOLVED,** That the Genesee County Legislature does hereby award a construction bid to DiFiore Construction, Inc. 155 Pool Street, Rochester, NY 14600 for the Reconstruction of Taxiway 'C' at the Genesee County Airport in amount not to exceed \$1,994,357.40; and be it further

**RESOLVED,** That the consultant agreement and construction bid award are contingent upon the successful receipt of a Federal Aviation Administration Airport Improvement Program Grant that covers the costs of this project; and be it further

**RESOLVED**, That upon the receipt of a federal grant, the Genesee County Legislature hereby approves the above subject Project; and be it further

**RESOLVED**, That Genesee County Legislature does hereby authorize the County Treasurer to pay in the first instance 100% of the federal and non-federal share of the cost of the Project or portions thereof; and be it further

**RESOLVED**, That in the event the full federal and non-federal share costs of the Project exceeds the amount appropriated above, the Genesee County Legislature shall convene as soon as possible to appropriate said excess amount immediately upon notification by the Superintendent of County Highways thereof, and be it further

**RESOLVED**, That the Chairperson of the Genesee County Legislature be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or State Aid on behalf of the County of Genesee with the Federal Aviation Administration and the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of Project costs and permanent funding for the local share of the federal aid and state-aid eligible Project costs and all project costs within appropriations therefore that are not so eligible; and be it further

**RESOLVED**, That this resolution shall take effect immediately upon receipt of a federal grant for this Project.

**Budget Impact**: A capital project will be established for the Taxiway 'C' Reconstruction after the receipt and execution of the federal grant. The total project costs are estimated to be \$2,221,357.40 with funding shares set at 90% federal, 5% state and 5% local. The actual capital project will be based on the final amount provided for in the federal grant. The estimated local match required for this Project is \$111,067.

Legislator Stein seconded the resolution which was adopted by 288 votes, Torrey (38) absent.

# RESOLUTION NO. 228 AGREEMENT RENEWAL – HIGHWAY/ FACILITIES MANAGEMENT/CENTRAL SERVICES – WORK CLOTHING – APPROVAL OF

**WHEREAS**, The Genesee County Highway Department is currently under contract with Cintas Corporation and this agreement allows for 3-1 year extensions, the Genesee County Highway Superintendent recommends renewing the contract agreement with Cintas Corporation, and **WHEREAS**, The Committee on Public Service did review this recommendation and does concur. Now, therefore, Be it,

**RESOLVED,** That the Chair of the Genesee County Legislature is hereby authorized and directed to enter into a renewal agreement with Cintas Corporation, 5740 Genesee Street, Lancaster, New York 14086 for the work clothing as per bid specifications, effective September 1, 2018 through August 31, 2019 with two more one year renewals as per bid prices.

**Budget Impact Statement:** Work clothing is budgeted in County Road and Road Machinery Funds, Facilities Management Operating Budget and Central Services Operating Budget

**RESOLUTION NO. 230** 

CONTRACT - SHARED SERVICES/HIGHWAY-APPROVAL OF

Legislator Stein offered the following resolution:

WHEREAS, The Genesee County Superintendent of Highways reported that the Genesee County Highway Department currently shares equipment, materials and services with other Genesee County municipalities and neighboring counties on an informal basis and to be in compliance with New York State Highway Law and General Municipal Law, Genesee County is required to adopt an agreement formalizing this arrangement, and

**WHEREAS**, the Superintendent of Highways reported that municipalities, including the County of Genesee, have the power and authority to contract for the purpose of renting, leasing, exchanging, borrowing or maintaining of machinery and equipment, with or without operators, with other municipalities, and

**WHEREAS**, the Superintendent of Highways reported that it has been determined that the County of Genesee and other municipalities have machinery and equipment which are not used during certain periods and have stored materials and supplies which are not immediately needed, and

WHEREAS, it is hereby determined that by renting, borrowing, exchanging, leasing or maintaining highway machinery and equipment and the borrowing or lending of materials and supplies, the County of Genesee and other municipalities may avoid the necessity of purchasing certain needed highway machinery and equipment and the purchasing of or storing a large inventory of certain extra materials and supplies, thereby saving the taxpayers money, and WHEREAS, it is the intent of the County of Genesee to give the Superintendent of County Highways the authority to enter into renting, exchanging, borrowing, lending or maintaining arrangements with the persons serving in similar capacities in other municipalities without the necessity of obtaining approval of the City/County/Town/Village governing board prior to the making of each individual arrangements, and

**WHEREAS,** Genesee County authorized such arrangements with other municipalities on February 27, 2006 and the Superintendent of Highways is requesting that such an arrangement be continued through an extension of the original agreement, and

**WHEREAS**, The Committee on Public Service has determined that it will be in the best interest of the County of Genesee to continue to be a party to such shared service arrangements, and does concur with this recommendation. Now, therefore, Be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the Highway Shared Services Agreement which shall be effective immediately through June 2020, and Be it Further

**RESOLVED,** The Legislative Clerk is authorized and directed to file a copy of the contract set forth in this resolution with the Supervisors/Mayors/Board Presidents of the municipalities within Genesee County.

**Budget Impact Statement**: None. Sharing municipal services is a cooperative effort to save money. Legislator Clattenburg seconded the resolution which was adopted by 288 votes, Torrey (38) absent.

#### RESOLUTION NO. 231 AWARD OF BID – HIGHWAY FUEL PRODUCTS – APPROVAL OF

Legislator Hilchey offered the following resolution:

**WHEREAS**, The Genesee County Highway Superintendent has contracted for the purchase and delivery of fuel products to the Genesee County Highway Department operated fuel farms, and **WHEREAS**, The Highway Superintendent recommends awarding a bid to NOCO Energy Corporation, and

**WHEREAS**, The Committee on Public Service did review this recommendation and does concur; now, therefore, be it

**RESOLVED,** That the Chairperson of the Genesee County Legislature is hereby authorized and directed to execute a contract with NOCO Energy Corp, 2440 Sheridan Drive, Tonawanda, NY 14150 for the sale and delivery of fuel products to the Genesee County Highway Department operated fuel farms, effective September 1, 2018 through August 31, 2019.

**Budget Impact Statement:** Purchase of fuel is a budgeted item in the Road Machinery Fund. The bids are based on the rack price differential system and the price is adjusted weekly. Prior to the vote Legislator Stein commented that GAM may benefit from an RFP for smaller loads of diesel. Highway Superintendent Tim Hens stated he would look into it.

Legislator Young seconded the resolution which was adopted by 288 votes, Torrey (38) absent.

#### **RESOLUTION NO. 232**

#### 2018 BUDGET AMENDMENT/SALARY SCHEDULE AMENDMENT-HIGHWAY- ASSISTANT ENGINEER-APPROVAL OF

Legislator Stein offered the following resolution:

**WHEREAS**, The Genesee County Highway Superintendent has requested assistance with program and project management with facility and infrastructure-related projects, especially those involving state or federal aid, and

**WHEREAS,** The Public Service Committee recommends the creation of an Assistant Engineer position at this time, and

**WHEREAS,** The Superintendent of Highways was directed to make adjustments to the 2018 budget in order to fund the position, and

**WHEREAS,** The Ways and Means Committee did review this request and does recommend that that a position be implemented at this time. Now, therefore, Be it,

**RESOLVED,** That the Genesee County Human Resources Director is hereby authorized and directed to amend the 2018 Management Salary Schedule by creating the title of Assistant Engineer (Grade 121), and be it further

**RESOVLED,** That the Genesee County Treasurer is hereby authorized and directed to amend the 2018 Budget by making the following transfers from D5110 to D5020:

**Budget Impact**: Funds are within existing County Road Fund. Total cost for the new position in 2018 is \$52,196. Costs covered by transfer from D5110 Road and Bridge Maintenance due to a vacancy with additional expenses coming from reduced true & level paving.

**WHEREAS,** five bids were received for the purchase of five (5) 2018, all-wheel drive, law enforcement pursuit rated, SUV style vehicles, with the lowest bid being submitted from Beyer Ford, 170 Ridgedale Avenue, Morristown, NJ 07960, for a total purchase price of \$143,652.25, and

**WHEREAS**, the Sheriff did request the bid for the purchase of five patrol vehicles and vehicle equipment be awarded to Beyer Ford, for a total purchase price of \$143,652.25, and

**WHEREAS**, the Committee on Public Service did review this request and does recommend approval at this time. Now therefore be it

**RESOLVED**, that the award of bid for the purchase of five (5) 2018, law enforcement SUV style vehicles will be made to Beyer Ford, for the total purchase price of \$143,652.25.

**Budget Impact:** \$156,800 has been appropriated to the 2018 asset acquisitions for the purchase of patrol vehicles and vehicle equipment. The total purchase price for five vehicles is \$143,652.25. The remaining \$13,147.75 will be used for the purchase and installation of any additional equipment needed to properly outfit the new patrol vehicles.
